## INDEPENDENT AUDITORS' REPORT

To the Board of Directors

### Opinion

We have audited the financial statements of GEMBA Group Annuity Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Note 1 - Description of Plan

The following description of the GEMBA Group Annuity Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

Government Employees’ Mutual Benefit Association, Inc. (“GEMBA”) established the Plan effective as of January 1, 1984. The Plan is a nonqualified tax deferred annuity plan, subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan is a program under which members are entitled to make non-tax deductible contributions for the purchase of group annuity contracts. These contributions were sent to a TI-Trust, Inc. custodian account (the “Trust”).

Contributions

Members of GEMBA may contribute to the Plan. In order to be a member of GEMBA, one must be a current or retired employee of the National Security Agency (“NSA”) or contractors or military personnel who are assigned to or retired from the NSA. Additionally, any civilians actively employed by any branch, department, or agency of the U.S. Government including, without limitation, the U.S. Postal Service and U.S. Courts can become members. The Plan offers a stable value fund (see Note 4), a guaranteed fixed interest fund and variable annuity contracts. The accompanying financial statements include only the stable value fund (see Note 4), guaranteed fixed interest fund and other general assets and liabilities of the Plan. Assets held in variable annuity accounts are excluded from the Plan statements because the annuity contracts are purchased for individual plan participants, and the insurance company assumes the obligation to pay their benefits. The contract is between the individual who purchases the variable annuity and the insurance company.

Participant Accounts

Each participant’s account is credited with the employee’s contribution and an allocation of investment earnings. Participants may direct the investment of their contributions into the investment options offered by the Plan. Participants may change their investment options at their discretion. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are always 100% vested in contributions plus actual earnings thereon.

Payment of Benefits

Participants may elect to receive either a lump-sum amount equal to the vested portion of his or her account, or equal installments over a number of years. These methods and options are described in the Plan agreement.

Note 2 - Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of net assets available of a defined benefit plan attributable to fully benefit-responsive investment contracts held by a defined contribution plan. Fully benefit-responsive investment contracts are now required to be reported at contract value because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (“U.S. GAAP”) requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Note 2 - Significant Accounting Policies (Continued)

Cash and Cash Equivalents

Cash and cash equivalents consist of highly liquid debt instruments purchased with original maturities of three months or less when purchased.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for the fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Management determines the Plan's valuation policies utilizing information provided by the investment advisers and custodians. See Note 3 for discussion of fair value measurements.

Interest income is recorded on the accrual basis.

Payment of Benefits

Benefits are recorded when paid.

Trustee and Administrative Expenses

Trustee fees are paid directly to the Trust and administrative fees are paid to GEMBA and to USI Consulting Group for performing certain administrative functions. All other expenses are paid directly by GEMBA.

Reclassifications

Certain reclassifications have been made to prior year amounts to conform to the current year presentation.

Note 3 - Fair Value Measurements

The Plan's investments (Money Market Fund) are reported at fair (current) value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to measure the fair value of certain financial instruments could result in a different fair value at the reporting date.

The fair value measurement accounting literature, FASB ASC 820-10, establishes a three-level hierarchy for disclosure of investments recorded at fair value. The classification of investments within the hierarchy is based on whether the inputs to the valuation methodology used for measurement are observable or unobservable. Observable inputs reflect market-derived or market-based information obtained from independent sources. Unobservable inputs would reflect the Plan's own assumptions about risk. The three levels for measuring fair value are based on the reliability of inputs and are as follows:

- Level 1 - Quoted prices are available in active markets for identical investments as of the reporting date. The types of investments included in Level 1 are publicly traded securities.
- Level 2 - Other significant observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.
- Level 3 - Significant unobservable inputs that reflect a reporting entity's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

The assets or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The inputs or methodology used for valuing securities are not necessarily an indication of the risk associated with investing in those securities. The following is a summary of the inputs used to value the Plan's net assets as of:

Note 4 - Stable Value Fund

In October 2019, an agreement was entered into with USI Consulting Group and TI-Trust, Inc. The assets held in existing portfolio of conventional guaranteed investment contracts was transferred to TI-Trust, Inc., the custodian. The guaranteed investment contract (GIC) issuers are obligated to repay the interest and principal at a specified interest rate that is guaranteed to the holder. As the contracts in the portfolio matured, the returned principal was invested in the money market fund and guaranteed fixed interest fund (Note 5). No GIC balances remained in the stable value fund at December 31, 2024.

As the underlying guaranteed investment contracts are fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the stable value fund. The stable value fund is presented on the face of the statements of net assets available for benefits at contract value. Contract value, as reported to the Plan by TI-Trust, Inc., represents contributions made under the agreement, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against contract value for credit risk of the underlying contract issuers or otherwise. The contract value of the stable value fund was \$-0- and \$17,896,972 at December 31, 2024 and 2023, respectively.

The Plan's ability to receive amounts due in accordance with the underlying fully benefit-responsive contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the stable value fund. Such events include amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), changes to the Plan's prohibition on competing investment options, the failure of the Trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or premature termination. The Plan administrator believes that any events that would limit the Plan's ability to transact at contract value with participants are probable of not occurring.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include an uncured violation of the Plan's investment guidelines, a breach of material obligation under contract, a material misrepresentation, or a material amendment to the agreement without consent of the issuer.

Note 5 - Guaranteed Fixed Interest Fund

The guaranteed fixed interest fund, made available through the Standard Insurance Company, is presented on the statements of net assets available for benefits at contract value. Contract value, as reported to the Plan by TI-Trust, Inc., represents contributions made under the agreement, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. Daily liquidity is available for participant contributions and withdrawals at contract value regardless of market conditions. The contract value of the guaranteed fixed interest fund was \$90,213,340 and \$82,785,655 at December 31, 2024 and 2023, respectively.

The Plan's ability to receive amounts due in accordance with the underlying fully benefit-responsive contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

#### Note 5 - Guaranteed Fixed Interest Fund (Continued)

Certain events limit the ability of the Plan to transact at contract value with the guaranteed fixed interest fund. Such events include amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), changes to the Plan's prohibition on competing investment options, the failure of the Trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or premature termination. The Plan administrator believes that any events that would limit the Plan's ability to transact at contract value with participants are probable of not occurring.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include an uncured violation of the Plan's investment guidelines, a breach of material obligation under contract, a material misrepresentation, or a material amendment to the agreement without consent of the issuer.

#### Note 6 - Due to Members

When applicable, balances due to members consist of amounts allocated to withdrawing members for distributions that have been processed and approved for payment prior to year-end, but have not yet been paid as of that date. At December 31, 2024, a distribution for \$27,345 had been requested and was yet to be paid. This distribution was included in Plan distributions. At December 31, 2023, no distributions were due to members.

#### Note 7 - Distributions to Members

The Plan made distributions to members in the amount of \$16,012,625 for the year ended December 31, 2024. As of December 31, 2024 and 2023, account balances eligible for distribution and included in the fund balances amounted to \$-0-.

#### Note 8 - Related Party Transactions

The Plan has the same Board of Directors as GEMBA and Government Employees' Benefit Association, Inc. ("GEBA"), a related nonprofit organization. During the year ended December 31, 2024, administrative fees to GEMBA of \$252,111 were included in administrative expenses. At December 31, 2024 and 2023, administrative fees of \$36,842 and \$28,605, respectively, were due to GEMBA.

GEMBA also arranges various other investment and retirement programs and products (the "Programs") for its members. Members may transfer funds between the Plan and the Programs at any time. Due to the timing of transfer requests between the Plan and the Programs, no amounts were due from the Programs at December 31, 2024 and 2023.

#### Note 9 - Plan Termination

Although it has not expressed any intent to do so, GEMBA has the right to terminate the Plan subject to the provisions of ERISA. The amounts in all affected accounts shall be distributed based upon Plan guidelines.

#### Note 10 - Tax Status

The Internal Revenue Service ("IRS") has determined and informed the Plan by letter dated September 9, 1982, that the Plan and related trust are designed in accordance with nonqualified tax-deferred annuity plans' applicable sections of the Internal Revenue Code ("IRC"). The Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and therefore, believes that the Plan is qualified and the related trust is tax-exempt under section 401-1(b)(3) of the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and to recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the accompanying financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2022.

#### Note 11 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Credit risk is the risk that an issuer or another counterparty to an investment will not fulfill its obligation. The Plan invests in a stable value fund that consists of a portfolio of guaranteed investment contracts (see Note 4) and a guaranteed fixed interest fund contract (see Note 5).

#### Note 12 - Subsequent Events

The Plan has performed an analysis of the activities and transactions subsequent to December 31, 2024 to determine the need for any adjustments to and/or disclosures within the financial statements for the year ended December 31, 2024. Management has performed its analysis through August 5, 2025, the date the financial statements were available to be issued. Activities subsequent to this date have not been evaluated by management. Management has concluded that no subsequent adjustment is required.
