INDEPENDENT AUDITOR'S REPORT

To the Trustees
Oregon Imaging Centers, L.L.C. 401(k) Profit Sharing Plan and Trust
Eugene, Oregon

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Oregon Imaging Centers, L.L.C. 401(k) Profit Sharing Plan and Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Oregon Imaging Centers, L.L.C. 401(k) Profit Sharing Plan and Trust's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Oregon Imaging Centers, L.L.C. 401(k) Profit Sharing Plan and Trust and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Oregon Imaging Centers, L.L.C. 401(k) Profit Sharing Plan and Trust's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

1. Plan Description

The following description of Oregon Imaging Centers, L.L.C. 401(k) Profit Sharing Plan and Trust (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions. The Plan's most recent restatement was effective April 11, 2023.

General

The Plan is a defined contribution plan covering all employees of Oregon Imaging Centers, L.L.C. (the Employer), except for students and union, non-resident alien, leased, and per diem employees, who are excluded as defined by the Plan. Prior to April 11, 2023, employees who have completed one hour of service and are age 18 or older were eligible for deferral contributions. Employees who have completed one year of service and are age 18 or older were eligible for matching and profit-sharing contributions. Entry dates would occur on the first day of the month coincident with or next following the completion of 30 days of service for employee deferrals and January 1 or July 1 for employer matching and profit sharing. Effective April 11, 2023, the service requirement for deferral contributions was redefined as one month of service and participants must be employed on the last day of the Plan year to be eligible for profit sharing contributions. Also, entry dates were restated as the first day of the month coincident with or next following the completion of 30 days of service for employee deferrals, employer matching and profit sharing. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may contribute pre-tax deferrals of compensation, or alternately after-tax deferrals (Roth contributions), up to the limits provided by the Internal Revenue Code (IRC). The Plan also allows for employees to make rollover contributions from other qualified defined benefit plans, defined contribution plans, or individual retirement accounts. The Employer may make discretionary matching contributions on each participant's elective contributions in such amounts as may be determined by the Employer each year. For 2024 and 2023, the Employer made a tiered matching contribution. For participants with one year of service, the matching contribution is equal to 25 percent of the first 6 percent of eligible compensation contributed as deferrals. For participants with two or more years of service, the matching contribution is equal to 50 percent of the first 6 percent of eligible compensation contributed as deferrals. The Employer may make discretionary profit-sharing contributions allocated on an employee by employee basis in amounts determined by the Employer. Participants must be employed on the last day of the year to share in an allocation of Employer profit sharing contributions. For 2024 and 2023, the Employer made a tiered profit sharing contribution. For participants with one year of service, the profit sharing contribution was 2.85 percent of each participant's eligible compensation. For participants with two or more years of service, the profit sharing contribution was 5.7 percent of each participant's eligible compensation. All contributions are limited to the applicable amounts as prescribed by the IRC.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocation of (a) the Employer's contributions, (b) the Plan's investment earnings or losses, and (c) certain Plan administration costs not paid by the Employer. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investments of their accounts between several investment alternatives available through the custodian, Fidelity Management Trust Company and John Hancock Life Insurance Company.

Vesting and Forfeitures

Participants are immediately vested in their elective deferral contributions plus actual earnings thereon. Vesting in the Employer's contribution portion of their accounts is based on years of continuous service. A participant is 100 percent vested after four years of credited service on a graded vesting schedule of 25 percent per year. Unvested portions of account balances for participants who leave employment are forfeited. The Employer may elect to use all or a portion of forfeitures to pay plan expenses. Any amounts unused will be first applied to restore/restate previous forfeitures to participant accounts and any remaining amounts can be used to reduce and/or be added to any Employer contributions. Total amounts forfeited were \$9,678 and \$7,420, respectively. Available forfeited unvested accounts totaled \$18,540 and \$7,560 at December 31, 2024 and 2023, respectively. For the years ended December 31, 2024 and 2023, no forfeitures were used to offset Employer contributions.

Payment of Benefits

On termination of service, death, disability, or attainment of retirement age, a participant or beneficiary may elect to receive an amount equal to the value of the participant's vested interest in their account in a lump-sum, annuity or a direct rollover to an eligible qualified retirement plan or IRA. The Plan allows in-service distributions of Employer contributions and associated earnings, subject to certain requirements related to months of service and years since the contribution was made. In-service distributions for hardships are also available on account of an immediate and heavy financial need of the participant, subject to the Plan's rules governing hardship withdrawals.

Participant Loans

The Plan does not permit participants to take a loan from their account.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. See Note 7 for additional information on fair value measurements.

Purchases or sales of securities are recorded on a trade-date basis. Investment income is recorded on the accrual basis. Net change in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Contributions

Participant contributions are recorded in the year in which they are withheld from compensation.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses and Fees

Expenses of maintaining the Plan are generally paid by the Employer and are therefore excluded from these financial statements. Certain custodial and recordkeeping fees or other related professional fees may be paid from Plan assets. Investment related expenses are included in net change in fair value of investments.

Recent Accounting Standard Adopted

On January 1, 2023, the Plan adopted Accounting Standards Update (ASU) 2016-13 Financial Instruments – Credit Losses (Topic 326): *Measurement of Credit Losses on Financial Instruments*, and all related amendments (ASC 326), which replaced the incurred loss methodology for recognizing credit losses with an expected loss methodology that is referred to as the current expected credit loss (CECL) methodology. CECL requires an estimate of lifetime expected credit losses to be recognized for financial assets based on historical experience, current conditions, and reasonable and supportable forecasts, and for the financial assets to be presented at the net amount expected to be collected on the statements of net assets available for benefits. The financial assets held by the Plan that are subject to ASC 326 are employer contributions receivable and participant contributions receivable.

The Plan adopted ASC 326 effective January 1, 2023. There was no impact to the financial statements as a result of adopting this standard.

3. Information Certified by Plan Trustee and Custodian

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company, acting as trustee for the Plan from April 12, 2023 to December 31, 2024 and John Hancock Life Insurance Company, acting as the custodian for the Plan from January 1, 2023 to April 11, 2023, has certified that the following information included in the accompanying financial statements and supplemental schedule is complete and accurate as of and for the years ended December 31:

4. Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of full or partial Plan termination, affected participants would become 100 percent vested in their Employer contributions.

5. Tax Status

The Plan has adopted a non-standardized pre-approved profit sharing plan with CODA sponsored by FMR LLC. The Internal Revenue Service (IRS) has informed the sponsor by an opinion letter dated June 30, 2020 that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, and therefore believe that the Plan is qualified and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

6. Risks and Uncertainties

The Plan provides for various investment options that have different investment strategies. These investments are exposed to various risks, such as interest rate, market, and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

7. Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to its fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Registered investment companies: These funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission (SEC). These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and considered to have a readily determinable fair value.

Interest-bearing cash: Valued at cost which approximates fair value.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair value. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

8. Related Party Transactions

Certain Plan investments are managed by an affiliate of Fidelity Management Trust Company (Fidelity), the trustee of the Plan from April 12, 2023 to December 31, 2024, and John Hancock Life Insurance Company (John Hancock), the custodian of the Plan from January 1, 2023 to April 11, 2023, and therefore these transactions qualify as party-in-interest transactions. Administration fees paid directly to John Hancock for the years ended December 31, 2024 and 2023, totaled \$0- and \$5,677, respectively. Administration fees paid directly to Fidelity Investments Institutional, an affiliate of Fidelity, for the years ended December 31, 2024 and 2023 totaled \$20,510 and \$10,231, respectively. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

9. Reclassification

Certain prior year amounts have been reclassified to conform to current year presentation. Such reclassifications had no effect on previously stated changes in net assets available for benefits.

10. Subsequent Events

Management evaluates events and transactions that occur after the statement of net assets available for benefits date as potential subsequent events. Management has performed this evaluation through the date of the independent auditor's report.

Effective February 21, 2025, the Plan implemented a new auto enrollment whereby newly eligible participants are auto enrolled at 6% with an annual 1% automatic increase, up to 10%.
