Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Moog Music, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. Note 1 – Description of Plan

The following brief description of the Moog Music, Inc. 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan agreement for more complete information.

General

The Plan was a defined contribution plan covering all full-time employees and some part-time, temporary, and seasonal employees of Moog Music, Inc. (the “Company”) who had completed one year of service and were 21 years of age or older. Leased and union employees and part-time, temporary, or seasonal employees who work less than 1,000 hours per year were excluded from plan participation. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

On June 9, 2023, the Company sold substantially all of its assets to inMusic MMI Acquisition, LLC. Company operations ceased following this transaction. On December 31, 2023, the Board approved termination of the Plan, effective immediately. See Note 6 for discussion of Plan termination.

Contributions

Participants could contribute a percentage of their compensation as pre-tax deferrals and Roth contributions to the Plan, and could also contribute amounts representing distributions from other qualified plans, as defined. Participants directed the investment of their contributions into various investment options offered by the Plan. The Company’s matching contribution was discretionary. The Company could also make an additional discretionary contribution. For the year ended December 31, 2023, the Company matched 50% of participant contributions, up to 5% of compensation. There were no matching contributions for the period ended December 20, 2024. The Company did not make any additional discretionary contributions during 2024 or 2023. Contributions were subject to certain limitations.

Participant Accounts

Each participant’s account was credited with the participant’s contribution and allocations of (a) the Company’s contributions and (b) Plan earnings and administrative expenses. Allocations were based on participant compensation or account balances, as defined by the Plan. The benefit to which a participant was entitled was the benefit that could be provided from the participant’s vested account.

Vesting

Participants were immediately vested in their contributions plus earnings thereon. Prior to Plan termination, vesting in discretionary employer contributions plus actual earnings thereon is based on years of service. A participant was 100% vested after six years of credited service. Upon Plan termination, all participants became 100% vested in all contributions.

Payment of Benefits

Upon termination of service for any reason, a participant could elect to receive either a lump-sum amount equal to the value of the participant’s vested interest in his or her account or installments. Mandatory distributions were required for vested balances of \$5,000 or less when a participant separated from service. In-service distributions were allowed at age 65.

Administrative Expenses

Plan fees and administrative expenses were paid by the Company and the Plan on a discretionary basis.

Forfeitures

At December 20, 2024 and December 31, 2023, forfeited non-vested accounts totaled \$-0- and \$14,994, respectively. Forfeitures could be used to pay Plan expenses or otherwise used at the Plan Sponsor's discretion to reduce employer contributions. For the period ended December 20, 2024, \$14,994 of forfeitures were used to pay Plan expenses.

Note 2 – Summary of Significant Accounting Policies

Basis of Accounting

The Plan's financial statements were prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP). The Plan has changed its basis of accounting used to determine the amounts at which investments are stated, from an ongoing Plan basis to the liquidation basis for periods after December 31, 2022. See Note 6 for discussion of Plan termination.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America required the Plan Administrator to make estimates and assumptions that affected reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments were stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation or depreciation included the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan invested in various investment securities. Investment securities were exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it was at least reasonably possible that changes in the values of investment securities would occur in the near term and that such changes could have materially affected participants' account balances and the amounts reported in the statements of net assets (in liquidation) available for benefits.

Payment of Benefits

Benefits were recorded when paid.

Subsequent Events

Subsequent events have been evaluated through October 9, 2025, the date the financial statements were available to the issuer.

Note 3 – Fair Value Measurements

The Plan's investments were reported at fair value in the accompanying statements of net assets (in liquidation) available for benefits. The methods used to measure fair value could have produced an amount that may have been indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods were appropriate and consistent with those of other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could have resulted in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of observable inputs other than quoted prices for identical assets; and Level 3 inputs consist of unobservable inputs and have the lowest priority. The Plan used appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measured fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs were used only when Level 1 or Level 2 inputs were not available.

The following table sets forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2023. Classification within the fair value hierarchy table was based on the lowest level of any input that was significant to the fair value measurement.

income accounts were not fully benefit-responsive; therefore, fair value was the relevant measurement attribute. Fair value was the amount the Plan participant would receive if they transferred or surrendered their funds out of the guaranteed income account prior to maturity. The fair value was computed using a combination of the current interest rates based on remaining investment terms at the reporting date as well as the interest rate on the account. The guaranteed income accounts were classified within Level 3 of the valuation hierarchy. Significant changes to the terms of these contracts or interest rates could have resulted in a significantly higher or lower fair value measurement for these investments.

Note 4 – Contracts with Insurance Companies

The Plan invested in a contract with John Hancock Life Insurance Company (U.S.A.), which maintained contributions in various pooled separate accounts. The percentage of contributions allocated to each fund was determined by the participants.

The separate accounts were maintained on a "unit" basis. The unit value was adjusted daily to reflect investment results under the separate accounts. These accounts were reported at fair value. The value of each account on any date was determined by multiplying the number of units held by the unit value at the close of business on that particular date.

Note 5 – Related-Party Transactions

Certain administrative functions were performed by employees of the Company. These employees were also Plan participants. No such employee received compensation from the Plan.

Plan participants invested in funds held or managed by the Plan Trustee and these were considered related party transactions. Fees paid to the Trustee by the Plan for administrative services were \$63,975 for the period ended December 20, 2024.

Note 6 – Plan Termination

On December 31, 2023, the Board approved termination of the Plan, effective immediately. All participants were 100% vested in their account balances as of December 31, 2023. On December 20, 2024, all assets were distributed to participants.

Note 7 – Tax Status

The Plan adopted a non-standardized pre-approved profit sharing plan sponsored by Crowe, LLP. The Internal Revenue Service had determined and informed the Company by a letter dated June 30, 2020, that the Plan was designed in accordance with applicable sections of the *Internal Revenue Code (IRC)*. The Plan had been amended since receiving the opinion letter; however, the Plan Administrator believed that the Plan was designed and being operated in compliance with the applicable requirements of the *IRC*.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator analyzed the tax positions taken by the Plan, and concluded that as of December 20, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.
