NOTE 1 - DESCRIPTION OF PLAN

The following description of the Regional Paramedical Services 401(k) Profit Sharing Plan & Trust (Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established on January 1, 2016. The plan covers all salaried and hourly employees of the Company who have six months of service and are age 19 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Effective February 29, 2016, Participants may contribute up to 92% of compensation to the plan through voluntary pre-tax payroll deductions, after tax payroll deductions called Roth contributions, or a combination of both. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions in addition to the participant's regular deferral contribution. Participants may also contribute amounts representing distributions from other qualified benefit or defined contribution plans called rollover contributions. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company contributes 100% of the first 2% of plan compensation deferred. The Company also makes discretionary profit sharing contributions to eligible employees. No Company profit sharing contribution was made during 2024. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of the Company's profit-sharing contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions, rollover contributions, and Company matching contributions plus actual earnings thereon. Vesting in the Company's profit sharing contribution portion of their accounts is based on years of continuous service. A participant is 100% vested in Company profit sharing contributions after six years of credited service.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. Interest is set at 1% above prime and payments are made through payroll deductions with terms ranging from six months to 60 months, unless the loan is used to purchase a participant's principal residence, in which case repayment terms may not exceed ten years.

Payments of Benefits

Upon death, disability, or normal or early retirement, a participant may elect to receive a lump sum or installments equal to the value of the participant's vested interest in his or her accounts. Upon termination of service, a participant may elect to receive a lump sum equal to the value of the participant's vested interest in his or her accounts after six months have elapsed following termination of service.

Forfeitures

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$0 and \$2,121. These accounts are used to reduce future employer contributions or administrative expenses. During the year ending December 31, 2024, \$5,391 of forfeited nonvested accounts were used to reduce administrative expenses.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Accounting Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Notes 4, 5, and 6 for discussion of contract value and fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Payments of Benefits

Benefits payments are recorded as deductions when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to administration of notes receivable from participants and distributions are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

Evaluation of Subsequent Events

Management has evaluated subsequent events through the date of the Independent Auditor's Report, which is the date the financial statements were available to be issued.

NOTE 3 - CERTIFIED INVESTMENT INFORMATION

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, and interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Transamerica Financial Life Insurance Company, Inc. (Transamerica), the trustee of the Plan.

NOTE 4 - INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan holds a fully benefit-responsive investment contract with Transamerica, listed in the statements of net assets available for benefits as Stable Value Fund. Transamerica maintains the contributions in the general account. Contract value is the relevant measure for benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the contract. The contract values are determined daily based on the fair values of the underlying investments, including separate accounts under group annuity contracts and all mutual funds under NAV custodian agreements. Contract values, as reported by Transamerica, represent contributions made under each contract, plus earnings, less participant withdrawals and administrative expenses. The group annuity contract held by the Plan meets the five conditions to be considered fully benefit-responsive. A Plan merger or termination would limit the Plan from transacting at contract value. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

NOTE 5 - INVESTMENTS MEASURED AT NET ASSET VALUE PER SHARE

Pooled separate accounts (PSAs) are measured at fair value using the net asset value (NAV) per share (or its equivalent) practical expedient. The NAV of the PSAs is equal to the contract value, which is the number of participation units owned under the contract in each PSA multiplied by the unit value of the participation units. The unit values of participation units in PSAs are estimated by Transamerica based on the value of the underlying assets owned by the fund minus the fund's liabilities, divided by the number of participation units outstanding. Participant transactions (purchases and sales) may occur daily with no advance notification requirements.

NOTE 6 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 inputs to the valuation methodology include the following:
 - Quoted prices for similar assets or liabilities in active markets
 - Quoted prices for identical or similar assets or liabilities in inactive markets
 - Inputs other than quoted prices that are observable for the asset or liability
 - Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The plan has no assets that are subject to reporting under the fair value hierarchy. See Note 4 for a description of the valuation method for the stable value fund valued at contract value and Note 5 for a description of the valuation method for pooled separate accounts valued at net asset value per share as a practical expedient to fair value.

NOTE 7 - RELATED PARTY TRANSACTIONS

The plan invests in Transamerica Financial Life Insurance Company, Inc. pooled separate accounts and a stable value fund. Transamerica serves as custodian and recordkeeper for the Plan and, therefore, these transactions qualify as party in interest transactions. Fees paid by the Plan for recordkeeping services were \$30,499 for the year ended December 31, 2024.

NOTE 8 - PLAN TERMINATION

Although it has not expressed intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. If the Plan is terminated, each participant's account becomes fully vested. The Company has the option to direct a complete distribution of the assets to the participants or to continue the trust fund as though the Plan had not been terminated.

NOTE 9 - TAX STATUS

The Plan document is a volume submitter plan provided by Ascensus LLC. The Internal Revenue Service (IRS) has informed the provider in an opinion letter dated June 30, 2020, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter. The Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan is considered to qualify as a tax-exempt plan under Section 401(a) of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 10 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
