Status of Our Audit

AUDIT OF FINANCIAL STATEMENTS

- We have completed our audit of the financial statements and supplemental schedules of the Acciona Energy North America 401(k) Plan (“the Plan”) as of and for the year ended December 31, 2024. Our audit was conducted in accordance with auditing standards generally accepted in the United States of America. This audit of the financial statements does not relieve management or those charged with governance of their responsibilities.
- With respect to the supplementary information accompanying the financial statements, we made certain inquiries of you and evaluated the form, content, and methods of preparing the information to determine that the information complies with the DOL’s Rules and Regulations for Reporting and Disclosure under ERISA, the method of preparing it has not changed from the prior period, and the information is appropriate and complete in relation to our audit of the financial statements. We compared and reconciled the supplementary information to the underlying accounting records used to prepare the financial statements or to the financial statements themselves.
- All records and information requested were freely available for our inspection.
- Management and other personnel provided full cooperation.

Other Audit Findings or Issues

We generally discuss various matters, including applying accounting principles and auditing standards, with management each year before retention as the Plan’s auditors. However, these discussions occurred in the ordinary course of our professional relationship, and our responses were not a condition for our retention.

General Recommendations

Recommendation Regarding the Definition of Compensation

The Plan defines compensation beginning with Form W-2 wages and excluding items such as reimbursements, expense allowances, and fringe benefits. In 2024, management reconsidered its treatment of housing allowances and, after conducting research, concluded that housing allowances fall under the category of fringe benefits.

We note that determining whether specific types of pay qualify as fringe benefits is outside the scope of the audit. The IRS has published extensive guidance on fringe benefits (see IRS Publication 15-B, Employer’s Tax Guide to Fringe Benefits), reflecting the complexity of these determinations.

Given the dollar amount of earnings coded as housing allowances, we recommend that the Sponsor specifically exclude housing allowances in the written definition of compensation if that reflects operational intent. This would limit the Company’s exposure in the event a regulator were to take an alternate position that might otherwise require corrective action.

Additionally, we observed other types of allowances (e.g., auto allowances) being included as eligible compensation. We recommend that the Sponsor evaluate all allowances collectively, determine the operational intent, and then coordinate with Fidelity to draft and execute an amendment that formalizes these exclusions in the plan documentation.

Required Communications

General Recommendations (cont.)

Unused forfeitures

On December 31, 2024, unused forfeited accounts totaled \$6,245. The terms of your Plan provide that forfeited accounts be used to offset expenses or reduce employer contributions. We recommend that available forfeitures be used to offset employer-matching contributions on an ongoing basis (or at least zeroed annually).

The general rule is that assets in a plan's forfeiture account should be used or allocated in the plan year incurred. The IRS has stressed the timeframe for using these assets promptly.

Reportable Findings

We are required to communicate, in writing, all reportable findings, material weaknesses, and significant deficiencies that have been identified as part of the audit to those charged with governance. The definitions of material weakness, significant deficiencies, and control deficiencies follow:

Reportable Finding: matters that are one or more of the following:

- An identified instance of noncompliance or suspected noncompliance with laws or regulations per AU-C section 250, *Consideration of Laws and Regulations in an Audit of Financial Statements*.
- A finding arising from the audit that is, in the auditor's professional judgment, significant and relevant to those charged with governance regarding their responsibility to oversee the financial reporting process per AU-C section 260, *The Auditor's Communication with Those Charged with Governance*.
- An indication of deficiencies in internal control identified during the audit that has not been communicated to management by other parties and that, in the auditor's professional judgment, are of sufficient importance to merit management's attention per AU-C section 265, *Communicating Internal Control Related Matters Identified in an Audit*.

Material Weakness: A deficiency, or combination of deficiencies, in internal control, such that there is a reasonable possibility that a material misstatement of the plan's financial statements will not be prevented or detected and corrected on a timely basis.

Significant Deficiency: A deficiency, or combination of deficiencies, in internal control less severe than a material weakness yet necessary enough to merit attention by those charged with governance.

Deficiency in Internal Control: A deficiency in internal control exists when the design or operation of a control does not allow management or employees, in the ordinary course of performing their assigned functions, to prevent, detect, and correct misstatements on a timely basis.

In conjunction with our audit of the financial statements, Dufek & Company, LLC assisted management in preparing the financial statements and making necessary cash-to-accrual adjustments.

We have performed audits of the financial statements of the Acciona Energy North America 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Acciona Energy North America 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Notes to Financial Statements

Note 1. Description of Plan

The following description of the Acciona Energy North America 401(k) Plan (the Plan) is provided for general informational purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering employees of Acciona Energy USA Global LLC, Acciona Solar Power, Inc., Acciona Agua Corporation (USA), Acciona Infrastructure USA Corp., Acciona Culture Corporation, and Acciona Facility Services, USA (collectively, the Company), except non-resident aliens, leased employees, and temporary employees. Employees who are age twenty-one or older and have completed three months of service are eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions: Each year, participants may make pre-tax and Roth contributions, subject to certain Internal Revenue Code (IRC) limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

The Plan includes a provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 5% of eligible compensation, and their contributions invested in a designated balanced fund until changed by the participant. Automatically enrolled participants have their deferral rate increased at a rate of 1% per year on July 1 up to a maximum of 10% of eligible compensation, unless otherwise elected by the participant.

The Company makes a safe harbor matching contribution equal to 100% of the first 5% of eligible compensation an employee contributes to the Plan. The Company made safe harbor matching contributions of \$1,397,196 to the Plan for the year ended December 31, 2024.

In addition, the Company may make discretionary nonelective contributions, which are not dependent upon employee contributions. Discretionary nonelective contributions are allocated pro-rata, based upon compensation, to those participants who work 1,000 hours and are employed on the last day of the Plan year. The last day and 1,000-hour requirement are waived in the event of death, disability, or retirement. The Company did not make a nonelective contribution to the Plan for 2024.

Participants direct the investment of all contributions, including Company contributions, into investment options offered by the Plan. The Plan currently offers various mutual funds and a collective trust stable value fund as investment options for participants.

Participant Accounts: Each participant's account is credited with the participant's contributions, Company contributions, plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes to Financial Statements

Note 1. Description of Plan (cont.)

Vesting: Participants are vested immediately in their contributions, Company contributions and actual earnings thereon.

Notes Receivable from Participants: Participants may borrow from their fund accounts a minimum of \$1,000 to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates commensurate with local prevailing rates as determined by the Plan Administrator at the inception of each loan. Principal and interest is paid ratably through payroll deductions.

Payment of Benefits: On termination of service due to death, disability, separation or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. In addition, in-service withdrawals are allowed after participants reach age 59 ½ or in cases of financial hardship.

The Plan has the ability to make automatic distributions without participant consent for terminated participants that fail to affirmatively elect a distribution and have a vested account balance under \$5,000.

Note 2. Summary of Accounting Policies

Basis of Accounting: The Plan's financial statements are prepared on the accrual basis of accounting.

Use of Estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Sponsor determines the Plan's valuation policies utilizing information provided by the custodian. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions: Contributions from Plan participants and the safe harbor matching contributions from the Company are recorded in the year in which employee contributions are withheld from compensation.

Note 2. Summary of Accounting Policies (cont.)

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of Benefits: Benefits are recorded when paid.

Expenses: Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events: The Plan has evaluated subsequent events through October 6, 2025, the date the financial statements were issued.

Note 3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Note 3. Fair Value Measurements (cont.)

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Stable value collective trust fund: Composed primarily of fully benefit-responsive investment contracts valued at the NAV of units of the collective trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months notification to ensure that securities liquidations will be carried out in an orderly business manner.

Note 4. Certified Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information supplied to the Plan Administrator and certified as complete and accurate by Fidelity Management Trust Company (the trustee of the Plan).

Note 5. Related-Party Transactions and Party in Interest Transactions

Fidelity Management Trust Company is the trustee as defined by the Plan. Fees paid to Fidelity for record keeping and investment management services amounted to \$37,994 for the year ended December 31, 2024. These transactions qualify as exempt party in interest transactions.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

Note 7. Tax Status

The Company has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 9. Nonexempt Transactions

As reported on the accompanying Supplemental Schedule of delinquent participant contributions, employee deferrals of \$75,814 related to the year ended December 31, 2023 were not remitted to the Plan within the time frame specified by the Department of Labor's Regulation 29 CFR 2510.3-102, thus constituting nonexempt transactions between the Plan and the Company. In 2024, the Company remitted amounts to restore participants' lost earnings on the delinquent contributions.

No new instances of late remittance were identified during the 2024 audit. Because the related correction occurred in 2024, the supplemental schedule of delinquent participant contributions remains required through the year of correction and is presented with the 2024 Form 5500.
