To the Sunnen Retirement Plan Committee
Sunnen Employees' Retirement Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Sunnen Employees' Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2023 and 2022, and the related statement of changes in net assets available for benefits for the year ended December 31, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2023 and 2022, and for the year ended December 31, 2023 stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

NOTE 1 — DESCRIPTION OF PLAN

The following description of the Sunnen Employees' Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all eligible employees of Sunnen Products Company (the Company). Employees may enter the Plan immediately upon meeting the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Fidelity Management Trust Company (Fidelity) is the trustee of the Plan. The Company has also appointed Strategic Advisor, Inc. as an investment manager to provide discretionary investment management services and Moneta Group Investment Advisors, LLC as an investment advisor.

Contributions

Participants may contribute up to 50% of annual eligible compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also elect to make after-tax contributions to a Roth account. The Company automatically enrolls eligible employees with a fixed deferral contribution at 3% unless the employee elects otherwise. In addition, the Plan annually increases a participant's deferral rate by 1%, up to a maximum of 9%, unless the participant elects otherwise.

The Company's matching contributions are discretionary and determined as a percentage of participant elected deferrals. The Company elected to match contributions at 50% of the first 6% of participant contributions for the year ended December 31, 2023.

The Company may make discretionary nonelective contributions in an amount to be determined by the Company for each Plan year. Participants must complete at least 1,000 hours of service during the Plan year and be employed as of the last day of the Plan year to be eligible to receive the nonelective contributions for that Plan year.

Contributions are subject to certain limitations. Participants may also transfer funds to the Plan from other qualified retirement plans.

Investment Options

Participants of the Plan elect investment accounts in which their contributions, as well as Company contributions, are invested. The investment account options comprise various degrees of risk and return.

NOTE 1 — DESCRIPTION OF PLAN (Continued)

Participant Accounts

Each participant's account is credited with the participant's contribution, Company contributions, and investment earnings based on their selected investments. Participant accounts may be charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions and Company matching contributions plus earnings thereon. Participants are also fully vested in their accounts transferred from other plans.

Vesting in the Company discretionary nonelective contribution portion of participant accounts is based on credited years of service, as follows:

Notes Receivable From Participants

Participants may borrow from their accounts based on financial hardship and approval by the plan committee, but no more than \$50,000 or 50% of the participant's vested account balance, whichever is less. The loans are secured by the balance in the participant's account and only two loans may be outstanding at any given time. The loan interest rate is determined by the plan administrator at the time of loan initiation. Principal and interest is paid ratably through monthly payroll deductions.

Payment of Benefits

On termination of service due to death, disability or retirement, participants become fully vested and may elect to receive an amount equal to the value of their accounts in either a lump-sum amount or in installments, depending on the size of the participant's account balance at the time of termination. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account in a lump-sum distribution.

The Company may authorize certain withdrawals from a participant's account in the event of proven financial hardship or at the age of 59½. Hardship withdrawals are subject to specific statutory and regulatory requirements.

Forfeited Accounts

Forfeitures may be used to reduce Company contributions or pay plan expenses. No forfeitures were utilized during the year ended December 31, 2023. Unallocated forfeitures were \$60,513 and \$54,470 at December 31, 2023 and 2022, respectively.

NOTE 2 — SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan were prepared on the accrual method of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Contributions

Contributions from participants are recorded in the year in which the employee contributions are withheld from compensation. Contributions from the Company are recorded in the year in which the related participant's wages are paid.

Payment of Benefits

Benefits are recorded when paid.

Administration Expenses

Plan expenses primarily consist of investment advisory and recordkeeping fees. Fees related to the administration of notes receivable from participants and benefit payments to participants are charged directly to the participant's account and are included in administrative expenses. Certain investment related expenses are included in net appreciation of fair value of investments. Expenses of maintaining the Plan may be paid directly by the Company at its discretion and are excluded from these financial statements.

Fidelity offers professional portfolio management to participants in the Plan for an additional fee. Plan participants may choose to use Fidelity Portfolio Advisory Service at Work, which is a service of Strategic Advisors, Inc., a registered investment adviser and affiliate of Fidelity.

The revenue sharing amounts that Fidelity receives from the mutual funds are credited back to the participants invested in those funds on a quarterly basis. The Plan's administrative and advisory costs are paid via a per participant fee charged quarterly to each participant's account. During the year ended December 31, 2023, revenue credits of \$16,831 were netted against plan expenses. Unallocated revenue credit program balances were \$21,542 and \$12,463 at December 31, 2023 and 2022, respectively.

Subsequent Events

Subsequent events were evaluated through October 1, 2024, which is the date the financial statements were available to be issued.

NOTE 3 — FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023 and 2022.

Mutual funds and money market funds: valued at the daily closing price reported by the fund, which is the quoted net asset value (NAV) of shares.

Common/collective trusts: valued at the NAV of units of the fund which is based on the estimated market value of the underlying investments less its liabilities. The stable value common/collective trusts invests in a fund in which the underlying assets consists primarily of fully benefit-responsive investment contracts. The fund is valued at NAV, the practical expedient to estimate fair value.

NOTE 4 — INFORMATION CERTIFIED BY TRUSTEE

Information related to investments and notes receivable from participants held at December 31, 2023 and 2022, and net appreciation in fair value of investments, interest and dividends for the years then ended, disclosed in the accompanying financial statements, was obtained or derived from data provided to the plan administrator and certified to as complete and accurate by Fidelity, the trustee.

NOTE 5 — PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are shares of mutual funds managed by Fidelity. Fidelity is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid to Fidelity and affiliates were \$62,724 for the year ended December 31, 2023. Certain fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investments, as these are not direct payments by the Plan.

NOTE 6 — PLAN TERMINATION

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their company contributions.

NOTE 7 — TAX STATUS

The Company has adopted a pre-approved defined contribution plan, and therefore, can rely on the advisory letter issued by the Internal Revenue Service on June 30, 2020, which stated that the Plan is acceptable under Section 401 of the Internal Revenue Code. Management believes that the Plan is operating in compliance with all the terms provided in the nonstandardized plan agreement. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

The Plan is subject to examination by the IRS for the statutory period.

NOTE 8 — RISKS AND UNCERTAINTIES

The Plan invests in various types of investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
