INDEPENDENT AUDITOR'S REPORT

To the Administrator of
Delta Health Alliance, Inc. Retirement Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Delta Health Alliance, Inc. Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Delta Health Alliance, Inc. Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Delta Health Alliance, Inc. NOTE 1 - DESCRIPTION OF PLAN

The following description of the Delta Health Alliance, Inc. Retirement Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

- a. *General* - The Plan, which became effective January 1, 2010, is a defined contribution plan covering substantially all full-time employees of Delta Health Alliance, Inc.(a nonprofit organization), who have completed two months of service. The Plan has no minimum age requirement. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).
- b. *Contributions* - Each year, participants may make contributions to the Plan in the form of salary reductions equal to the lesser of \$23,000 for 2024 and \$22,500 for 2023 (plus an additional \$7,500 for 2024 and 2023, if over 50) or 100% of defined compensation. The Organization contributes 6% (3% elective and 3% non-elective) of the participants' defined compensation even if the participants' do not wish to contribute to the Plan. If the participants' elect to contribute to the Plan, then the Organization will match 50% of the first 6% of salary deferrals and of the participant's compensation. Participants may elect to make voluntary contributions under the Plan in amounts determined by the Plan administrator with the consent of the Custodian.
- c. *Participant Accounts* - For each participant, accounts are established for salary reduction contributions, matching contributions and voluntary contributions. Each participant's account is credited with the participant's salary reduction contributions, voluntary contributions, employer contributions, and investment earnings and allocation of the Organization's contributions and forfeitures of terminated participants' non-vested accounts and charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings or account balances, as defined. Each participant designates how salary reduction contributions and matching contributions are invested among the investment funds made available under the Plan by the Custodian. If no investment selection is made when signing up for Plan entry, then the appropriate target date fund based on age is automatically selected. Any other contributions are invested in accordance with instructions of the Custodian. The benefit to which a participant is entitled is the benefit that can be provided from the participant's accounts.
- d. *Vesting* - Participants are immediately vested in their salary reduction contributions, voluntary contributions, and basic matching contributions plus actual earnings thereon. Vesting in discretionary profit sharing and matching contributions are also immediately vested.
- e. *Notes Receivable from Participants* – The Plan does not allow loans to participants.
- f. *Withdrawals from Accounts* - The Plan allows participants to make in-service withdrawals from their accounts upon attaining age 59½. Participants are not permitted to borrow amounts from the Plan.
- g. *Payment of Benefits* - On termination of service, a participant may elect to receive a lump sum payment equal to the value of his or her account. Other methods of payment are permitted by the Plan. At December 31, 2024 and 2023, account balances for terminated participants amounted to \$4,076,975 and \$3,062,278.
- h. *Forfeited Accounts* - At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$2 and \$401, respectively. Forfeited amounts, if any, will supplement future Company contributions.

NOTE 2 - SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation, (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

The Plan's audit expenses are paid by the plan sponsor, which is a party-in-interest. These expenses are excluded from these financial statements. Investment-related expenses are included in net appreciation (depreciation) in the fair value of investments.

NOTE 4 – FAIR VALUE MEASUREMENTS

The Plan’s investments are reported at fair market value in the accompanying statement of net assets available for benefit. The method used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. No Level 3 inputs were available to the Plan.

Level 1 Fair Value Measurements

Mutual funds:

Valued at daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE 6 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to reduce, suspend or discontinue contributions to the Plan at any time or to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become one hundred percent vested in their accounts.

NOTE 7 - TAX STATUS

The Internal Revenue Service has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt.

Effective January 1, 2019, the plan was amended to disallow hardship withdrawals.

The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2022.

NOTE 8 – SUBSEQUENT EVENTS

Management has evaluated subsequent events through October 13, 2025, the date the financial statements were available for issue, and has determined that no events have occurred subsequent to the statement of net assets available for benefits date that would require adjustment to, or disclosure in, the financial statements.

NOTE 9 – RISKS AND UNCERTAINTIES

The Plan invests in various investments securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amount reported in the statement of net assets available for benefits.

NOTE 10 – ADMINISTRATIVE EXPENSES

Plan administrative expenses amounted to \$6,050 and \$4,900 for December 31, 2024 and 2023, respectively. Plan administrative expenses are deducted from Plan assets. Mutual fund fees were charged against fund appreciation.

Fees paid to Burleigh Consulting Group, the third party administrator, and to Taylor, Powell, Wilson & Hartford, P.A. for audit services are not deducted from plan assets. The Plan Sponsor pays all of these fees.

NOTE 11 – CONCENTRATIONS

The industries in which the employer in Note 1 operate are primarily concentrated in a small geographical area within Mississippi.

NOTE 12 – PARTY-IN-INTEREST

Fees paid to Capital Research and Management Co., which provided investment related services, amounted to \$6,050 and \$4,900 for the years ended December 31, 2024 and 2023, respectively.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.
