We have performed audits of the financial statements of Nishikawa Cooper LLC Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institutions).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Note 1. Plan Description

The following description of the Nishikawa Cooper LLC Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General: Nishikawa Cooper LLC (the Company) is a joint venture between Nishikawa Rubber Company and Cooper Standard Automotive. The Plan is a defined contribution plan covering substantially all employees of the Company who have attained age 18 and have completed 30 days of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions: Each year, participants may elect to contribute a percentage of their pre-tax and/or after-tax wages, as defined by the Plan, limited to the maximum amount allowed by the Internal Revenue Code (IRC). Participants may also contribute amounts representing distributions from other qualified plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan Agreement contains an auto-enrollment feature in which participants are automatically enrolled after meeting the eligibility requirements noted above. Participants subject to the auto-enrollment feature start at 3% withholding with an annual increase (as defined) of 1% not to exceed 12% of compensation.

The Company may, at its discretion, make matching contributions to the Plan, as well as an additional discretionary profit-sharing contribution. For the year ended December 31, 2024, the Company contributed a Qualified Automatic Contribution Arrangement (QACA) safe harbor match of participant contributions equal to 100% of the first 1% and 50% of the next 5% of the participants' base compensation that a participant contributed to the Plan. The Company did not contribute a traditional safe harbor matching contribution or discretionary profit-sharing contribution during the year ended December 31, 2024.

Participant accounts: Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contribution, (b) Plan earnings and (c) charged with an allocation of certain administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are immediately vested in their voluntary contributions and their employer traditional safe-harbor matching contributions, plus actual earnings thereon. Vesting in the remainder of their accounts is based on years of continuous service. A participant is 100% vested in the Company's QACA matching contributions, plus actual earnings thereon, after two years of service (cliff-vesting). A participant is 100% vested in the Company's discretionary profit-sharing contributions, plus actual earnings thereon, after six years of service.

Forfeitures: Forfeitures are used to (1) reduce Company matching and/or profit-sharing contributions; and (2) pay plan expenses. No forfeitures were reallocated during the year ended December 31, 2024. Forfeited non-vested accounts at December 31, 2024 and 2023, were approximately \$256,000 and \$13,000, respectively.

Payment of benefits: Upon termination of service, attainment of age 65, death, retirement, permanent disability or other separation from service, a participant or the decedent's beneficiary will receive a lump-sum amount equal to the vested value of his or her account. Benefits are recorded when paid.

Notes to Financial Statements

Note 1. Plan Description (Continued)

Notes receivable from participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to the maximum equal to the lesser of 50% of their vested account or \$50,000. The interest rate is established based on the current prime rate, plus a factor, and currently ranges from 4.25% to 9.50% for all outstanding notes. The note repayment schedule can be no longer than 60 months, unless proceeds are used for the purchase of a primary residence. Principal and interest are paid ratably through payroll deductions.

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Delinquent loans are treated as distributions based upon the terms of the plan document.

Administration of plan assets: Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. All costs and expenses incurred in administering the Plan are charged to the Plan, unless otherwise paid by the Company.

Note 2. Significant Accounting Policies

Basis of accounting: The financial statements of the Plan are prepared under the accrual method of accounting.

Use of estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Investment valuation and income recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's administrative committee determines the Plan's valuation policies utilizing information provided by the trustee. See below for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near-term and that such change could materially affect the amounts reported in the statement of net assets available for benefits.

Fair value measurements: Accounting standards establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Note 2. Significant Accounting Policies (Continued)

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full-term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Shares of registered investment companies: Valued at the closing price reported on the active market on which the individual securities are traded.

Common collective trust fund: Valued using the net asset value (NAV) (as a practical expedient) of shares held by the fund at year-end.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Subsequent events: The Plan has evaluated subsequent events for potential recognition and/or disclosure through September 29, 2025, the date the financial statements were available to be issued.

Changes in fair value levels: To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another. We evaluate the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits. For the year ended December 31, 2024, there were no transfers in or out of Level 3 investments.

Note 5. Party-in-Interest Transactions

Fees paid to the trustee by the Plan for the year ended December 31, 2024, were approximately \$202,000. The Plan allows for participant loans. These transactions qualify as party-in-interest.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

Note 7. Tax Status and Uncertain Tax Positions

The Plan adopted a non-standardized form of a prototype plan sponsored by Lincoln. The prototype plan has received a determination letter dated June 30, 2020, from the IRS as to the prototype plan's qualified status. The prototype plan determination letter has been relied upon by this Plan. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the IRC.

The Plan's administrator has evaluated the Plan's tax positions and concluded that the Plan has maintained its tax-exempt status and had taken no uncertain tax positions that require adjustment to the financial statements. With few exceptions, the Plan is no longer subject to income tax examinations by the U.S. federal, state or local tax authorities for the years before 2021.
