***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Heat and Frost Insulators and Asbestos Workers Local 38 Retirement Investment Account Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Heat and Frost Insulators and Asbestos Workers Local 38 Retirement Investment Account Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

1. DESCRIPTION OF PLAN

The following brief description of the Heat and Frost Insulators and Asbestos Workers Local 38 Retirement Investment Account Plan, (the "Plan"), a multiemployer money purchase plan, provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

The Plan came into existence on January 1, 2001 and was initially funded by a transfer of funds from the Retirement Plan for the Heat and Frost Insulators and Asbestos Workers Local No. 38, Plan No. 001 in the amount of \$12,773,155. The transfer represented the net assets available for benefits of the defined contribution component of Plan No. 001 at the time of the transfer.

A. General:

The Plan is a defined contribution plan covering substantially all members of the Heat and Frost Insulators and Asbestos Workers Local No. 38 (the "Local"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Trustees is responsible for oversight of the Plan.

B. Contributions:

Each covered employer (as defined by the most recent collective bargaining agreement) contributes amounts monthly as required by the collective bargaining agreement in effect during the course of the Plan year. The covered employers contributed \$6.00 per hour paid for the first six months and \$6.50 per hour paid for the final six months of 2024. The covered employers contributed \$5.90 per hour paid for the first six months and \$6.00 per hour paid for the final six months of 2023. The covered employers have complied with the collective bargaining agreement contribution rates for the 2024 and 2023 Plan years. Participants may direct the trustee to invest all of the participant's accounts in specific funds or other investments permitted under the Plan. The employees are not required or permitted to make any contributions to the retirement plan. Contributions are subject to certain IRS limitations.

C. Participants Accounts:

Each participant's account is credited with the employer contribution, Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

D. Vesting:

Participant accounts are 100% vested at all times.

- E. Notes Receivable from Participants:  
Participants may not borrow from the Plan.
- F. Payment of Benefits:  
When each participant shall reach his normal retirement date (i.e. his/her 59<sup>th</sup> birthday) while in the employ of the employer, he shall be entitled to receive the full amount which has accumulated in his individual account. The participant can choose any one of the following benefit payment options:
1. Lump sum distribution
  2. Husband-wife 50% form (joint and survivor annuity)
  3. Specified monthly payment
  4. Combination lump sum and specified monthly payments
  5. The Plan allows COVID distributions of up to \$100,000. Repayment of CARES Act distributions is allowed partially or in full within three years of withdrawal of funds.

Upon termination of a participant's employment for any reason other than death, retirement or disability, which results in a break of service of six consecutive months, the terminated participant shall be eligible for a separation from service distribution. The distribution shall be in the form of a lump sum distribution of the participant's individual account.

If a participant becomes totally and permanently disabled, as defined by the Plan, prior to reaching normal retirement age (59) the participant shall be eligible for distribution of his or her individual account as if the participant had retired under the normal retirement provisions of the Plan. The distribution of the participant's disability retirement benefits shall be in the form available to participants that retire under the normal retirement provisions of the Plan.

- G. Forfeited Accounts:  
Participant accounts are 100% vested at all times. Accordingly, there are no forfeited accounts.
- H. Plan Amendments:  
Effective April 2020, the Plan adopted the suspension of required minimum distribution provision of the Coronavirus Aid, Relief, and Economic Security (CARES) Act that was signed into law on March 27, 2020. As a result of the act, required minimum distributions were completely waived for 2020. The plan has until 2026 to formally amend the Plan. Effective January 2020, the Plan was amended to allow a participant once they reach age 59½, but does not retire pursuant to terms of the Plan, to be eligible to receive an in-service partial lump sum distribution.

Effective April 2020, the Plan adopted the distribution provision of the CARES Act. A CARES Act distribution allows the Plan's participants to take a COVID-19 related distribution up to \$100,000 from the Plan beginning on or after January 1, 2020 and before December 31, 2020. The Plan has until 2026 to formally amend the Plan.

Effective January 2020, the Plan has adopted certain requirements of the Setting Every Community Up for Retirement Enhancement (SECURE) Act which changed required minimum distribution age from 70.5 to 72, requires non-spouse beneficiaries to withdraw funds within ten years, allows penalty free withdraws for new parents and other provisions. The Plan has until 2026 to formally amend the Plan.

The SECURE 2.0 Act made a change to the age of when an individual can begin taking a required minimum distribution (RMD). Effective January 1, 2023 the age to begin taking an RMD increased to 73 and will eventually increase to 75 in 2033. The Plan will need to be amended for this provision and has until December 31, 2028 to do so.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

### A. Basis of Accounting:

The financial statements of the Plan are prepared using the accrual method of accounting in conformity with accounting principles generally accepted in the United States of America.

### B. Use of Estimates:

The preparation of financial statements requires the Plan administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### C. Investment Valuation and Income Recognition:

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management of the Heat and Frost Insulators and Asbestos Workers Local 38 Retirement Investment Account Plan determines the Plan's policies utilizing information provided by the investment advisers, trustee and insurance company. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Contributions are recorded in period earned. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year, and may include interest and dividends earned in mutual funds and pooled separate accounts as allowed by Department of Labor.

- D. **Payment of Benefits:**  
Benefits are recorded when paid.
  
- E. **Administrative Expenses:**  
Expenses of maintaining the Plan are paid directly and indirectly by the Plan and are allocated directly to the participant accounts as defined in the Plan document. Investment related expenses are included in net appreciation of fair value of investments.
  
- F. **Date of Management Review:**  
Subsequent events were evaluated through October 3, 2025 which is the date the financial statements were available to be issued.

The investment and administrative expenses were netted against investment earnings on the certification as part of a revenue sharing agreement and are reflected in investment and administrative expenses on the financial statements.

All investment-related information in the accompanying supplemental Schedule H, Line 4i Schedule of Assets (Held at End of Year) as of December 31, 2024, except for \$12,792 of cash and cash equivalents. This account is used to collect contractor contributions until they are administratively segregated and allocated to participant accounts.

5. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1:

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2:

Input to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3:

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds:*

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common Collective Trusts:*

Valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchased and sales) may occur daily.

6. PARTY-IN-INTEREST

The Plan investments are primarily mutual funds managed by Alerus, the Plan trustee, as defined by the Plan and, therefore, these transactions qualify as party-in-interest. Alerus Financial, N.A. was paid \$49,570 for administrative services to the plan during 2024.

Northeast Advisors, Inc., a Registered Investment Advisor, was paid \$25,974 for investment advisory services to the Plan during 2024.

Ira H. Weinstock, P.C., the Plan's attorney, was paid \$304 for legal services provided to the Plan during 2024.

7. PLAN TERMINATION

Although it has not expressed any intent to do so, the Board of Trustees has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Participant's accounts are 100% vested at all times.

8. TAX STATUS

The IRS has determined and informed the Company by a letter dated January 11, 2002, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified and the related trust is tax-exempt. Also, on February 2, 2018, the Plan was amended based on a signed compliance statement received from the Department of the Treasury's Voluntary Compliance Group. In accordance with the compliance letter the Plan was amended to bring it in compliance with various legislative and regulatory changes.

Plan management is required to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.
