### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of HSL Asset Management L.L.C. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of HSL Asset Management L.L.C. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

### **Opinion**

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. ## **Emphasis of Matter - Correction of Error**

As discussed in Note 10 to the financial statements, certain errors resulting in the overstatement of amounts previously reported for participant contributions as of December 31, 2023, were corrected by management of the Company during the current year. Accordingly, amounts reported for excess contributions payable have been restated in the 2023 financial statements now presented and an adjustment has been made to net assets available for benefits as of December 31, 2023, to correct the error. Our opinion is not modified with respect to that matter.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about HSL Asset Management L.L.C. 401(k) Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditors' Responsibilities for the Audit of the Financial Statements**

Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. ## Notes to Financial Statements

Year Ended December 31, 2024

### 1. Description of plan:

The following description of the HSL Asset Management L.L.C. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions. The Plan was established in August 2002, and has been amended several times since that date.

#### General:

The Plan covers all employees of HSL Asset Management, L.L.C., HSL Properties Financial Corporation, HSL Construction Services, and Desert Hospitality Management, collectively referred to as the Sponsor.

The Plan is a defined contribution retirement plan with 401(k) provisions consisting of a salary reduction arrangement. The Plan covers all employees of the Sponsor who have completed 60 consecutive days of service and are at least 18 years of age. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### Participants' contributions:

Under the 401(k) provisions of the Plan, the participants may elect to defer a portion of their eligible compensation, as defined by the plan, up to current statutory limits determined annually and prescribed by the Internal Revenue Service (IRS). Participant contributions may be in the form of pre-tax or Roth contributions. The Plan also permits participants to make additional voluntary contributions of qualified rollovers from other retirement plans.

#### Employer contributions:

For eligible participants with at least one year of service, the Sponsor will contribute and allocate to each participant's account an amount equal to 50% of the participant's elective deferral up to 6% of the participant's compensation. The employer may, in addition, make discretionary contributions. Discretionary contributions, when made, are allocated to active participants on the last day of the plan year with at least 1,000 hours of service during the plan year. There were no discretionary contributions made during the current plan year. Employer contributions are invested in the same funds and increments as directed by the participant for the participant's contributions.

#### Participant accounts:

Each participant's account is credited with the participant's elective deferral, employer and rollover contributions, actual earnings thereon, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### Notes to Financial Statements (continued)

Year Ended December 31, 2024

1. Description of plan (continued):

Vesting:

Participants are immediately vested in their elective deferral and any rollover contributions made to the Plan, plus actual earnings thereon. Vesting in the employer's matching and discretionary contribution portion of the participant's accounts, plus actual earnings thereon, is based on years of credited service. Participants are fully vested after three years of credited service, or upon the normal retirement date. The Plan defines a year of credited service to be a Plan year (January 1 through December 31) with the participant rendering at least 1,000 hours of service. Upon death or total disability of a participant prior to retirement, the participant's account balance shall become fully vested.

Participants' loans:

The Plan allows for participants to obtain loans from the Plan. Loans cannot exceed 50% of the vested portion of the participant's account (or \$50,000 if less), and must be a minimum of \$500. The loan must be repaid within five years unless the entire proceeds are used to purchase the participant's primary residence, in which case the loan may be repaid over a period consistent with commercial loan practices. All loans will provide for the repayment of interest at rates commensurate with local prevailing rates, as determined by the Plan Administrator, on the date of the loan. Principal and interest are paid through payroll deductions. The participant's individual account serves as collateral for the loan. Loans will be considered in default if payments are not made for 90 days. Upon default, death, disability or termination of employment, the entire outstanding principal and accrued interest shall be immediately due and payable. Because the participant's account collateralizes the loan in its entirety, the credit quality of the participant is not assessed by the Plan Administrator. Unpaid loans will be treated as a taxable distribution from the Plan.

For financial reporting purposes, participants' loans are included in the statements of net assets available for benefits as notes receivable from participants.

Investment options:

Upon enrollment in the Plan, a participant may direct contributions in any increments into any of several investment options. Participants may change their investment options inside the platform at any time.

Payment of benefits:

On termination of service due to death, disability, retirement or other reasons, a participant may elect to receive a lump-sum distribution equal to the value of the participant's vested interest in his/her account or may elect to take partial payments. Participants with account balances less than \$5,000 must take a lump-sum distribution as soon as practicable following termination. The Plan requires mandatory distributions in excess of \$1,000 be automatically rolled over to an IRA established on behalf of participants who do not affirmatively consent to receive their distributions. The plan also allows participants who have attained the age of 59½ to take in-service distributions from the fully vested portion of their account balance.

### Notes to Financial Statements (continued)

Year Ended December 31, 2024

1. Description of plan (continued):

Forfeited accounts:

The Plan allocates participant forfeitures first to reduce administrative costs and then to reduce Sponsor contributions. At December 31, 2024 and 2023, there were no forfeited non-vested amounts to be allocated in future periods.

Hardship withdrawals:

If approved by the Plan Administrator, a participant may withdraw the vested portion of his/her account balance resulting from elective deferrals and related earnings, matching and discretionary contributions to satisfy any of the following immediate and heavy financial needs: unreimbursed medical expenses for qualified persons, purchase of a principal residence, to prevent eviction from or foreclosure on a principal residence, to pay for post-secondary education expenses for qualified persons, funeral expenses, for expenses that qualify as a casualty deduction under the Internal Revenue Code (IRC), to repair damage to a principal residence that would qualify for a casualty loss deduction or for expenses and losses incurred on account of a federally declared disaster.

2. Summary of significant accounting policies:

Basis of accounting:

The financial statements of the Plan are prepared using the accrual method of accounting.

Estimates:

The preparation of financial statements in conformity with U.S. generally accepted accounting principles (GAAP) requires the trustees to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition:

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of the fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Net appreciation in the fair value of investments includes both realized and unrealized gains and losses on investments bought and sold as well as held during the year.

#### 2. Summary of significant accounting policies (continued):

##### Notes receivable from participants:

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the plan document. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

##### Excess contributions payable:

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 excess contributions to the applicable participants prior to March 15, 2025.

##### Payments of benefits:

Benefits paid to participants are recorded when paid.

##### Expenses:

Certain expenses of maintaining the Plan are paid by the Plan unless otherwise paid for by the Sponsor. Investment related expenses are included in net appreciation in fair value of investments.

##### Subsequent events:

The Plan has evaluated the events that have occurred subsequent to December 31, 2024 through September 30, 2025, the date that the financial statements were available to be issued. The Plan has no responsibility to update these financial statements for events and circumstances occurring after this date.

#### 3. Federal income tax status:

The Sponsor has adopted a non-standardized pre-approved profit sharing plan with CODA as published by Principal Life Insurance Company, who obtained its latest opinion letter on June 30, 2020, in which the IRS stated that the Plan, as then designed, was in accordance with the applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator and the Sponsor believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### 4. Fair value measurements:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets or active markets that the Plan does not have access to;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

**Common/collective investment trusts:** These trusts' assets are invested and reinvested primarily in mutual funds, separate accounts and collective trust funds. The Plan also holds an investment in the Principal Stable Value Z Fund. The Principal Stable Value Z Fund is 100% invested in the Morley Stable Value Fund, which invests in conventional, synthetic and separate account investment contracts. The trusts are valued at the net asset value of units of the trust. The net asset value of the trust's shares is determined daily and includes adjustments for investment fees.

**Pooled separate accounts:** These accounts' assets are invested and reinvested primarily in equity securities, bonds, real estate and mutual funds. The underlying investments are valued using quoted market prices for similar assets in active or non-active markets. The net asset value of the accounts is determined daily and includes adjustments for investment fees.

**Registered investment companies:** These funds are valued at the closing price reported in the active market in which the individual securities are traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Investments:

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, dividends, and interest for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Principal Life Insurance Company and Principal Trust Company.

6. Related party transactions:

Exempt party in interest transactions:

The Plan paid certain expenses to Principal Life Insurance Company and other service providers during 2024 related to plan administration and investment activity. These transactions qualify as exempt party in interest transactions under ERISA.

Related party transactions:

Expenses that are paid directly by the Sponsor are excluded from these financial statements. Employees of the Sponsor perform certain accounting and administrative functions for the Plan, however, no employee receives compensation from the Plan.

Non-Exempt party in interest transactions:

During 2018, 2023, and 2024, the Sponsor had certain employee deferral contributions and participant loan repayments totaling \$316,459 that were not deposited as soon as it was reasonably possible to segregate them from the Sponsor's assets. Under ERISA, these are considered non-exempt party in interest transactions. The Sponsor plans to contribute lost interest to the affected participants' accounts.

7. Plan termination:

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

9. Risks and uncertainties:

The Plan invests in various investment securities that are exposed to risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

10. Restatement:

The Sponsor had not completed the required compliance testing for the Plan as of the date the prior year financial statements were issued. The prior year compliance testing was completed in the current year, resulting in an ADP/ACP failure for 2023. Refunds of \$72,731 related to the 2023 Plan year were processed in December 2024. Accordingly, the Sponsor has restated excess contributions payable and net assets available for benefits at December 31, 2023. The restatement resulted in a reduction in net increase in net assets available for benefits for 2023 of \$72,731. There was no impact to net increase in net assets available for benefits for 2024.
