INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator
4C2 Electrical Associates, LLC 401(k) Profit Sharing Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the accompanying financial statements of 4C2 Electrical Associates, LLC 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about 4C2 Electrical Associates, LLC 401(k) Profit Sharing Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control related matters that we identified during the audits.

Other Matter - Supplemental Schedules Required by ERISA

The supplemental schedules of delinquent participant contributions for the year ended December 31, 2024, and of assets (held at end of year) as of December 31, 2024, (collectively, "supplemental schedules") are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- the form and content of the supplemental schedules, other than the information in the supplemental schedules that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedules related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

1. DESCRIPTION OF THE PLAN

The following description of the 4C2 Electrical Associates, LLC 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the plan document and related adoption agreement for a more complete description of the Plan's provisions.

General

The Plan was established effective November 27, 2017, restated effective November 15, 2021, and is a defined contribution plan covering substantially all employees of 4C2 Electrical Associates, LLC (the "Employer" or the "Company"). The Plan is designed to comply with the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 (ERISA) and Internal Revenue Code (IRC), as amended.

An expansion of Setting Every Community Up for Retirement Enhancement Act of 2019 ("SECURE 2.0") was signed into law on December 29, 2022, as part of the Consolidated Appropriations Act of 2023. The effective dates of provisions within SECURE 2.0 vary through 2026. The Company has until the end of the Plan year beginning on or after January 1, 2026, to amend the Plan for the changes related to SECURE 2.0. The Plan has not been formally amended to adopt these provisions as of the date these financial statements were available to be issued.

Plan administration

The Plan is administered by the Company. Ascensus Trust Company (the "Trustee") is the asset custodian and trustee of the Plan's assets and is responsible for the custody of the Plan's investments and executing investment transactions. Ascensus LLC, as agent for the Trustee, certified the investments and investment activity as of December 31, 2024 and December 31, 2023, and for the year ended December 31, 2024. An affiliate of the Trustee is the Plan's recordkeeper and is responsible for maintaining participants' accounts and executing participant initiated transactions.

Eligibility

All employees, except for employees covered by a collective bargaining agreement and nonresident aliens, who have attained twenty-one years of age, and one year of service are eligible to participate in the Plan on the first day of the month following satisfaction of the eligibility requirements.

1. DESCRIPTION OF THE PLAN (continued)

Contributions

Plan participants may elect to contribute up to 100% of their annual eligible compensation as pre-tax or after-tax (Roth) contributions subject to the limits imposed by the IRC. Participants are automatically enrolled in the Plan upon meeting eligibility requirements, unless they affirmatively elect not to participate in the Plan. Participants automatically enrolled in the Plan defer a minimum of 3% of their annual compensation as pre-tax contributions. In addition, the Plan allows rollovers of participants' distributions from other employer qualified plans or individual retirement accounts into the Plan. Plan participants who have attained age 50 or older before the end of a calendar year are allowed to make additional contributions called "catch-up contributions" to the Plan, up to the annual contribution limit as defined in the IRC.

The Employer makes Employer safe harbor matching contributions equal to 100% of the employee's salary deferral that does not exceed 3% of their compensation, plus 50% of the employee's salary deferrals between 3% and 5% of their compensation. The Employer may also make a discretionary profit sharing contribution, as determined by the Employer. Participants must work 1,000 hours and be employed on the last day of the year to receive Employer contributions. The Employer did not make any profit sharing contributions for the year ended December 31, 2024.

Participant accounts

Each participant's account is credited with the participant's contributions, rollovers, Employer safe harbor matching contributions and discretionary profit sharing contributions, if any, an allocation or deduction of Plan earnings or losses, and charged with certain administrative expenses, as applicable. Allocations of investment earnings are based strictly on the participant's selection of investments and timing of purchases and sales. Other allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately 100% vested in employee salary deferral and rollover contributions plus actual earnings or losses thereon, as well as all Employer safe harbor contributions.

Vesting (continued)

Employees must complete at least 1,000 hours of service during a vesting computation period to be credited with a year of service. A participant's account becomes 100% vested upon death, attaining normal retirement age (the age of 59½) while an employee, retirement due to disability, or termination of the Plan.

Notes receivable from participants

Notes receivable from participants ("participant loan" or "loans") are issued directly from the participant's account balance. Under the terms of the Plan, participants may borrow from their accounts, a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. Participant loan terms are generally five years or less, but may exceed five years if the purpose of the loan is to purchase a principal residence up to 10 years. The participant loans are secured by the balance in the participant's account and outstanding loans accrue interest at a rate commensurate with rates for similar loans. A participant may not have more than one loan outstanding from their Plan account at any time. Loan principal and interest are paid through payroll deductions and becomes immediately payable upon the occurrence of a distributable event, as defined. Participant loans outstanding as of December 31, 2024, accrue interest at rates ranging from 3.25% to 8.50% with various maturity dates through March 2040.

Payment of benefits

Distributions and withdrawals are payable upon retirement, termination, financial hardship, disability, or death. In-service withdrawals from a participant's account are permitted to participant's who are 59 1/2 or older. If a participant's account balance is less than or equal to \$1,000 upon termination, the balance is distributed immediately in a lump-sum cash payment unless a direct rollover into another qualified benefit plan is requested. Balances greater than \$1,000 and less than or equal to \$7,000 will be rolled over to an individual retirement plan designated by the administrator if the participant has not requested a lump-sum cash payment or a direct rollover into another qualified benefit plan. If the account balance is over \$7,000 upon termination, the participant can consent to either a distribution paid in the form of a lump-sum cash payment, a direct rollover into another qualified plan, or postpone payment to a later date and remain in the Plan as described in the plan documents. Participants may also receive a distribution, subject to certain limitations, for a financial hardship, as defined.

Forfeited accounts

Forfeitures of terminated participants' non-vested account balances may be used to reduce Employer contributions, or to pay Plan expenses. During 2024, \$1,597 of forfeitures was used to reduce administrative expenses. As of December 31, 2024 and 2023, there were no unallocated forfeitures remaining.

Administrative expenses

Administrative expenses are generally paid by the Employer, but may, at the discretion of the plan administrator, be paid by the Plan. Transaction fees for certain participant initiated activities are individually charged to the specific account of the participant initiating any such transaction.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting and financial statement presentation

The financial statements of the Plan are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of estimates

The preparation of financial statements in conformity with U.S. GAAP requires the Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes, and disclosure of contingent liabilities, therein. Actual results may differ from those estimates.

Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and changes therein.

Investment valuation and income recognition

Investments held by the Plan are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (see Note 4).

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation of investments includes the Plan's gains and losses on investments bought and sold, as well as those held, during the year.

Contributions and contributions receivable

Contributions from participants are recorded based on the date the contributions have been separated from a participant's pay by the Company, which is the pay date. Employer contributions are recorded in the year they are earned and to coincide with the year in which the Company records contributions. The Plan records receivables for all contributions based upon the contributions recognized, less amounts received by the Plan as of the last day of the Plan year.

Rollover contributions from participants are recorded when received by the Trustee.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. If a participant ceases to make repayments and the plan administrator deems the participant note to be a distribution, the note receivable is reduced, and a benefit payment is recorded.

Payment of benefits

Benefit payments are recorded when paid.

Administrative expenses

Administrative expenses are recorded when incurred.

Subsequent events

The Plan has evaluated subsequent events through October 10, 2025, the date the financial statements were available to be issued. No subsequent events have occurred that would have a material impact on the presentation of the Plan's financial statements.

3. INFORMATION PREPARED AND CERTIFIED BY THE TRUSTEE (UNAUDITED)

The plan administrator, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of ERISA. Accordingly, the Trustee (Note 1), determined to be a qualified institution by the plan administrator, has certified, through its agent, Ascensus LLC, to the completeness and accuracy of:

- Investments and notes receivable from participants as shown in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023;

- Investment income and interest income on notes receivable from participants as shown in the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024;
- Investments and notes receivable from participants reflected in the supplemental schedule of assets (held at end of year) as of December 31, 2024 (the "supplemental schedule").

Accordingly, as requested by the plan administrator, the Plan's independent auditor performed no audit procedures on the certified information other than to agree the certified information to the related information included in the Plan's financial statements and supplemental schedule.

4. FAIR VALUE MEASUREMENTS

Accounting standards define fair value as the price that would be received from selling an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Such standards establish a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to measurements involving significant unobservable inputs (Level 3 measurements).

The three levels of fair value hierarchy are as follows:

- *Level 1* - inputs are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan has the ability to access at the measurement date;
- *Level 2* - inputs other than Level 1 that are observable, either directly or indirectly, such as quoted prices in active markets for similar assets or liabilities, quoted prices for identical or similar assets or liabilities that are not active, or either inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities; or
- *Level 3* - unobservable inputs for the asset or liability that are supported by little or no market activity and that are significant to the fair value of the asset or liability

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement in its entirety. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- Mutual funds - The Plan's investments in mutual funds are valued at the daily closing price as reported on the open market. Mutual funds held by the Plan are open-end mutual funds that are registered with the Security and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
- Common/collective trust fund (CCT) - The net asset value (NAV), as determined by the issuer, is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the CCT, the issuer reserves the right to require 12-month notification in order to ensure that securities liquidations will be carried out in an orderly business manner. Investments in the CCT can be redeemed daily and there are no unfunded commitments.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. PLAN TERMINATION

The Company has the right under the Plan to discontinue its operations at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, amounts allocated to participants' accounts become fully vested.

6. TAX STATUS

The Plan is a defined contribution plan designated and operated to qualify as a tax-exempt plan under the IRC. The non-standardized pre-approved profit sharing plan with CODA plan document used by the Plan obtained a tax opinion letter from the Internal Revenue Service dated June 30, 2020, which stated that plan document, as then defined, was in compliance with the applicable requirements of the IRC and is appropriate for use by employers for the benefit of their employees. The Company believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

7. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

ERISA defines party-in-interest similarly to the definition of a related party under U.S. GAAP, except that ERISA's definition is broader and includes all entities and individuals that provide services to the Plan; however, these entities may not necessarily be related parties. Management did not identify any related parties to the Plan that were not considered to be party-in-interest.

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, and an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons.

The Company pays certain fees and expenses on behalf of the Plan. These transactions qualify as party-in-interest transactions. The Plan is not required to repay expenses paid by the Company on its behalf.

The Trustee retains as compensation for services provided to the Plan, any interest (or "float") on amounts earned, while certain transactions are pending. This applies to both contributions and distributions. Earnings are at institutional money market rates.
