INDEPENDENT AUDITORS' REPORT

To the Plan Administrator of the Canam 401(k) Plan and its Participants:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Canam 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. 1. DESCRIPTION OF THE PLAN

The following description of the Canam 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established on January 1, 1984. The Plan covers eligible employees of Canam Steel Corporation (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and was amended and restated effective January 1, 2021. The Plan was most recently amended to reduce the eligibility requirement from three months of service to one month of service effective March 1, 2023.

Eligibility

All employees of the Company are eligible to participate in the Plan except for leased employees, collectively bargained employees unless covered by an agreement that provides for their participation, employees who are residents of Puerto Rico, seasonal employees, and interns. Effective March 1, 2023, employees were eligible to participate in the Plan after attaining age eighteen and completing one month of service. Effective March 1, 2023, employees were eligible for safe harbor contributions and discretionary profit-sharing contributions after completing one month of service.

Participant Contributions

Participants may make pre-tax or after-tax (Roth) contributions to the Plan up to 90% of compensation, as defined by the Plan, not to exceed the maximum allowable contribution under the Internal Revenue Code (the Code), which totaled \$23,000 for the year ended December 31, 2024. The participants' Roth elective contributions are allocated to a separate account maintained for such contributions. Participants who have attained or are expected to attain the age of 50 before the end of the Plan year are eligible to make additional catch-up contributions subject to limitations imposed by the Code, which totaled \$7,500 for the year ended December 31, 2024. Participants may roll over amounts to the Plan representing distributions from other qualified retirement plans.

The Plan has an automatic enrollment provision whereby an eligible employee who does not opt out of the Plan or choose a salary deferral election of their compensation is automatically enrolled to contribute 3% (Pre-tax) of their current compensation to the Plan. Eligible participants' deferral elections are automatically increased effective July 1st of the Plan year. The automatic increase provisions apply to new participants who have been automatically enrolled for at least six months and current participants who are deferring between 3% and 14% of their compensation. Participants who elect to only make Roth deferrals (after-tax) are not subject to the automatic increase provisions.

1. DESCRIPTION OF THE PLAN – cont'd.

Company Contributions

The Company contributes a safe harbor contribution of 100% of salary deferrals on the first 3% of compensation, plus 50% of salary deferrals up to the next 2% of compensation to eligible participants which includes collectively bargained employees covered under Local Unions 7886 and 8139 of the United Steel, Paper and Forestry, Rubber, Manufacturing, Energy, Allied Industrial and Service Workers International Union. Contributions are calculated on a per payroll basis. Company safe harbor contributions totaled \$3,396,665 for the year ended December 31, 2024.

The Company also allows for discretionary profit-sharing contributions to be made on behalf of each eligible participant. Participants must be employed on the last day of the Plan year to receive the discretionary contributions except for when terminated due to death, disability or reaching normal or early retirement age. The Company did not make any such discretionary contributions for the year ended December 31, 2024.

Participant Accounts

Each participant's account is participant-directed and is credited with the participant's contributions and Company contributions in accordance with the investment options selected by each participant. Any earnings, losses, and administrative expenses are allocated to a participant's account based upon the balance in each account. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately 100% vested in their voluntary and rollover contributions, and Company safe harbor contributions, plus actual earnings thereon. Participants vest in Company discretionary contributions plus earnings and losses thereon, based on year of services, as defined by the Plan agreement, according to the following schedule:

Payment of Benefits

Upon termination of service, death, disability, retirement (age 65), or attainment of age 59 ½, a participant (or their beneficiary, in the event of death) is entitled to a lump-sum distribution of their vested account balance, or periodic installments, as defined by the Plan. Eligible participants are also permitted to a distribution under qualified reservist and active-duty provisions. Upon proof, to the satisfaction of the Plan administrator, of an immediate and heavy financial need, amounts contributed by the participant may be withdrawn for hardship purposes.

Effective January 1, 2024, in accordance with the SECURE 2.0 Act (SECURE 2.0), the Plan elected to increase the threshold for mandatory distributions from \$5,000 to \$7,000. Those participants with vested account balances between \$1,000 and \$7,000 that have not elected to distribute their balance will have their balance rolled over into an individual retirement account designated by the Plan administrator without participant consent. A formal amendment incorporating all SECURE 2.0 provisions is expected to be adopted no later than December 31, 2026 in accordance with IRS guidelines. As of October 9, 2025, the Plan has not been formally amended for these provisions.

Distributions are subject to the applicable provisions of the Plan agreement. Certain income tax penalties may apply to withdrawals or distributions prior to age 59 ½. For the years ended December 31, 2024 and 2023, net assets of the Plan allocated to participants who had elected to withdraw from the Plan but had not been paid by year-end totaled \$62,227 and \$0, respectively.

Notes Receivable from Participants

Participants may borrow up to 50% of their vested account balance, not to exceed \$50,000, without regard to the intended use of the funds. The minimum note amount is \$1,000 and a participant may hold only one outstanding note at any given time. The notes are collateralized by the participant's vested account balance. Principal and interest are paid ratably through payroll deductions. The interest rate on the loan will be determined by the Plan administrator based on the prevailing interest rates charged by persons in the business of lending money for loans at the time of note issuance. Notes for reasons other than the purchase of a primary residence are to be repaid within five years. Notes for the purchase of a primary residence are to be repaid within fifteen years.

Forfeitures

Forfeitures of non-vested portions of Company contributions shall be used to reduce administrative expenses and future Company contributions, as directed by the Plan administrator. The forfeitures account totaled \$398 and \$194 as of December 31, 2024 and 2023, respectively. During the year ended December 31, 2024, no forfeitures were used to reduce administrative expenses and Company contributions.

Plan Expenses

Certain administrative expenses of the Plan are paid by the Company, except for expenses that are charged to participant accounts, including loan fees, withdrawal fees, plan administrative fees and investment management fees. Certain investment expenses which are charged within investments are included in net appreciation in fair value of investments. All other expenses of the Plan for the year ended December 31, 2024 were paid by the Company and are excluded from these financial statements.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements are prepared under the accrual method of accounting whereby income is recognized when earned and expenses are recognized when incurred.

Use of Estimates

The preparation of the financial statements in conformity with accounting principles generally accepted in the U.S. (GAAP) requires the Plan's management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought, sold, and held during the year.

Fair Value Measurement

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, defines fair value and establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value:

Interests in common/collective trusts: Valued at the net asset value (NAV) practical expedient as determined by the issuer.

Interests in registered investment companies: Valued at the closing price of shares held by the Plan at year-end. Shares are traded on an active market.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain instruments could result in a different fair value measurement at the reporting date. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent notes are treated as distributions based on the terms of the Plan agreement.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

The Plan evaluated for disclosure any subsequent events through October 9, 2025, the date the financial statements were available to be issued and determined there were no material events that warrants disclosure.

3. INVESTMENTS

All investment information disclosed in the accompanying financial statements and supplemental schedule, including assets held as of December 31, 2024 and 2023, interest and dividend income, and net appreciation in fair value of investments for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by the Trustee of the Plan, Vanguard Fiduciary Trust Company.

4. PARTY-IN-INTEREST TRANSACTIONS

The Plan loans funds to its participants according to the applicable provisions of the Plan agreement. The Plan invests in shares of mutual funds that are managed by an affiliate of the Trustee. The Company provides the Plan with certain accounting and administrative services for which no fees are charged. All such transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.

5. INCOME TAX STATUS

The Plan adopted a pre-approved plan, which received a favorable opinion letter from the Internal Revenue Service dated June 30, 2020. The opinion letter states that the Plan document is acceptable and may be relied on by an adopting employer with respect to the qualification of the Plan under Section 401(a) of the Code of 1986. The Plan administrator believes that the Plan is designed, and currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes the Plan continues to be qualified, and the related trust tax-exempt.

5. INCOME TAX STATUS – cont'd.

ASC 740, *Income Taxes*, prescribes a recognition threshold and a measurement attribute for the financial statement recognition and measurement of tax positions taken or expected to be taken in a tax return as well as guidance on de-recognition, classification, interest and penalties and financial statement reporting disclosures. For these benefits to be recognized, a tax position must be more-likely-than-not to be sustained upon examination by taxing authorities. Given the Plan is tax exempt and has no unrelated business income, the provisions of ASC 740 do not have an impact on the Plan's financial statements. The Plan recognizes interest and penalties accrued on any unrecognized tax exposures as a component of income tax expense. The Plan does not have any amounts accrued relating to interest and penalties as of December 31, 2024 and 2023.

The Plan is subject to routine audits by the IRS and Department of Labor; however, there are currently no audits for any periods in progress.

6. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions and terminate the Plan, subject to the provisions of ERISA. In the event of termination of the Plan, affected participants will become 100% vested in their accounts and the net assets of the Plan will be distributed to participants based upon individual account balances.
