Note 1. Description of Plan

The following description of The Maybe Pharma Commercial LLC (formerly Mayne Pharma Inc.) ("Company") 401(k) Plan ("the Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General:

The Plan is a defined contribution plan covering all employees of the Company. Prior to April 10, 2016, the Plan had a six month service requirement for eligibility in the Plan. Effective April 10, 2016, the Plan eliminated the six month service requirement. Employees of the Company are now considered eligible to participate the in the Plan the first day of the month after employment. The elimination of the six month service requirement was applied retroactively. Employees must also be eighteen years of age or older in order to be eligible. Prior to May 11, 2018, employees needed to be twenty-one years of age to be eligible. The Plan is subject to the provisions of ERISA. The Plan's Administrative Committee is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Company's Board of Directors. The Company is a wholly owned subsidiary of Mayne Pharma Inc. Group Limited. Effective September 1, 2015, the Plan added Libertas Pharma, Inc. as a related employer. Effective July 28, 2016, the Plan added Mayne Pharma LLC as a related employer. Effective January 11, 2021, the Plan added Adelaide Apothecary, LLC as a related employer.

Contributions:

Each year, participants may contribute up to the maximum annual pretax contribution or an after-tax 401(k) Roth contribution, as defined in the Plan and imposed by the Internal Revenue Code. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan offers various mutual funds and common collective trust funds as investment options for participants. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate (pre-tax) set at 4 percent of eligible compensation. The Company contributes a discretionary matching contribution. The Company contributes 50 percent of the first 10 percent of compensation that a participant contributes to the Plan. Participants also direct their matching contribution into the various investment options offered by the Plan. Contributions are subject to certain IRS limitations.

Note 1. Description of Plan (Continued)

Participant Accounts:

Each participant's account is credited with the participant's contribution and the Company matching contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting:

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's matching contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100 percent vested after three years of credited service. Prior to April 10, 2016, the Plan used a six year graduated schedule for vesting.

Notes Receivable from Participants:

Participants may borrow from their fund accounts, a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's vested account. The loan interest rate, determined quarterly, is set at the prime rate, as defined. Principal and interest is paid ratably through payroll deductions.

Payments of Benefits:

On termination of service due to death, disability, retirement or other termination reasons, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount, or periodic payments over a defined period of time if the participant's vested interest exceeds \$5,000. Any distribution greater than \$1,000 (but less than \$5,000) that is made to a participant without the participant's consent before the participant's normal retirement age (or age 62, if later) will be rolled over to an individual retirement plan designated by the Plan Administrator.

Note 2. Summary of Significant Accounting Policies

Forfeited Accounts:

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$148,572 and \$317,519, respectively. These accounts will be used by the Plan to pay or reduce future employer matching contributions. During 2024, Plan expenses of the employer in the amount of \$8,886 and were paid and \$497,272 of employer contributions were paid from the forfeited non-vested accounts.

Basis of Accounting:

The accompanying financial statements are prepared on the modified cash basis of accounting with revenue recognized when received and expenses as paid. However, investments are reported at fair value. Accordingly, the financial statements are not intended to present the net assets available for benefits and changes in net assets available for benefits of the plan in accordance with accounting principles generally accepted in the United States.

Use of Estimates:

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that effect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition:

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Administrative Committee determines the Plan's valuation policies utilizing information provided by the investment advisors and trustee of the Plan. See note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the cash basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains or losses on investments bought or sold as well as held during the year.

Notes Receivable from Participants:

Notes receivable from participants are measured at their unpaid principal balance. Interest income is recorded on the cash basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits:

Benefits are recorded when paid.

Expenses:

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are charged directly to the Plan.

Note 3. Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include: Quoted prices for similar assets or liabilities in active markets; Quoted prices for identical or similar assets or liabilities in inactive markets; Inputs other than quoted prices that are observable for the asset or liability; Inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common Collective Trusts and Pooled Separate Accounts: Valued at the net asset value of units of the collective trusts. The net asset value, as provided by the trustee, is used as a practical expedient to estimate fair value. The net asset value is based on the fair value of the underlying investments held by the funds less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported net asset value. Participant transactions (purchases and sales) may occur daily. There are no redemption restrictions associated with the common collective trust or pooled separate account.

Note 4. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

Note 5. Tax Status

Effective June 10, 2015, the Plan was restated to adopt Fidelity's Volume Submitter Defined Contribution Plan (basic plan document #17). The Volume Submitter Plan was restated for the Pension Protection Act of 2006 and other legislative and regulatory changes. The Fidelity plan has received an opinion letter dated June 30, 2020. The volume submitter plan has been amended since receiving its favorable opinion to comply with ERISA regulations. However, the plan sponsor believes that the Plan is designed, and is currently being operated, in compliance with applicable requirements of the Internal Revenue Code and therefore believes that the Plan is qualified and the related trust is tax-exempt. See Note 10 for additional information on changes to the Plan.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2022.

Note 6. Information Prepared and Certified by Trustee (Unaudited)

The information related to investments disclosed in the accompanying financial statements and supplemental schedule including all investments held at December 31, 2024 and 2023 and net appreciation in value of investments and interest for the year ended December 31, 2024 was obtained or derived from data that has been prepared and certified to as complete and accurate by Fidelity Management Trust Company, the trustee of the Plan.

Note 7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities of the Plan are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 8. Subsequent Events

The Plan has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued.

Note 9. Related Party Transactions and Party In Interest

Certain Plan investments in the amount of \$8,697,135 and \$7,141,459 at December 31, 2024 and 2023, respectively are shares of mutual funds managed by Fidelity Management Trust Company (FMTC). FMTC is the Trustee as defined by the Plan; therefore, these transactions qualify as party-in-interest transactions.

The Plan has entered into an agreement with Fidelity Investments Retirement Plan Service Agreement whereby recordkeeping and administrative services will be based on fixed basis point pricing. FMTC receives revenue from mutual fund service providers for services FMTC provides to these funds. This revenue is used to offset certain amounts owed to FMTC for its administrative services to the Plan. If the administrative fees exceed the revenue sharing amount, the remaining balance will be charged to the participants' accounts. To the extent that the revenue sharing amounts exceed the administrative expenses, such amounts will not be applied to any future administrative costs, but may generate a Fidelity service credit that may be used to purchase additional Fidelity Services as agreed upon by the parties. The Plan made a direct payment to Fidelity for recordkeeping and trustee fees in the amount of \$34,854 which was not covered by revenue sharing for the year ended December 31, 2024. The Plan Sponsor pays directly any other fees related to the Plan's operation.

Note 10. Plan Changes

The Plan was amended to change the way participant loans and distributions are processed. Effective April 13, 2023, the Trustees have given authorization for pre-approval of routine loans, distributions and hardship distributions that do not require spousal approval. Fidelity will process those payments without any interaction by the Company. Fidelity will automatically process distributions for terminated employees that have vested account balances under \$5,000 and required minimum distributions for retirees. Existing participant loans will be processed via payroll deductions and remitted by the Company to Fidelity. New loans will be processed by Fidelity and repayments will be made through a direct payment by the participant to Fidelity. The Plan will also allow for in-house ROTH conversions.

Effective June 9, 2023, if a participant is terminated for a reason other than death and has an outstanding loan balance, the amount will not be due immediately. The loan shall continue to be payable in accordance with the loan term provisions.

Effective November 29, 2023, Plan officials approved an amendment and restatement of the Basic Plan Document. With this adoption, the Plan allows participants to change withholding amounts at the beginning of each pay period. The Plan allows participant loans to continue after a participant terminates employment.
