INDEPENDENT AUDITORS' REPORT

To the Plan Administrator, Participants and Beneficiaries
of the Upper Lakes Foods, Inc. Retirement Savings Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Upper Lakes Foods, Inc. Retirement Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

NOTE A - DESCRIPTION OF THE PLAN

The following description of Upper Lakes Foods, Inc. Retirement Savings Plan (the "Plan") is provided for information purposes only. Participants should refer to the plan document for a more complete description of the Plan's provisions.

[1] General:

The Plan is a defined contribution plan adopted by Upper Lakes Foods, Inc. (the "Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The plan administrator is responsible for oversight of the Plan. Management determines the appropriateness of the Plan's investment offerings and monitors investment performance, and reports to the Plan's investment committee.

Standard Insurance Company is the recordkeeper of the Plan. Minnesota Life Insurance Company holds the Plan's investment assets.

[2] Eligibility:

Employees become eligible to participate upon attaining age 18. Employees are eligible to make salary deferral contributions and receive matching contributions to the Plan the first of the month three months after their date of hire. There is an automatic enrollment feature whereby eligible participants automatically make pre-tax contributions equal to 3% of eligible compensation to a default investment fund until changed by the participant. To be eligible for company discretionary contributions, employees generally become participants on the first entry date after completing one year of employment, attaining age 18, and were employed by the Company on the last day of the plan year. Entry dates are on the first day of the month on or after eligibility requirements are met.

[3] Contributions:

Participants may elect to make pre-tax salary deferral contributions, not to exceed annual limitations specified in the Plan. Pre-tax salary deferral contributions cannot exceed the amount allowable under Section 415 of the Internal Revenue Code ("IRC"). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants also may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants may also make after-tax Roth 401(k) deferral contributions. Participants direct the investment of their contributions into various investment options offered by the Plan. The Company may make discretionary and matching contributions as determined annually by management. There were no discretionary contributions for the year ended December 31, 2024. During the year ended December 31, 2024, the Company made matching contributions of 50% up to 6% of employee eligible compensation, resulting in \$657,983 in matching contributions.

[4] Participant accounts:

Each participant's account is credited with the participant's contributions and the Company's contributions, as well as allocations of plan earnings. Discretionary contributions are allocated in the same proportion that each participant's eligible compensation bears to the total eligible compensation of all participants. Participant accounts are charged with plan losses and an allocation of administrative expenses that are paid by the Plan. Plan earnings and losses are allocated based on account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

NOTE A - DESCRIPTION OF THE PLAN (CONTINUED)

[5] Vesting:

Participants are always 100% vested in their pre-tax salary reduction contributions, Roth contributions, rollover contributions, and related earnings. Participants vest 20% each year beginning after two years of service until reaching four years of service and becoming 100% vested in their employer-derived contributions and related earnings. Upon termination of employment, any nonvested amount of employer-derived contributions is forfeited.

[6] Notes receivable from participants:

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Participants may borrow from their fund accounts a minimum of \$1,000 and up to a maximum of \$50,000 (reduced by the highest outstanding loan balance of loans during the one-year period ending the day before the new loan is made). Loans may not exceed 50% of the vested account balance. The loans are secured by the vested balance in the participant's account. Loan terms range from one to five years; however, terms may exceed five years for the purchase of a primary residence. The loan interest rate, determined quarterly, is set at a commercially reasonable rate of interest. The loans mature at various dates through October 2029 and bear interest at rates ranging from 3.25% to 10.50% at December 31, 2024 and 2023. Principal and interest are paid ratably through payroll deductions for loans taken out prior to December 31, 2020. Beginning January 1, 2021 for all new loans, principal and interest is paid through ACH or check. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are recorded as distributions on the basis of the terms of the plan agreement.

[7] Normal and early retirement:

Normal and early retirement ages are 65 and 55, respectively. Participants vest 100% in their account balances at age 65 (for active employees) or 55 (upon early retirement), although actual payment of benefits may generally not begin until the participant is entitled to a distribution under terms of the Plan.

[8] Payment of benefits:

A participant or a participant's beneficiary is entitled to 100% of the account balance in the event of permanent disability or death, or their vested balance at retirement. In addition, participants may obtain hardship withdrawals, as defined by the Plan. Participants with vested account balances that do not exceed \$7,000 (\$5,000 through December 31, 2023) will be distributed directly to the participant or to an eligible retirement plan as of the earliest date of their retirement, death, or termination. If no election is made, it will be paid directly to an IRA. Vested benefits that exceed \$7,000 (\$5,000 through December 31, 2023) are distributed either in a single lump-sum payment or installments over a period not more than the participant's life expectancy.

[9] Forfeitures:

At December 31, 2024 and 2023, forfeited nonvested amounts totaled \$0 and \$27,610, respectively. These amounts are used by the Company to pay plan expenses or to reduce employer contributions. Any remaining forfeitures will be allocated to active participant accounts annually. The Company used \$64,593 in forfeitures to reduce employer contributions and \$440 to pay plan expenses during the year ended December 31, 2024.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

[1] Basis of accounting:

The financial statements of the Plan are prepared on the accrual basis of accounting.

[2] Use of estimates:

The preparation of the financial statements, in accordance with accounting principles generally accepted in the United States of America, requires management to make estimates and assumptions that may affect certain amounts and disclosures in the financial statements and accompanying notes. Actual results could differ from those estimates.

[3] Investment valuation and income recognition:

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Management determines the Plan's valuation policies utilizing information provided by the investment adviser and insurance company (see Note D for a discussion of fair value measurements).

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Realized gains and losses related to sales of investments are recorded on a trade-date basis, and unrealized gains and losses are recorded based on the fair value as of the end of the plan year. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

[4] Payment of benefits:

Benefits paid to participants are recorded when paid.

[5] Administrative expenses:

The Plan's expenses are paid either by the Plan or the Company, as provided by the plan document. Expenses that are paid directly by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, certain investment related expenses are included in net appreciation in fair value of investments presented in the accompanying statement of changes in net assets available for benefits.

[6] Subsequent events:

The Plan has evaluated subsequent events through October 9, 2025, the date the financial statements were available to be issued.

NOTE C - INVESTMENT CERTIFICATION

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. Investments and notes receivable from participants held at December 31, 2024 and 2023, and investment income and interest on notes receivable from participants, for the year ended December 31, 2024 that are disclosed in the accompanying financial statements and supplemental schedule, were obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Minnesota Life Insurance Company. Minnesota Life Insurance Company and its affiliates are collectively referred to as Minnesota Life Insurance Company.

NOTE D - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurements and Disclosures*, are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Pooled Separate Accounts - Pooled separate account investment options are separate accounts that invest directly in one underlying mutual fund. Pooled separate accounts are offered and managed by Minnesota Life Insurance Company. Pooled separate accounts are valued using the unit value calculated based on the net asset value ("NAV") of the underlying pool of securities that are mutual funds. Mutual funds trade on one or more U.S. or foreign exchanges, and the fair value is derived based on the closing prices for the underlying securities.

NOTE D - FAIR VALUE MEASUREMENTS (CONTINUED)

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE E - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Minnesota Life Insurance Company is the Plan's insurance company, Standard Insurance Company is the record keeper, and MHS Advisory Services, LLC is the investment advisor and, therefore, transactions with these entities qualify as party-in-interest transactions. Fees incurred and paid directly by the Plan to Standard Insurance Company and MHS Advisory Services, LLC for administrative services were \$9,405 and \$55,934, respectively, during the year ended December 31, 2024.

NOTE F - TAX STATUS

The Company adopted a non-standardized pre-approved plan sponsored by Minnesota Life Insurance Company. The non-standardized pre-approved plan sponsor obtained its latest determination letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since receiving the determination letter, the plan administrator and the Plan's tax counsel believe the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by a government authority. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

NOTE G - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks, as well as the financial strength of the insurance company. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Volatility in the financial markets may significantly impact the subsequent valuation of the Plan's investments. Accordingly, the valuation of investments at December 31, 2024 may not necessarily be indicative of amounts that could be realized in a current market exchange.

NOTE H - PLAN TERMINATION

Although the Company has not expressed any intent to do so, it has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants become 100% vested in their employer contributions.
