Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2024 Financial Statements

We have performed an audit of the financial statements of MBA Tech, Inc. Retirement Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). Basis for Opinion on the 2024 Financial Statements

We conducted our audit in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the 2024 Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion on the 2024 financial statements.

Responsibilities of Management for the 2024 Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

NOTE 1 - DESCRIPTION OF PLAN

The following description of the MBA Tech, Inc. Retirement Savings Plan (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

General: The Plan is a defined contribution plan covering all non-union employees of Convergix East Michigan, LLC (the “Company” or “Employer”) who have attained age 18 and completed one hour of service. Effective September 12, 2024, the Company changed its legal name from MBA Tech, Inc. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Contributions: Participants are allowed to contribute up to 100% of their eligible compensation, as defined by the Plan, limited to the maximum amount established by the Internal Revenue Service (“IRS”). Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Plan allows elective catch-up contributions of amounts established by the IRS for those participants who have attained age 50 by the close of the Plan year. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to contribute to the Plan. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. The Company makes matching contributions of 100% on the first 1% of compensation plus 50% on the next 5% of compensation that employees contribute to the Plan. The Company may also make additional discretionary matching contributions not to exceed 6% of participant compensation and discretionary profit-sharing contributions. The Company contributed \$290,582 in matching contributions and \$0 in profit-sharing contributions to the Plan for the year ended December 31, 2024.

Participant Accounts: Each participant’s account is credited with the participant’s contributions and an allocation of Employer contributions and Plan earnings (losses) and is charged with his or her withdrawals and an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. Participants direct the investment of their contributions and Company contributions into various investment options available under the Plan.

Vesting: Participants are immediately vested in their contributions plus actual earnings thereon upon entry into the Plan. Vesting in Company contributions is based on years of continuous service. Participants are 20% vested in matching contributions after one year of credited service and 100% after two years of credited service. Profit sharing contributions vest at a rate of 20% per year and become 100% vested after five years of credited service. In addition, matching and profit-sharing contributions become 100% vested upon a participant’s attainment of age 65, death or disability, in each case while still employed with the Company.

Payment of Benefits: Upon termination of service, a participant (or their beneficiaries upon death of the participant) is eligible to receive an amount equal to the vested interest of his or her account in a lump-sum payment or in various installment annuities. In-service withdrawals are also permitted for active participants who have attained age 59½. In addition, participants may make “hardship withdrawals,” as defined by the Plan.

Notes Receivable from Participants: Participants may borrow from their account a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The loans are secured by the balance in the participant’s account, bear interest at prevailing interest rates, and cannot exceed five years unless the loan is for the purchase of a principal residence. Principal and interest are paid through payroll deductions.

Forfeitures: Forfeitures of nonvested account balances of terminated participants are used to pay administrative expenses of the Plan or to reduce Employer contributions. During the year ended December 31, 2024, forfeitures of \$2,910 were used to reduce administrative expenses. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$37,184 and \$14,489, respectively.

Administrative and Investment Management Expenses: Plan recordkeeping and custodial fees are paid by the Plan and reflected in the financial statements as administrative expenses. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment management fees are charged to the Plan as a reduction of investment return and included in investment income reported by the Plan. All other expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition: The Plan's investments are reported at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value. Contract value is the relevant measure for the investment contract because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the contracts. Purchases and sales of investments are reflected on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Risks and Uncertainties for Investments: The Plan provides for various investment options. The underlying investments are exposed to various risks, such as interest rate, market, liquidity and credit risks. Due to the level of risk associated with certain investments and the level of uncertainty related to changes in the value of investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participant's account balances and the amounts reported in the statements of net assets available for benefits.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances.

Benefit Payments: Benefits are recorded when paid.

Subsequent Events: Plan management has evaluated subsequent events for recognition and disclosure through October 13, 2025, the date the financial statements were available to be issued.

NOTE 3 - CERTIFIED INVESTMENTS AND NOTES RECEIVABLE FROM PARTICIPANTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Sentry Life Insurance Company, the custodian of the Plan (“Sentry”).

NOTE 4 - FAIR VALUE MEASUREMENTS

Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan’s principal or most advantageous market for the asset or liability. Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan’s own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following descriptions of the valuation methods and assumptions used by the Plan to estimate the fair values of investments apply to investments held directly by the Plan.

Pooled Separate Accounts: As a practical expedient, the fair value of participation units held in pooled separate accounts are based upon the net asset values per unit as provided by Sentry and are not assigned a level in the fair value hierarchy. The pooled separate accounts of \$8,990,795 and \$7,949,616 at December 31, 2024 and 2023, respectively, provide for daily redemptions by the Plan at reported net asset value per share, with no advance notification requirement or redemption restrictions.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 – INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan holds a traditional investment contract with Sentry which meets the criteria as a fully benefit-response investment contract and is therefore reported at contract value. Contract value represents contributions made to the contract, plus earnings, less participant withdrawals and administrative expenses. Sentry maintains the contributions in its general account and guarantees the Plan a return of principal and interest under the terms of the contract. The interest crediting rate is updated quarterly based upon contract provisions, and it may not be less than the guaranteed minimum interest rate, as shown on the contract specifications. The general account is credited with earnings on the underlying investments and is charged for participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value.

The Plan's investment contract specifies certain events that might limit the ability of the Plan to transact at contract value. Such events include failure of the Plan to maintain its qualified plan and tax-exempt status, premature contract termination initiated by the Company, Plan termination or merger, changes to the Plan's prohibition on competing investment options, and bankruptcy of the Plan Sponsor or other events that significantly affect the Plan's operations. In addition, certain events allow the contract issuer to terminate the contract and settle at amounts different from contract value. Such events include failure by contract holder to pay expense charges, failure by contract holder to provide information or contributions required under the contract, failure by contract holder to make contributions over and above expenses charged, the Plan's loss of its qualified plan status, and complete or partial termination of the Plan.

Plan management does not believe there are any events probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with participants.

NOTE 6 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Company contributions and earnings thereon.

NOTE 7 - PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the Employer, and certain others. Certain Plan investments are managed by Sentry or their subsidiaries or affiliates. Investment management fees paid by the Plan to investment managers, which are parties-in-interest, are reflected in the financial statements as a reduction of the return on the Plan's investments. Recordkeeping and custodial fees also qualify as parties-in-interest transactions. The Company provides certain accounting, recordkeeping and administrative services to the Plan for which it receives no compensation. Certain fees are paid by the Company for administration of the Plan. Notes receivable from participants are also considered party-in-interest transactions.

NOTE 8 - TAX STATUS

The Internal Revenue Service issued an opinion letter, most recently dated June 30, 2020 that stated the prototype plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code. Plan management believes that the Plan is currently being operated in accordance with the Internal Revenue Code and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.
