We have performed an audit of the financial statements of Mid West Fabricating Company 401(k) Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

**Plan Description**

The following description of the Mid West Fabricating Company (the "Company") 401(k) Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Employees are eligible for participation in the Plan after completing six months of full-time service and after having attained the age of 18. Benefits are based on the employees' contributions (elective deferrals), plus the employees' share of Mid West Fabricating Company's matching and discretionary contributions and accumulated income from investments. Benefits may be paid as a lump-sum amount or in installments upon retirement, withdrawal, or termination.

Contributions

Participant contributions are recorded and credited to each participant's account when received by the trustee. Any contributions attributable to the Plan year but not received by the trustee by the last day of the Plan year are recorded as a receivable.

Each year, participants may contribute up to 100% of pre-tax annual compensation, as defined in the Plan agreement. The Plan also provides for after-tax Roth elective deferrals. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans. The Plan has an automatic enrollment requirement for pre-tax contributions of 1% of eligible compensation unless the participant makes another election. The amount of such automatic enrollment will increase annually by 1% up to a maximum of 6% of the participant's compensation. The Company will match 50% of the participant's elective deferral that does not exceed 6% of the participant's compensation.

In 2021, the Plan adopted provisions to allow for after-tax employee contributions into the Plan. Also, the Plan adopted a provision that allowed for entry and modification of contribution elections on a monthly basis.

Additional discretionary contributions may be made by the Plan Sponsor at the option of the Plan Sponsor's Board of Directors; however, no additional discretionary contributions were made in 2024 or 2023. The Plan provides for the acceptance of rollover contributions from other plans qualified under the Internal Revenue Code ("IRC"). Contributions are subject to certain limitations.

Participant Accounts

Each participant's account is comprised of the participant's contributions and allocations of (a) the Company's contributions, (b) Plan earnings, and (c) charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan Document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions and employer contributions, plus actual earnings thereon.

Effective September 1, 2024, the Company amended the Plan Document to change vesting in Company matching contributions and non-elective contributions. Vesting in the Company's matching and non-elective portions of their accounts plus actual earnings thereon is based on years of continuous service and is subject to the following vesting percentage provisions:

<u>Years of Service</u>	<u>Vesting Percentage</u>
Less than three years	0%
Three or more years	100%

Employees are 100% vested in Company matching contributions and non-elective contributions plus actual earnings thereon made prior to September 1, 2024.

Investment Options

A participant may direct Company and participant contributions in any of the various investment options offered by the Plan. Participants may change their investment options at any time.

Payment of Benefits

A participant may receive the value of his or her vested account upon retirement, disability, or termination. Upon death of a participant, the beneficiary shall be entitled to the full value of the account. Distributions are made in either a lump-sum or equal installments not to exceed the life expectancy of the participant. The Plan also provides for in-service distributions if certain financial hardship conditions are met or upon reaching age 59½ while employed by the Company.

Forfeited Accounts

There were no forfeitures in the Plan as of December 31, 2024 or 2023. These accounts will be used to reduce Company matching contributions, added to other Company contributions, or reallocated, as elected by the Company. No forfeitures were used during 2024 or 2023.

Cash and Cash Equivalents

Cash and cash equivalents consist of funds received by the Trustee and not yet allocated to participants at year-end of \$23,029 and \$36,782 and cash for brokerage transactions of \$4,703 and \$4,022 for the years ended December 31, 2024 and 2023, respectively.

SECURE ACT 2.0

On December 23, 2022, Congress passed the Consolidated Appropriations Act of 2023 which included SECURE Act 2.0. SECURE Act 2.0 contains over 90 new retirement provisions, with varying effective dates through 2027. Since SECURE Act 2.0 provisions include both required and optional elements, the Plan Administrator will determine the optional provisions to elect and amend the Plan Document accordingly. Most of the significant provisions will become effective in 2024 and thereafter. Accordingly, there is no material impact to the Plan's 2024 financial statements.

**Summary of Significant Accounting Principles**

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

The Plan's administrative expenses are paid by either the Plan or the Company, as provided by the Plan agreement.

Reclassification

Certain accounts presented on the 2023 financial statements have been reclassified in order to conform to the 2024 presentation.

**Fair Value Measurements**

ASC 820, Fair Value Measurements and Disclosures establishes a framework for measuring fair value which provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurement) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common Collective Trust:* Valued at the NAV provided by the administrator of the fund. Issues and redemptions of units are recorded upon receipt of unit holder's instructions based on the determined NAV per unit, which is determined daily. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. For this fund, there are no unfunded commitments, redemption restrictions, and participants can transact daily.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Certified Investment Information**

**Related Party Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50 percent or more of such an employer or employee association, or relatives of such persons.

Plan and participant fees paid for third-party administration, investment advisory, and trust service of the Plan amounted to \$5,088 and \$38,200 for the years ended December 31, 2024 and 2023, respectively. The Plan invests in various funds of the Plan recordkeeper and Custodian. The Company provides certain administrative services at no cost to the Plan. If revenue is received by the Custodian from mutual fund service providers under a revenue sharing arrangement, the Custodian remits to the Plan on a quarterly basis. Such amounts are used to reduce Plan administrative expenses.

Certain Plan investments are shares in accounts that are managed by Fidelity Personal Trust Company. Fidelity Personal Trust Company is the Custodian as defined by the Plan and qualifies as a party-in-interest.

**Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions and terminate the Plan. In the event of termination or partial termination of the Plan, all amounts credited to a participant's account, including Company contributions, become fully vested.

**Tax Status**

The Company adopted a prototype standardized profit sharing plan that received a favorable opinion letter from the Internal Revenue Service on June 30, 2020, which stated that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the accompanying statements of net assets available for benefits.

**Subsequent Events**

The Plan has evaluated subsequent events through July 16, 2025, the date the financial statements were available to be issued.
