Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). ### 1. DESCRIPTION OF THE PLAN

The following description of DS Graphics Employee Savings 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

#### a. General

The Plan is a defined contribution 401(k) plan covering all eligible employees of DS Graphics, Inc. (the Plan Sponsor) (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan Administrator and Trustees are responsible for the oversight of the Plan. The Plan Administrator and Trustees determine the appropriateness of the Plan's investment offerings, monitor investment performance, and report to the Plan Sponsor's Board of Directors.

#### b. Eligibility

Upon completion of three months of service with the Plan Sponsor, employees are eligible to participate in the Plan provided they have attained the age of twenty-one. Employees are also eligible to receive the Plan Sponsor's discretionary matching contributions, discretionary profit-sharing contributions, and discretionary qualified non-elective contributions upon completing three months of service and attaining the age of twenty-one. Additionally, to be eligible for the discretionary profit-sharing contributions, employees must also have worked 500 hours during the plan year. The Plan excludes employees covered by a collective bargaining agreement and non-resident aliens.

#### c. Contributions

Each year, participants may contribute up to 100% of pre-tax annual compensation, as defined in the Plan, up to the maximum allowed by the Internal Revenue Service (IRS). The Plan allows for catch-up contributions for participants who have attained the age of fifty by the end of the plan year. The Plan allows for participants to make post-tax (Roth) contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans (rollover contributions). Participants direct the investment of their contributions into various investment options offered by the Plan.

Employees of the Plan Sponsor, who do not affirmatively elect otherwise, are automatically enrolled into the Plan once the eligibility requirements have been met. Employees who are automatically enrolled default to deferral contributions in the amount of 3% or elects otherwise.

The Plan Sponsor makes discretionary matching contributions equal to 25% of the participant's employee contributions that does not exceed 6% of a participant's eligible compensation. The Plan Sponsor's matching contributions, profit-sharing contributions, and qualified non-elective contributions are discretionary and are determined annually by the Plan Sponsor. Discretionary profit-sharing contributions and qualified non-elective contributions are allocated based on a formula determined by the Plan Sponsor's Board of Directors. Discretionary matching contributions totaled \$156,711 for the year ended December 31, 2024. The Plan Sponsor did not contribute any discretionary profit-sharing contributions or qualified non-elective contributions for the year ended December 31, 2024.

#### d. Participant Accounts

Each participant's account is credited with the participant's contributions, allocations of the Plan Sponsor's contributions and plan earnings or losses, and charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant's earnings or losses, account balances, or specific participant transactions, as defined in the plan document. The benefit to which a participant is entitled to is the benefit that can be provided from the participant's vested account.

#### e. Vesting

Participants are vested immediately in their contributions, the Plan Sponsor's discretionary qualified non-elective contributions, plus actual earnings or losses thereon. Participants vest in the Plan Sponsor's discretionary matching contributions and discretionary profit-sharing contributions based on a six-year graded schedule as follows:

<u>Years of Service</u>	<u>Percentage</u>
1 year or less	0%
2 years but less than 3	20%
3 years but less than 4	40%
4 years but less than 5	60%
5 years but less than 6	80%
6 years or more	100%

Participants become fully vested upon attainment of normal retirement age, death or disability.

#### f. Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or one-half of their vested account balance. The loans are secured by the balance in the participant's account. Participants may have up to two loans outstanding at any time. Loan terms range from one to five years, unless for the purchase of a primary residence, in which case the term may be up to thirty years. Interest is due on the outstanding principal balance at a rate equal to the prime loan rate plus 2%. Principal and interest are paid ratably through payroll deductions.

#### g. Payment of Benefits

The Plan provides for a normal retirement benefit to be paid to participants who have reached the age of 65, with no option for early retirement. Upon termination of services, a participant may elect to receive a lump-sum, installment, or partial payments equal to the value of the participant's vested account balance or leave their balance in the Plan if the balance is over \$5,000. The Plan requires balances up to \$1,000 to be paid out to participants upon termination, and requires balances from \$1,000 to \$5,000 be rolled over to an individual retirement account (IRA). Effective January 1, 2024, the Plan adopted the SECURE Act 2.0 provision by increasing involuntary force-out distributions to \$7,000.

#### g. Payment of Benefits (Continued)

The Plan allows in-service withdrawals upon attainment of age 59½. A participant may also request a withdrawal upon demonstration to the Plan Administrator that they are suffering a "hardship". Hardship is defined in applicable regulations promulgated or to be promulgated pursuant to the applicable section of the Internal Revenue Code (IRC) or standards established by the Secretary of the Treasury or their delegate.

#### h. Forfeitures

Forfeitures represent non-vested Plan Sponsor discretionary contributions forfeited by participants who terminate their employment or who withdraw from the Plan. Forfeitures are retained by the Plan and are used to reduce future Plan Sponsor contributions and pay plan expenses. The Plan had \$3,849 of unallocated forfeitures as of December 31, 2024. The Plan had no unallocated forfeitures as of December 31, 2023. The Plan Sponsor used \$3,477 of forfeitures to pay plan expenses during 2024.

### 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### Basis of Presentation

The Plan prepares its financial statements in accordance with generally accepted accounting principles (U.S. GAAP) established by the Financial Accounting Standards Board (FASB). References to U.S. GAAP in these notes are to the FASB Accounting Standards Codification (ASC).

#### Use of Estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for disclosure of fair value measurement.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation of investments includes gains and losses on investments bought and sold, as well as held during the year.

#### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded on an accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. No allowances for credit losses have been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan payments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded. As of December 31, 2024, there were \$59,366 of defaulted loans that have been deemed distributed and are included in benefits paid to participants in the accompanying statement of changes in net assets available for benefits.

#### Contributions

Contributions from plan participants and the discretionary matching contributions from the Plan Sponsor are recorded in the year which the participant contributions are withheld from compensation. The Plan Sponsor's discretionary profit-sharing contributions and discretionary qualified non-elective contributions are recorded when such contributions are authorized by the Plan Sponsor's Board of Directors.

#### Payment of Benefits

Benefits are recorded when paid.

#### Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements. Fees related to recordkeeping, the administration of participant loans, and processing of distributions are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation of investments.

#### Subsequent Events

Subsequent events have been evaluated through October 7, 2025, which is the date the financial statements were available to be issued. There were no events that met the criteria for recognition or disclosure in the financial statements.

### 3. INFORMATION PREPARED AND CERTIFIED BY THE PLAN'S QUALIFIED INSTITUTION

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Ascensus, LLC, as an authorized representative for Ascensus Trust Company (Ascensus), a qualified institution, has certified to the completeness and accuracy of all investments and notes receivable from participants reported in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, and the supplemental schedule, Form 5500, Schedule H, Part IV, Line 4i - Schedule of Assets Held at End of Year as of December 31, 2024, and the related investment transactions and investment income and interest income on notes receivable from participants reported in the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.

At the request of the Plan Administrator, the Plan's independent auditors did not perform auditing procedures with respect to certified investment information, except for comparing such certified investment information included in the accompanying financial statements and supplemental schedule, Form 5500, Schedule H, Part IV, Line 4i - Schedule of Assets Held at End of Year as of December 31, 2024.

### 4. FAIR VALUE MEASUREMENT

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants as of the measurement date. *Fair Value Measurement* establishes a hierarchy of the valuation techniques based upon whether the inputs to those valuation techniques reflect assumptions other market participants would use based upon market data obtained from independent sources (also referred to as observable inputs).

The fair value hierarchy is as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value:

*Mutual funds and money market funds:* Valued at the daily closing price as reported by the fund. Mutual funds and the money market funds are held by the Plan are open-ended funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. These funds held by the Plan are deemed to be actively traded.

There has been no change in the methodology used at December 31, 2024 and 2023.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 5. PLAN TERMINATION

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become fully vested and all accrued benefits shall be paid to participants in accordance with the provisions of the Plan.

### 6. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Section 3(14) of ERISA defines a party-in-interest to include, among others, fiduciaries or employees of the Plan, any person who provides services to the Plan or an employer whose employees are covered by the Plan. The Plan has a service agreement with the Vanguard Group (Vanguard), who has retained Ascensus as a subcontractor to provide recordkeeping services for the Plan. Both Vanguard and Ascensus are considered parties-in-interest. Accordingly, transactions with investment funds managed and held by the Plan's qualified institution, expenses paid to the Plan's third-party administrator out of plan assets, and notes receivable from participants are considered party-in-interest transactions. During plan year 2024, there were \$60,945 of administrative expenses paid to the qualified institution and third-party administrator by the Plan.

### 7. TAX STATUS

The Plan Sponsor has obtained an opinion letter dated June 30, 2020, in which the IRS stated that the restated prototype plan document was in compliance with applicable requirements of the IRC. The Plan Administrator timely adopted the restated prototype plan. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is currently being operated in accordance with the IRC.

U.S. GAAP requires the Plan Administrator to evaluate tax positions taken by the Plan and recognizes a tax liability (or asset) if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.

### 8. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant balances, and the amounts reported in the accompanying statements of net assets available for benefits.

### **9. DELINQUENT PARTICIPANT CONTRIBUTIONS**

During 2022 and 2021, the Plan Sponsor failed to segregate and remit in a timely manner certain participant contributions and loan repayments (salary reduction amounts) from its assets within the required time period as specified by the United States Department of Labor Reg. 2520.3012. Failure to segregate and remit contributions and loan repayments within the specified time period is a prohibited transaction according to the provisions of ERISA and the IRC. The Plan Sponsor remitted the lost earnings for the delinquent participant contributions and loan repayments for 2022 and 2021 in January 2024.

## Independent Auditor's Report

To the Plan Administrator and Trustees of  
DS Graphics Employee Savings 401(k) Plan:

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of DS Graphics Employee Savings 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). ### 1. DESCRIPTION OF THE PLAN

The following description of DS Graphics Employee Savings 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

#### a. General

The Plan is a defined contribution 401(k) plan covering all eligible employees of DS Graphics, Inc. (the Plan Sponsor) (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan Administrator and Trustees are responsible for the oversight of the Plan. The Plan Administrator and Trustees determine the appropriateness of the Plan's investment offerings, monitor investment performance, and report to the Plan Sponsor's Board of Directors.

#### b. Eligibility

Upon completion of three months of service with the Plan Sponsor, employees are eligible to participate in the Plan provided they have attained the age of twenty-one. Employees are also eligible to receive the Plan Sponsor's discretionary matching contributions, discretionary profit-sharing contributions, and discretionary qualified non-elective contributions upon completing three months of service and attaining the age of twenty-one. Additionally, to be eligible for the discretionary profit-sharing contributions, employees must also have worked 500 hours during the plan year. The Plan excludes employees covered by a collective bargaining agreement and non-resident aliens.

#### c. Contributions

Each year, participants may contribute up to 100% of pre-tax annual compensation, as defined in the Plan, up to the maximum allowed by the Internal Revenue Service (IRS). The Plan allows for catch-up contributions for participants who have attained the age of fifty by the end of the plan year. The Plan allows for participants to make post-tax (Roth) contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans (rollover contributions). Participants direct the investment of their contributions into various investment options offered by the Plan.

Employees of the Plan Sponsor, who do not affirmatively elect otherwise, are automatically enrolled into the Plan once the eligibility requirements have been met. Employees who are automatically enrolled default to deferral contributions in the amount of 3% or elects otherwise.

The Plan Sponsor makes discretionary matching contributions equal to 25% of the participant's employee contributions that does not exceed 6% of a participant's eligible compensation. The Plan Sponsor's matching contributions, profit-sharing contributions, and qualified non-elective contributions are discretionary and are determined annually by the Plan Sponsor. Discretionary profit-sharing contributions and qualified non-elective contributions are allocated based on a formula determined by the Plan Sponsor's Board of Directors. Discretionary matching contributions totaled \$156,711 for the year ended December 31, 2024. The Plan Sponsor did not contribute any discretionary profit-sharing contributions or qualified non-elective contributions for the year ended December 31, 2024.

#### d. Participant Accounts

Each participant's account is credited with the participant's contributions, allocations of the Plan Sponsor's contributions and plan earnings or losses, and charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant's earnings or losses, account balances, or specific participant transactions, as defined in the plan document. The benefit to which a participant is entitled to is the benefit that can be provided from the participant's vested account.

#### e. Vesting

Participants are vested immediately in their contributions, the Plan Sponsor's discretionary qualified non-elective contributions, plus actual earnings or losses thereon. Participants vest in the Plan Sponsor's discretionary matching contributions and discretionary profit-sharing contributions based on a six-year graded schedule as follows:

<u>Years of Service</u>	<u>Percentage</u>
1 year or less	0%
2 years but less than 3	20%
3 years but less than 4	40%
4 years but less than 5	60%
5 years but less than 6	80%
6 years or more	100%

Participants become fully vested upon attainment of normal retirement age, death or disability.

#### f. Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or one-half of their vested account balance. The loans are secured by the balance in the participant's account. Participants may have up to two loans outstanding at any time. Loan terms range from one to five years, unless for the purchase of a primary residence, in which case the term may be up to thirty years. Interest is due on the outstanding principal balance at a rate equal to the prime loan rate plus 2%. Principal and interest are paid ratably through payroll deductions.

#### g. Payment of Benefits

The Plan provides for a normal retirement benefit to be paid to participants who have reached the age of 65, with no option for early retirement. Upon termination of services, a participant may elect to receive a lump-sum, installment, or partial payments equal to the value of the participant's vested account balance or leave their balance in the Plan if the balance is over \$5,000. The Plan requires balances up to \$1,000 to be paid out to participants upon termination, and requires balances from \$1,000 to \$5,000 be rolled over to an individual retirement account (IRA). Effective January 1, 2024, the Plan adopted the SECURE Act 2.0 provision by increasing involuntary force-out distributions to \$7,000.

#### g. Payment of Benefits (Continued)

The Plan allows in-service withdrawals upon attainment of age 59½. A participant may also request a withdrawal upon demonstration to the Plan Administrator that they are suffering a "hardship". Hardship is defined in applicable regulations promulgated or to be promulgated pursuant to the applicable section of the Internal Revenue Code (IRC) or standards established by the Secretary of the Treasury or their delegate.

#### h. Forfeitures

Forfeitures represent non-vested Plan Sponsor discretionary contributions forfeited by participants who terminate their employment or who withdraw from the Plan. Forfeitures are retained by the Plan and are used to reduce future Plan Sponsor contributions and pay plan expenses. The Plan had \$3,849 of unallocated forfeitures as of December 31, 2024. The Plan had no unallocated forfeitures as of December 31, 2023. The Plan Sponsor used \$3,477 of forfeitures to pay plan expenses during 2024.

### 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### Basis of Presentation

The Plan prepares its financial statements in accordance with generally accepted accounting principles (U.S. GAAP) established by the Financial Accounting Standards Board (FASB). References to U.S. GAAP in these notes are to the FASB Accounting Standards Codification (ASC).

#### Use of Estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for disclosure of fair value measurement.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation of investments includes gains and losses on investments bought and sold, as well as held during the year.

#### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded on an accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. No allowances for credit losses have been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan payments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded. As of December 31, 2024, there were \$59,366 of defaulted loans that have been deemed distributed and are included in benefits paid to participants in the accompanying statement of changes in net assets available for benefits.

#### **Contributions**

Contributions from plan participants and the discretionary matching contributions from the Plan Sponsor are recorded in the year which the participant contributions are withheld from compensation. The Plan Sponsor's discretionary profit-sharing contributions and discretionary qualified non-elective contributions are recorded when such contributions are authorized by the Plan Sponsor's Board of Directors.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Administrative Expenses**

Certain expenses of maintaining the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements. Fees related to recordkeeping, the administration of participant loans, and processing of distributions are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation of investments.

#### **Subsequent Events**

Subsequent events have been evaluated through October 7, 2025, which is the date the financial statements were available to be issued. There were no events that met the criteria for recognition or disclosure in the financial statements.

### **3. INFORMATION PREPARED AND CERTIFIED BY THE PLAN'S QUALIFIED INSTITUTION**

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Ascensus, LLC, as an authorized representative for Ascensus Trust Company (Ascensus), a qualified institution, has certified to the completeness and accuracy of all investments and notes receivable from participants reported in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, and the supplemental schedule, Form 5500, Schedule H, Part IV, Line 4i - Schedule of Assets Held at End of Year as of December 31, 2024, and the related investment transactions and investment income and interest income on notes receivable from participants reported in the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.

At the request of the Plan Administrator, the Plan's independent auditors did not perform auditing procedures with respect to certified investment information, except for comparing such certified investment information included in the accompanying financial statements and supplemental schedule, Form 5500, Schedule H, Part IV, Line 4i - Schedule of Assets Held at End of Year as of December 31, 2024.

### **4. FAIR VALUE MEASUREMENT**

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants as of the measurement date. *Fair Value Measurement* establishes a hierarchy of the valuation techniques based upon whether the inputs to those valuation techniques reflect assumptions other market participants would use based upon market data obtained from independent sources (also referred to as observable inputs).

The fair value hierarchy is as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value:

*Mutual funds and money market funds:* Valued at the daily closing price as reported by the fund. Mutual funds and the money market funds are held by the Plan are open-ended funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. These funds held by the Plan are deemed to be actively traded.

There has been no change in the methodology used at December 31, 2024 and 2023.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 5. PLAN TERMINATION

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become fully vested and all accrued benefits shall be paid to participants in accordance with the provisions of the Plan.

### 6. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Section 3(14) of ERISA defines a party-in-interest to include, among others, fiduciaries or employees of the Plan, any person who provides services to the Plan or an employer whose employees are covered by the Plan. The Plan has a service agreement with the Vanguard Group (Vanguard), who has retained Ascensus as a subcontractor to provide recordkeeping services for the Plan. Both Vanguard and Ascensus are considered parties-in-interest. Accordingly, transactions with investment funds managed and held by the Plan's qualified institution, expenses paid to the Plan's third-party administrator out of plan assets, and notes receivable from participants are considered party-in-interest transactions. During plan year 2024, there were \$60,945 of administrative expenses paid to the qualified institution and third-party administrator by the Plan.

### 7. TAX STATUS

The Plan Sponsor has obtained an opinion letter dated June 30, 2020, in which the IRS stated that the restated prototype plan document was in compliance with applicable requirements of the IRC. The Plan Administrator timely adopted the restated prototype plan. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is currently being operated in accordance with the IRC.

U.S. GAAP requires the Plan Administrator to evaluate tax positions taken by the Plan and recognizes a tax liability (or asset) if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.

### 8. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant balances, and the amounts reported in the accompanying statements of net assets available for benefits.

### **9. DELINQUENT PARTICIPANT CONTRIBUTIONS**

During 2022 and 2021, the Plan Sponsor failed to segregate and remit in a timely manner certain participant contributions and loan repayments (salary reduction amounts) from its assets within the required time period as specified by the United States Department of Labor Reg. 2520.3012. Failure to segregate and remit contributions and loan repayments within the specified time period is a prohibited transaction according to the provisions of ERISA and the IRC. The Plan Sponsor remitted the lost earnings for the delinquent participant contributions and loan repayments for 2022 and 2021 in January 2024.
