***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of The Martz Group 401(K) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of The Martz Group 401(K) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

## ***Opinion***

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the accrual basis of accounting in the format prescribed by the DOL's Rules and Regulations for Reporting under ERISA.

## ***Basis for Opinion***

1. DESCRIPTION OF PLAN

The following description of The Martz Group 401(K) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

A. General:

The Plan is a safe-harbor defined contribution plan covering substantially all nonunion employees of Frank Martz Coach Company; Gold Line, Inc.; National Coach Works of Virginia, Inc.; First Class Coach Company, Inc.; and Further Transportation Management, Inc. (the "Companies") who have attained age twenty-one with no service requirement for elective deferrals, safe harbor matching contribution and nonelective contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). Effective March 2, 2023, the Plan was amended to include Further Transportation Management, Inc. as an employer.

B. Contributions:

Each year, participants in the Plan may contribute up to 100% of pretax compensation (W-2 wages including elective deferrals), as defined by the Plan, subject to certain statutory limitations. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Plan is an Eligible Automatic Contribution Arrangement (EACA)/Qualified Automatic Contribution Arrangement (QACA) and as such, new hires are automatically enrolled in the Plan and a fixed 3% is withheld from their compensation unless they make a contrary election. Catch-up deferrals are permitted. The Companies have the option to make discretionary profit-sharing contributions to the Plan at the discretion of the Boards of Directors. In 2024, the Companies tiered safe-harbor matching contribution is 100% of the employee's deferral up to 3% and an additional 50% of the employee's deferral from 4%-6%. Participants direct the investments of their contributions into various investment options offered by the Plan. Contributions are remitted to the Plan on a weekly basis. Contributions are subject to certain IRS limitations.

C. Participants Accounts:

Each participant's account balance is maintained separately and is credited with the participant's contribution, including rollovers, and allocations of the Companies' safe-harbor and discretionary matching contributions and Plan earnings and charged with an allocation of plan losses and administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investments in their own accounts.

D. Vesting:

Participants are always one hundred percent vested in their voluntary contributions and rollovers plus actual earnings thereon. Employees vest in the Companies' contribution portion of their accounts and earnings in accordance with the following table:

2 Years	20%
3 Years	40%
4 Years	60%
5 Years	80%
6 Years or More	100%

E. Notes Receivable from Participants:

Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate, determined quarterly, is set at 1 percent above the prime rate, which ranged from 4.25% to 10.50% in 2024. Principal and interest are paid ratably through payroll deductions. Participants may only have one loan outstanding at a time.

F. Payment of Benefits:

On termination of service for any reason, a participant will receive the vested interest in his or her account as a single lump sum distribution. Mandatory distributions apply to account balances up to \$5,000 and account balances between \$1,000 and \$5,000 are subject to automatic rollover. Accounts below \$1,000 are distributed in cash while accounts over \$5,000 require a participant's consent for distribution. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan Document.

G. Forfeited Accounts:

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$0. The forfeiture account increased \$26,570 for current year forfeitures and increased \$87 for current year activity. These accounts can be used to reduce employer discretionary contributions and pay plan expenses which amounted to \$19,554 and \$7,103, respectively, in 2024.

H. Plan Amendments:

Effective April 2020, the Plan adopted the suspension of required minimum distribution provision of the CARES Act that was signed into law on March 27, 2020. As a result of the act, required minimum distributions were completely waived for 2020. The Plan has until December 31, 2026 to formally amend the Plan.

Effective April 2020, the Plan adopted the distribution provision of the CARES Act. A CARES Act distribution allows the Plan's participants to take a COVID-19 related distribution up to \$100,000 from the Plan beginning on or after January 1, 2020 and before December 31, 2020. The Plan has until December 31, 2026 to formally amend the Plan.

Effective April 2020, the Plan has adopted the temporary loan repayment deferral provision of the CARES Act. The deferral provision adopted by the Plan allows qualified Plan participants who have Plan loan repayments to defer such repayments for twelve months. The Plan has until December 31, 2026 to formally amend the Plan.

Effective April 2020, the Plan adopted the coronavirus related loans to a qualified individual up to \$100,000 that must be taken by September 22, 2020. The Plan has until December 31, 2026 to formally amend the Plan.

Effective January 2020, the Plan has adopted certain requirements of the Setting Every Community Up for Retirement Enhancement (SECURE) Act which changed required minimum distribution age from 70.5 to 72, requires non-spouse beneficiaries to withdraw funds within ten years, allows penalty free withdraws for new parents and other provisions. The Plan has until December 31, 2026 to formally amend the Plan.

Effective January 2023, the SECURE 2.0 Act made a change to the age an individual must begin taking required minimum distributions (RMD). The age to begin taking an RMD increased to 73 for individuals who turn 72 on or after January 1, 2023. The RMD age increases to 75 in 2033. The Plan has until December 31, 2026 to formally amend the Plan.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

### A. Basis of Accounting:

The financial statements of the Plan are prepared using the accrual basis of accounting and are presented in the format prescribed by the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 ("Department of Labor"). The prescribed format differs from accounting principles generally accepted in the United States of America in that they do not require interest and dividends earned within mutual funds, pooled separate accounts, or bank common/collective trusts, etc., to be reported separately from the change in fair value (e.g. net appreciation/depreciation).

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measurement for the portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

B. Use of Estimates:

The preparation of financial statements requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

C. Investment Valuation and Income Recognition:

Investments are reported at fair value (except for the fully benefit - responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisors and trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Contributions are recorded in their period earned. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the plan's gains and losses on investments bought and sold as well as held during the year and may include interest and dividends earned in pooled separate accounts as allowed by the Department of Labor.

D. Notes Receivable from Participants:

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024. If a participant ceases employment, all loans become due and payable at the severance date. If not repaid or directly rolled over to a new employer's Plan, the Plan Administrator will deem the participant loan to be in default and the participant loan balance will be reduced and a benefit payment will be recorded.

E. Payment of Benefits:

Benefits are recorded when paid.

F. Administrative Expenses:

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of benefit payments and notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

G. Date of Management Review:

Subsequent events were evaluated through October 7, 2025 is the date the financial statements were available to be issued.

3. INFORMATION CERTIFIED TO BY THE PLAN'S CUSTODIAN / TRUSTEE

The Plan Administrator has elected the method of compliance in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the DOL Rules and Regulations for Reporting and Disclosure under ERISA. 4. INVESTMENTS AND FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1:

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Input to the valuation methodology include

- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3:

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Pooled Separate Accounts:*

Valued at the net asset value (NAV) of units of pooled separate accounts at Principal Trust Company, the Plan trustee. The NAV, as provided by the Principal Trust Company, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable the fund will sell the investments for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily.

*Registered Investment Companies:*

Valued at the daily closing price as reported by the fund. Registered investment companies held by the Plan are open-ended mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The registered investment companies held by the Plan are deemed to be actively traded.

5. INVESTMENT CONTRACT WITH INSURANCE COMPANY

Principal Trust Company on behalf of the Plan entered into a benefit-responsive investment contract with Principal Life Insurance Company reported as the Principal Fixed Income Guaranteed Option. Principal Life Insurance Company maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charges for participant withdrawals and administrative expenses. The contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

The guaranteed investment contract meets the fully benefit-responsive criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by the participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Prudential Retirement Insurance and Annuity Company, represents contributions made under the contract, plus earnings, less participant withdraws, and administrative expenses. Participants may ordinarily direct the withdrawal of transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than 1.75 percent. Such interest rates are reviewed on a semi-annual basis for resetting. At December 31, 2024, the interest rate was 2.55%.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdraw from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator believes that any events that would limit the Plan's ability to transact at contract value with participants are not probable.

The investment contract has no stated maturity.

6. PARTY-IN-INTEREST

The Plan investments included shares of pooled separate accounts and registered investment companies managed by Principal Trust Company, the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest. Fees incurred by the Plan for investment management services from Principal Trust Company are included in net depreciation in fair value of the investment as they are paid through revenue sharing, rather than a direct payment. The trustee charged loan and distribution administration fees to participants of \$4,936 in 2024. In addition, the Plan paid the trustee \$41,341 in recordkeeping and administration fees. The Plan also paid the audit fee.

7. PLAN TERMINATION

Although it has not expressed any intent to do so, the Companies have the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, or partial termination (as defined), participants will become 100% vested in their employer contributions.

8. TAX STATUS

The Company adopted a prototype non-standardized profit-sharing plan with CODA. The IRS has determined and informed the volume submitter by a letter dated June 30, 2020, that the restated prototype plan document adopted by the Plan qualified under Internal Revenue Code (IRC) section 401. The Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified and the related trust is tax-exempt.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

9. RISKS AND UNCERTAINTIES

The Plan invests in various investments securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
