We have performed audits of the financial statements of PS Operating Company 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. ### 1. Plan Description

---

The following brief description of the PS Operating Company 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### ***General***

The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was established to provide retirement benefits for the employees of PS Operating Company LLC dba QC Supply (the Company).

Employees are eligible to make pre-tax and designated after-tax Roth salary reduction deferral after attaining age 21 and completing 60 days of service. Effective January 1, 2024, participants are eligible to receive safe harbor matching contributions after completing 60 days of service. Prior to January 1, 2024, participants who completed at least six months of service were eligible to receive safe harbor matching contributions. Participants who complete at least six months of service and are employed on the last day of the Plan year are eligible to receive discretionary nonelective contributions. Eligible employees may become participants on the first day of each calendar month following the date on which eligibility requirements are satisfied.

#### ***Contributions***

Participants may contribute up to 100% of annual eligible compensation, subject to the maximum dollar amounts allowable by law. Participants may also contribute amounts representing distributions from other qualified plans. Participants are automatically enrolled in the Plan with an initial salary deferral of 5%. On January 1 of each year, the employee's deferral rate will be increased by 1% until it reaches a total of 10% of their eligible compensation (15% effective January 1, 2025). At any time, a participant can elect not to contribute or may increase or decrease the deferral rate to any rate allowed under Plan provisions.

The Company will make safe harbor matching contributions equal to 100% of the first 5% of the participant's elective deferrals. The Company may also make discretionary nonelective contributions.

All participants who are eligible to make deferral contributions and who are projected to attain age 50 before the close of the calendar year shall be eligible to make catch-up contributions. Contributions are subject to certain limitations.

### *Participant Accounts*

Each participant's account is credited with the participant's contribution and an allocation of a) Company contributions, b) Plan earnings or losses, and c) Plan administrative expenses. The Company's safe harbor matching contributions are allocated to participants based upon each participant's elected salary deferral. Discretionary nonelective contributions are allocated based on each participant's eligible compensation. Plan earnings or losses are allocated on the basis of actual results of the investments selected by each participant. Plan administrative expenses are allocated based on each participant's account balance or evenly between all participants, depending on the nature of the expense. Investments are maintained in individual member accounts managed by Principal Trust Company (Principal).

### *Vesting*

Participants are vested immediately in their contributions and safe harbor matching contributions. Participants are also vested immediately in certain discretionary matching contributions made during the periods prior to July 1, 2020 and subsequent to August 1, 2020, plus actual earnings thereon.

The Company's discretionary nonelective contributions as well as certain discretionary matching contributions made during the period July 1, 2020 through August 1, 2020 are both based on years of continuous service. A participant is 20% vested after two years of credited service and vesting increases 20% per year until a participant is 100% vested after six years of credited service.

### *Notes Receivable from Participants*

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates. The terms of the notes receivable are limited to five years, unless the note is for the purchase of a primary residence, in which case a longer term may be permitted. Principal and interest are paid through payroll deductions.

### *Payment of Benefits*

Upon termination, retirement, disability, or death the participant or beneficiary may elect to receive lump sum, installment payments, and partial withdrawals equal to the value of the vested funds allocated to the participant's account. The Plan requires that distribution payments between \$1,000 and \$7,000 (\$5,000 prior to January 1, 2024) be directly rolled over to an individual retirement account designated by the plan administrator in the event the participant does not elect otherwise. Distributions under \$1,000 will be paid out to the participant in the event the participant does not elect a payout option. Participants may receive hardship and in-service distributions, as permitted in the Plan document. Benefits are recorded when paid.

### *Forfeitures*

Upon a participant's termination of employment before normal retirement or death, the portion of their Company discretionary contributions not then vested shall be forfeited. The forfeited portion of any participant's account may be used to reduce Company contributions or to pay Plan expenses. Forfeitures may also be re-allocated to remaining participants. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$141 and \$21,077, respectively. During the years ended December 31, 2024 and 2023, Company contributions and Plan expenses were reduced by a total of \$35,542 and \$19,799, respectively.

## 2. Summary of Significant Accounting Policies

---

A summary of the significant accounting policies consistently applied in the preparation of the accompanying financial statements is set forth below.

### *Basis of Presentation*

The accompanying financial statements have been prepared on the accrual basis and in conformity with accounting principles generally accepted in the United States of America.

### *Presentation of Participant-Directed Funds*

The Plan's presentation of participant-directed investments is in accordance with the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 962, *Plan Accounting-Defined Contribution Pension Plans*.

### *Use of Estimates*

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

### *Investment Valuation and Income Recognition*

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Delinquent notes are reclassified as distributions based upon the terms of the Plan document.

### ***Other***

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. All fees and expenses of the record keeper and custodians which are incurred in connection with the Plan are paid by the Plan and recorded in administrative expenses. Other certain expenses specifically incurred by or attributable to individual participants are paid from the applicable participants' accounts. Investment-related expenses are included in net appreciation in fair value of investments.

### ***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### ***Subsequent Events***

Subsequent events are events or transactions that occur after the statement of net assets available for benefits date but before the financial statements are available to be issued and may require potential recognition or disclosure in the financial statements. Management has considered such events or transactions through October 8, 2025. See the "Contributions" section of Note 1 for a description of a subsequent event.

## **3. Information Certified by Principal**

---

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by Principal except for comparing such information certified by the custodian to information included in the Plan's financial statements and supplementary information.

#### 4. Fair Value Measurement

---

FASB ASC 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their net asset value (NAV) and to transact at that price. Funds held by the Plan are deemed to be actively traded.

*Common Collective Trust:* Valued at the NAV based on the fair value of its underlying investments. FASB ASC 820, *Fair Value Measurement and Disclosures*, allows NAV per share as a practical expedient to estimate the fair value as long as certain requirements are met. It is the Plan's assessment that this fund meets those requirements.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### 5. Tax Status

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authority. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

### 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested. Distributions to participants of the account balances would be made as soon as practicable after the termination date.
