Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

I have performed audits of the financial statements of Save on SP 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), my audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

Opinion

In my opinion, based on my audits and on the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section—

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

I conducted my audits in accordance with auditing standards generally accepted in the United States of America (GAAS). My responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of my report. I am required to be independent of the Plan and to meet my other ethical responsibilities in accordance with the relevant ethical requirements relating to my audits. I believe that the audit evidence I have obtained is sufficient and appropriate to provide a basis for my ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of my report, my objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes my opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

I am required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that I identified during the audit.

Notes to Financial Statements December 31, 2024 and 2023

1. Description of the Plan

The following description of the Save on SP 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General — The Plan is a defined contribution plan sponsored by Save on SP LLC (the “Company” or “Employer”) and covers substantially all employees of the Company and adopting employers who have completed six months of eligible service, as defined and are age 21 or older. Upon reaching eligibility, participants are allowed to enter the Plan on January 1st, April 1st, July 1st, and October 1st.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). John Hancock Life Insurance Company of New York (“John Hancock”) is the Plan's custodian and recordkeeper.

Contributions — Participants may contribute up to the maximum amount allowed by law. The Plan permits both pre-tax and Roth (post-tax) deferrals. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

The Plan is a safe harbor 401(k) plan, as defined in the Plan documents. The Employer will make a safe harbor contribution for the Plan Year to the account of each eligible participant in an amount equal to 3% of each participant's compensation. Employer safe harbor contributions amounted to \$507,007 for the year ended December 31, 2024 of which \$432,966 was received by the Plan in 2024 and allocated to eligible participants' accounts, and \$74,041 was received by the Plan and allocated to eligible participants' accounts on April 11, 2025. Safe harbor contributions are 100% vested.

Effective January 1, 2025, the Plan was amended to add a discretionary Employer matching contribution. For 2025, the Company will make a matching contribution equal to 200% of a participant's elective deferrals up to 4% of the participant's compensation. The Employer matching contributions will vest ratably over three years. The Plan also provides for Employer Nonelective Contributions (Profit Sharing) at the discretion of the Employer. A participant must complete six months of credited service, as defined to share in allocations of Employer Nonelective Contributions. Employer Nonelective Contributions, if any, are allocated at the Employer's discretion among employee groups, as defined. The amount allocated to each employee group shall then be allocated among the eligible participants within each respective employee group in the ratio that each eligible participant's compensation for the Plan year bears to the total compensation paid to all eligible participants within the respective group. Employer Nonelective Contributions amounted to \$820,485 for the year ended December 31, 2024. This amount was received by the Plan and allocated to eligible participants' accounts on April 11, 2025, of which \$803,792 was funded in cash and \$16,693 was funded from forfeited accounts.

All contributions are subject to certain Internal Revenue Code (“IRC”) limitations.

Participants direct the investment of their contribution into various investment options offered by the Plan. The various American Funds target-date funds are the default investments used when a participant has not made an investment election for all or any portion of their accounts.

Participant Accounts — Each participant's account is credited with the participant's contributions, an allocation of Employer contributions and Plan earnings, and charged with withdrawals and administrative expenses and Plan losses. Allocations are based on participant earnings, or account balances as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting — Participants are 100% vested in their elective deferral contributions, rollover contributions, Employer safe harbor contributions, and any earnings thereon. Discretionary Employer Nonelective Contributions and any earnings thereon vest ratably over a three-year period, as defined.

Notes Receivable from Participants — Participants may borrow from their fund accounts a minimum of \$1,000 and a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms generally range from one to five years, or fifteen years for the purchase of a participant's primary residence. The maximum number of Plan loans outstanding at any one time is one. Interest is fixed at the prime rate plus 1% when the loan is issued.

Payment of Benefits and Withdrawals – Upon termination of service due to retirement, early retirement, death, or disability, a participant may elect to receive the value of the participant's vested interest in his or her account, in the form of a lump-sum, as defined by the Plan. Participant balances less than \$5,000 (\$7,000 effective January 1, 2024) are required to be distributed in accordance with plan provisions. Subject to certain conditions, other payments may be permitted for in-service distributions including financial hardship, as defined by the IRC.

Forfeited Accounts — During 2024, new forfeited non-vested accounts totaled \$59,412. As of December 31, 2024 and 2023, forfeited non-vested accounts amounted to \$16,693 and \$54,064, respectively. These accounts will be used to pay expenses of the Plan or to reduce Employer contributions, as defined. During 2024, forfeitures of \$51,396 were used to pay administrative fees and \$54,000 were used to reduce employer contributions.

2. Summary of Significant Accounting Policies

Basis of Accounting — The financial statements of the Plan are prepared using the accrual basis of accounting under accounting principles accepted in the United States of America. Certain reclassifications were made to the prior year net assets available for benefits to conform with the current year presentation.

Investment Valuation and Income Recognition — Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants — Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits – Benefit are recorded when paid.

Administrative Expenses – Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant’s account and are included in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments.

Use of Estimates — The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Market Risk Factors — The Plan invests in various investment securities. Investment securities are exposed to risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statement of net assets available for benefits.

Subsequent Events — Plan management has evaluated subsequent events through October 1, 2025, the date the financial statements were available to be issued.

3. Investment Valuation and Income Recognition

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described as follows:

- Level 1 – Unadjusted quoted prices in active markets for identical, unrestricted assets or liabilities that are accessible at the measurement date.
- Level 2 – Quoted prices for similar assets or liabilities in active markets or quoted prices for identical or similar assets or liabilities in markets that are not active. This level also includes inputs other than quoted prices that are observable, either directly or indirectly, for substantially the full term through corroboration with observable, independent market data. This includes investments valued at quoted prices adjusted for legal or contractual restrictions specific to the security.
- Level 3 – Pricing inputs are unobservable for the asset or liability. That is, inputs that reflect the reporting entity’s own assumptions about the assumptions that market participants would use in pricing the asset or liability.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Following is a description of the valuation methodologies used for investments measured at fair value as of December 31, 2024 and 2023:

Pooled Separate Accounts – The Plan’s investments in pooled separate accounts (“PSAs”) are stated at fair value as determined by John Hancock. PSAs are valued at Net Asset Value (“NAV”) which is based on the net assets of the underlying the sub-accounts and then dividing the NAV by the number of outstanding units. There are currently no redemption restrictions or unfunded commitments on these investments.

Cash – The Plan’s cash consists of unallocated deposits at John Hancock, valued at face amount, which approximates fair value.

4. Related-Party and Party-In-Interest Transactions

Plan investments are units in sub-accounts managed by John Hancock. John Hancock is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Notes receivable from participants also qualify as party-in-interest transactions.

Certain employees and/or officers of the Company or its affiliates perform administrative services to the Plan at no cost to the Plan.

5. Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

6. Tax Status

The Plan adopted a pre-approved plan document sponsored by Actuarial Consulting Services, Inc. Actuarial Consulting Services, Inc. (“ACSI”) received an opinion letter from the Internal Revenue Service, dated June 30, 2020, which states that the prototype document satisfies the applicable provisions of the Internal Revenue Code (“IRC”). The Plan has not received a determination letter specific to the Plan itself; however, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan’s financial statements.

As of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Certified Investment Information

The Company, acting in its capacity as the Plan administrator, has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. The following is a summary of the unaudited information regarding the Plan as of December 31, 2024 and 2023, and for the years ended December 31, 2024 and 2023, included in the Plan’s financial statements and supplemental schedule, that was prepared by or derived from information prepared by John Hancock Life Insurance Company of New York and furnished to the Company. The Company has obtained certifications from John Hancock Life Insurance Company of New York as of December 31, 2024 and 2023, and for the year ended December 31, 2024, that such information is complete and accurate.
