Scope And Nature Of The ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of FTL Capital, LLC Retirement Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities For The Audit Of The Financial Statements section:

Basis For Opinion

NOTES TO FINANCIAL STATEMENTS

December 31, 2024 And 2023

1. Description Of The Plan

The following brief description of FTL Capital, LLC Retirement Trust (the Plan) is provided for general information purposes only. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General

The Plan, which has been adopted by FTL Capital, LLC, d/b/a Lewis & Clark Holdings, LLC (the Company), is a defined contribution profit sharing plan, which includes a 401(k) provision. Related participating employers which are part of a controlled group include FTL Capital Partners, LLC d/b/a FTL Finance, IT US Acquisition Company, LLC d/b/a SureCam and Lewis & Clark Equity Partners, LLC. The Plan covers all employees immediately upon hire. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan's recordkeeper and Trustee is Ascensus, LLC, through a partnership with The Vanguard Group, Inc. and Ascensus Trust Company.

Contributions

Participants may contribute a percentage of their annual compensation as defined in the Plan Document, not to exceed the maximum allowable under the Internal Revenue Service (the IRS). Additionally, participants age 50 and over may make "catch-up contributions." Participants may also make rollover contributions to the Plan, provided such rollover amounts meet the criteria for transfer as established under the Internal Revenue Code (IRC or the Code).

The Plan includes an ADP Safe Harbor matching provision whereby the Company matches salary deferral contributions at a rate of 100% of the first 4% of eligible compensation.

The Company may also make a discretionary profit sharing contribution. The participant does not have to make deferral contributions to receive the contribution however there is a 1 year service requirement and the participant must be an employee of the Company on the last day of the Plan year. There were no discretionary profit sharing contributions made during 2024 or 2023.

Notes To Financial Statements (*Continued*)

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's contributions and an allocation of Plan earnings. The allocation of earnings is determined by the earnings of the participant's investment selection based on each participant's account balance, as defined in the Plan Document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions, employer profit sharing contributions and the ADP Safe Harbor match plus actual earnings thereon.

Notes Receivable From Participants

A participant may borrow from their account subject to certain limitations. The minimum amount of any note is \$1,000. In no event can the participant borrow more than \$50,000 or 50% of the participant's vested balance. Note terms are for a period up to 5 years or 10 years for the purchase of a principal residence and bear interest based on prevailing market rates. A participant may have only one note outstanding at any time. The notes are repaid through payroll withholdings including principal and interest.

Investment Options

Upon enrollment in the Plan, a participant may direct contributions into a number of investment options offered by the Plan.

Payment Of Benefits

Upon termination of employment, death, total disability, or attainment of normal retirement age, a participant (or beneficiary) may elect distribution of their account as a single lump sum.

In-Service Withdrawals

A participant may also elect to receive an in-service distribution upon attaining age 59 ½ or reach normal retirement age. The Plan does not allow for hardship withdrawals.

Administrative Expenses

Salaries and related benefits of employees who administer the Plan are paid by the Company. Other administrative expenses, primarily transaction fees and account fees, are paid by the Plan. Expenses incurred on the purchase or sale of investments are added to the cost or deducted from the proceeds of the respective investment.

2. Summary Of Significant Accounting Policies

Basis Of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

Estimates And Assumptions

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of additions to and deductions from net assets during the reporting period. Actual results could differ from those estimates.

Investment Valuation And Investment Income Recognition

The Plan's investments are recorded at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. The net change in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at unpaid principal balance plus accrued but unpaid interest. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan Document.

Payment Of Benefits

Benefits are recorded when paid.

Contributions Receivable And Credit Loss Policy

Amounts due for contributions are stated at the amount that management expects to collect from outstanding balances less an allowance for expected credit losses. The expected credit losses amount reflects management's best estimate of amounts that will not be collected. This assessment considers historical experience, current conditions and, when appropriate, reasonable and supportable forecasts.

The Company has concluded that no allowance for current expected credit losses was necessary at December 31, 2024 or 2023.

3. Certified Investment Information

The following is a summary of the Plan's asset information as of December 31, 2024 and 2023, and for the years then ended, included throughout the Plan's financial statements and supplemental schedule, that was prepared by or derived from information certified by Ascensus Trust Company (the Trustee), and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from the Trustee that the information provided to the Plan Administrator related to the following information is complete and accurate.

4. Fair Value Measurements

The Plan utilizes an established framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value:

Money Market Fund And Mutual Funds

Valued at the daily closing price as reported by the fund. The money market fund and mutual funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The funds held by the Plan are deemed to be actively traded.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. 6. Income Tax Status

The Plan uses a non-standardized pre-approved plan. The pre-approved plan sponsor has received an opinion letter from the IRS dated June 30, 2020, which states that the pre-approved document satisfies the applicable provisions of the Code. The Plan itself has not received a determination letter from the IRS. However, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code, which provides that, if certain conditions are met, an employer may rely on a favorable opinion letter issued to a pre-approved plan sponsor as if the employer had received a favorable determination letter. Therefore, no provision for income tax has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Plan Termination

Although it has not expressed intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

8. Transactions With Parties In Interest

The Plan pays fees to the recordkeeper for administrative services including loan and distribution transactions. In addition, certain participants have outstanding loans with the Plan. These transactions qualify as party in interest transactions allowable under ERISA.

9. Subsequent Events

Effective January 1, 2025, FTL Capital Partners, LLC d/b/a FTL Finance and IT US Acquisition Company, LLC d/b/a SureCam ceased participation in the Plan, and separate individual plans were established for each entity. Beginning on the effective date, all subsequent contributions were directed to the respective new plans. In February 2025, the investments and participant loans associated with the above entities totaling approximately \$2,970,000 were transferred to their corresponding plans.

Management evaluates subsequent events through the date the financial statements are available for issue, which is the date of the Independent Auditors' Report.

NOTES TO FINANCIAL STATEMENTS

December 31, 2024 And 2023

1. Description Of The Plan

The following brief description of FTL Capital, LLC Retirement Trust (the Plan) is provided for general information purposes only. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General

The Plan, which has been adopted by FTL Capital, LLC, d/b/a Lewis & Clark Holdings, LLC (the Company), is a defined contribution profit sharing plan, which includes a 401(k) provision. Related participating employers which are part of a controlled group include FTL Capital Partners, LLC d/b/a FTL Finance, IT US Acquisition Company, LLC d/b/a SureCam and Lewis & Clark Equity Partners, LLC. The Plan covers all employees immediately upon hire. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan's recordkeeper and Trustee is Ascensus, LLC, through a partnership with The Vanguard Group, Inc. and Ascensus Trust Company.

Contributions

Participants may contribute a percentage of their annual compensation as defined in the Plan Document, not to exceed the maximum allowable under the Internal Revenue Service (the IRS). Additionally, participants age 50 and over may make "catch-up contributions." Participants may also make rollover contributions to the Plan, provided such rollover amounts meet the criteria for transfer as established under the Internal Revenue Code (IRC or the Code).

The Plan includes an ADP Safe Harbor matching provision whereby the Company matches salary deferral contributions at a rate of 100% of the first 4% of eligible compensation.

The Company may also make a discretionary profit sharing contribution. The participant does not have to make deferral contributions to receive the contribution however there is a 1 year service requirement and the participant must be an employee of the Company on the last day of the Plan year. There were no discretionary profit sharing contributions made during 2024 or 2023.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. The net change in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at unpaid principal balance plus accrued but unpaid interest. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan Document.

Payment Of Benefits

Benefits are recorded when paid.

Contributions Receivable And Credit Loss Policy

Amounts due for contributions are stated at the amount that management expects to collect from outstanding balances less an allowance for expected credit losses. The expected credit losses amount reflects management's best estimate of amounts that will not be collected. This assessment considers historical experience, current conditions and, when appropriate, reasonable and supportable forecasts.

The Company has concluded that no allowance for current expected credit losses was necessary at December 31, 2024 or 2023.

3. Certified Investment Information

The following is a summary of the Plan's asset information as of December 31, 2024 and 2023, and for the years then ended, included throughout the Plan's financial statements and supplemental schedule, that was prepared by or derived from information certified by Ascensus Trust Company (the Trustee), and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from the Trustee that the information provided to the Plan Administrator related to the following information is complete and accurate.

4. Fair Value Measurements

The Plan utilizes an established framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value:

Money Market Fund And Mutual Funds

Valued at the daily closing price as reported by the fund. The money market fund and mutual funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The funds held by the Plan are deemed to be actively traded.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of a different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Risks And Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

6. Income Tax Status

The Plan uses a non-standardized pre-approved plan. The pre-approved plan sponsor has received an opinion letter from the IRS dated June 30, 2020, which states that the pre-approved document satisfies the applicable provisions of the Code. The Plan itself has not received a determination letter from the IRS. However, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code, which provides that, if certain conditions are met, an employer may rely on a favorable opinion letter issued to a pre-approved plan sponsor as if the employer had received a favorable determination letter. Therefore, no provision for income tax has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Plan Termination

Although it has not expressed intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

8. Transactions With Parties In Interest

The Plan pays fees to the recordkeeper for administrative services including loan and distribution transactions. In addition, certain participants have outstanding loans with the Plan. These transactions qualify as party in interest transactions allowable under ERISA.

9. Subsequent Events

Effective January 1, 2025, FTL Capital Partners, LLC d/b/a FTL Finance and IT US Acquisition Company, LLC d/b/a SureCam ceased participation in the Plan, and separate individual plans were established for each entity. Beginning on the effective date, all subsequent contributions were directed to the respective new plans. In February 2025, the investments and participant loans associated with the above entities totaling approximately \$2,970,000 were transferred to their corresponding plans.

Management evaluates subsequent events through the date the financial statements are available for issue, which is the date of the Independent Auditors' Report.
