December 31, 2024 and 2023

Note 1 – Plan Description

The following description of the Frost Brown Todd LLP Retirement Savings Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all voting members and non-attorney employees of Frost Brown Todd LLP, Commonwealth Management Services, LLC, and Multi-State Title Agency, Ltd. (collectively, Company and Plan Sponsor), who are not covered by a collective bargaining agreement or a leased employee. Each member and employee becomes eligible to participate in the Plan for the purpose of elective deferrals beginning the first pay date in the first month that begins at least 30 days after the date of employment. Participants are eligible for matching contributions on January 1 or July 1 after they have completed one year of eligible service and profit-sharing contributions after two years of eligible service. The Plan is subject to the provisions of ERISA. The Company, as the Plan Sponsor, designates representatives to the Plan's Retirement Committee. The Retirement Committee has engaged a discretionary investment manager to select and monitor the appropriateness of the Plan's investment options and periodically meets with that investment manager to monitor its work.

Effective January 1, 2017, the Plan was amended to reflect the adoption of the Frost Brown Todd LLP Retirement Savings Plan for Associated Lawyers (Other Plan), which was created for non-voting attorneys of the Company. The existing Frost Brown Todd LLP Retirement Savings Plan remained in place for voting members of the Company and for all non-attorney personnel. Persons who transferred employment classifications after January 1, 2024 such that they were no longer eligible to participate in the Plan, but rather became eligible upon such transfer to the Other Plan, had accumulated balances, including notes receivable from participants, from this Plan transferred to the Other Plan during 2024 in the aggregate amount of \$18,137,865. Persons who were no longer eligible to participate in the Other Plan, but became eligible upon such transfer to the Plan, had accumulated balances, including notes receivable from participants, from the Other Plan transferred to the Plan during 2024 in the aggregate amount of \$2,624,548.

In addition, as further explained in Note 4, on December 31, 2017, the Company established the Frost Brown Todd, LLP Master Trust, which was established for the joint investment of assets of the Plan and the Other Plan.

Note 1 – Plan Description (Continued)

Contributions

Each year, participants may contribute up to 85 percent of eligible annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit, defined contribution, IRA, or 403(b) plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Company contributes 100 percent of the first four percent of compensation that a participant contributes to the Plan. Additional profit-sharing amounts may be contributed to eligible participants at the option of the Company and are invested as directed by the participants. Participants are eligible for the profit-sharing contribution if they remained employed with the Company until the end of the Plan year. For the year ended December 31, 2024, the Company made a \$5,549,594 profit-sharing contribution to the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of the Company's profit-sharing contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan and credited with an allocable share of any revenue sharing, which the Plan's recordkeeper receives from mutual funds in which the Plan invests. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions and the Company's contribution portions of their accounts plus actual earnings thereon.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at a fixed rate equal to the prime rate (as defined by Reuters), plus one percentage point as of the first business day of the calendar month in which the loan application is accepted. Principal and interest are paid ratably through payroll deductions.

Note 1 – Plan Description (Continued)

Payment of Benefits

On termination of service due to death, disability, retirement, or other reasons, a participant may elect to receive either a lump-sum amount equal to the value of the participant's interest in his or her account, or defer receipt of their balance until the participant's required age under IRS Section 401(a)9 if the account is \$7,000 or more. Participants who have reached the age of at least 59 ½ may withdraw all or a portion of the participant's interest in his or her account. Participants may request a withdrawal of their rollover contributions at any time. Participants may request a hardship withdrawal of a portion of their account attributable to participant deferrals. Any hardship withdrawal is limited to the amount needed to meet the financial need.

Note 2 – Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Retirement Committee determines the Plan's valuation policies utilizing information provided by the investment advisors, Trustee, and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. A change in the Plan's interest in Frost Brown Todd, LLP Master Trust includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Note 2 – Significant Accounting Policies (Continued)

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is taxed as if a Plan distribution was received, and the account is offset for the loan when a distribution event can occur.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants, self-directed brokerage monthly fees, distribution, withdrawal and QDRO processing fees, and fees for investment advice provided to participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in the change in the Plan's interest in Frost Brown Todd, LLP Master Trust.

Note 3 – Summary of Financial Data Certified by the Trustee

Note 4 – Interest in Frost Brown Todd, LLP Master Trust

On December 31, 2017, the Company established the Frost Brown Todd, LLP Master Trust (Master Trust), which was established for the investment of assets of the Plan and the Other Plan. Each participating retirement plan has an undivided interest in the Master Trust, with the exception of self-directed brokerage accounts which are considered a divided interest. The assets of the Master Trust are held by T. Rowe Price Trust Company, the Trustee of the Plan.

The value of the Plan's interest in the Master Trust is based on the end of the year value of the Plan's interest in the Master Trust. The Plan's interest in net assets of the Master Trust was approximately 64 and 67 percent as of December 31, 2024 and 2023, respectively. Total investment income (including net appreciation in the fair value of investments) of the Master Trust is allocated to the individual plans based upon the amount of time the plan's assets were invested in the Master Trust.

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the Financial Accounting Standards Board ASC 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Money market fund: The carrying amount approximates fair value because of the short maturity of those instruments.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Self-directed brokerage accounts: Accounts primarily consist of mutual funds, common stocks, preferred stocks, government bonds, unit investment trusts, corporate obligations, cash, and cash equivalents that are valued on the basis of readily determinable market prices.

Collective trust fund: Valued at the NAV of units of a bank collective trust. The NAV, as provided by the Trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly manner.

Note 5 – Related Party Transactions and Party-in-Interest Transactions

Certain Plan investments are shares of mutual funds and a collective trust fund managed by T. Rowe Price Trust Company under the Master Trust. T. Rowe Price Trust Company is the Trustee as defined by the Plan and; therefore, these transactions qualify as party-in-interest transactions. The Plan also has additional investment advisors that are considered parties-in-interest. Certain fees incurred by the Plan for the investment management services are included in the change in the Plan's interest in the Master Trust, rather than a direct payment. The Plan did make direct payments to parties-in-interest and other service providers in the amount of \$165,624. Certain mutual funds share some revenue with T. Rowe Price Trust Company, which revenue is remitted back to the Plan and credited to participant accounts based on the extent to which the participant invested in the funds that paid the revenue sharing. The Company pays directly certain other fees related to the Plan's operations.

Note 6 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA.

Note 7 – Tax Status

The IRS has determined and informed the Plan administrator by a letter dated November 13, 2017, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and; therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing authorities; however, there are currently no audits for any tax periods in progress.

Note 8 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 9 – Subsequent Events

The Plan has evaluated subsequent events through October 2, 2025, the date the financial statements were available to be issued.

Effective January 1, 2025, the Plan adopted certain provisions of the SECURE 2.0 Act to increase catch-up limits for participants aged 60 to 63 years old to the greater of \$10,000 or 50 percent more than the regular catch-up amount.
