**NOTE 1 – DESCRIPTION OF PLAN**

The following description of the Pentagon Federal Credit Union Fort Buchanan Retirement Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document and any amendments thereto for a more complete description of the Plan’s provisions.

General: On June 1, 2002, Pentagon Federal Credit Union (the “Credit Union,” “PFCU,” or “Employer”) established the Pentagon Federal Credit Union Fort Buchanan Retirement Plan in accordance with Section 1165(e) of the Puerto Rico Internal Revenue Code. The Plan is a defined contribution retirement plan covering employees located at the Fort Buchanan location, subject to Board approval, employees of its subsidiaries or affiliated corporate entities. The Plan is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”), and Puerto Rico tax and regulatory requirements.

The Plan is administered by the Retirement Plan Committee (the “Committee”). Members of the Committee are appointed by the Board of Directors of the Credit Union. The Committee is responsible for determining the appropriateness of the Plan’s investment offerings, monitoring investment performance, and ensuring compliance with applicable requirements.

Plan Contributions and Investments: Employees become eligible to enroll in the Plan after 90 days of service time. Participants may contribute from 1% up to 100% of their pretax compensation subject to the legal limit of \$15,000 in 2024. The Plan also allows for after-tax employee contributions. The maximum amount of participant and employer contributions that can be allocated to a participant’s account is \$69,000 in 2024. Participants age 50 and over may also make additional “catch-up” contributions. These additional contributions may not exceed \$1,500 for the year ended December 31, 2024. In addition, the Plan provides that individuals may roll over all or part of a qualified distribution from another tax-qualified plan into the Plan. Participants have the option to opt-in to auto-escalation in which they will have their deferral election increased by 1-3% each year, capped at 10%. Once the 10% limit is reached, any increases are stopped.

The Company will also make employer matching contributions equal to 100% of a participant’s elective deferrals up to 10% of eligible compensation.

The Company may also make non-elective discretionary profit-sharing contributions. Participants must have worked 1,000 hours of service during the Plan year and be employed on the last day of the plan year, except in the event of death, disability or retirement during the year, to be eligible for the discretionary profit-sharing contribution. No discretionary profit-sharing contributions were made for the year ended December 31, 2024.

Participant Accounts: Each participant’s account is credited with the participant’s and employer’s contributions and an allocation of Plan earnings and is charged with his or her withdrawals and an allocation of administrative expenses and Plan losses. Allocations are based on contributions, eligible compensation, participant account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. Each participant directs the investment of his or her account to any of the investment options available under the Plan.

Vesting: Participants are immediately vested in their contributions and related earnings thereon.

**NOTE 1 – DESCRIPTION OF PLAN (Continued)**

A participant's vested interest in their employer matching contributions and employer non-elective discretionary contributions are based upon a 5-year graded schedule in which a participant is 100% vested after five years of credited service.

Notes Receivable from Participants: The Plan allows participants to borrow 50% of their vested funds subject to a maximum of \$50,000 without penalty. The rate of interest is based on the rate charged for Regular Share Loans plus 1%. In general, loan repayment terms range from one to five years, or longer for the purchase of a principal residence, but not to exceed 30 years. The notes are secured by the balance in the participant's account. Interest paid on loans remains in the participant's account and is recorded as investment income. Principal and interest are paid ratably through periodic payroll deductions.

Payment of Benefits: Benefits under the Plan become distributable upon the later of termination of employment or in the calendar year in which a participant reaches age 73. Upon the death of a participant, benefit payments will be paid to the surviving spouse or other designated beneficiary as appropriate. Participants whose employment is terminated on or after reaching age 65 may elect to receive distributions as a lump sum or periodic payments. Participants terminating employment prior to age 65 for reasons other than disability receive distributions in the form of a lump sum. Participants are also permitted to take in-service distributions upon attainment of age 59½ and in cases of immediate and heavy financial need in accordance with the Plan's hardship provisions.

Plan Termination: Although it has not expressed any intent to do so, the Company has the right under the plan agreement to terminate the Plan subject to provisions of ERISA.

Administrative Expenses: Expenses incurred in the administration of the Plan are paid by the Plan Sponsor unless the Plan Sponsor directs that such expenses shall be paid by the Plan. The Plan makes direct payment to The Vanguard Group, Inc. for administrative services. Investment management fees are charged to the Plan as a reduction of the investment return and included in the investment income (loss) reported by the Plan.

**NOTE 2 – SUMMARY OF ACCOUNTING POLICIES**

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from estimated amounts.

Investment Valuation and Income Recognition: The Plan's investments are reported at fair value. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits: Benefits are recorded when paid.

**NOTE 2 – SUMMARY OF ACCOUNTING POLICIES (Continued)**

Risks and Uncertainties: The Plan holds various investments. Investments are exposed to various risks such as interest rate, market, liquidity, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Unaudited 2023 Information: Amounts reported as of December 31, 2023 have not been audited by independent accountants. The first year that the Plan required an audit in accordance with ERISA was for the year ended December 31, 2024.

**NOTE 3 – 2024 CERTIFIED INVESTMENTS AND NOTES RECEIVABLE FROM PARTICIPANTS**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024, and net appreciation in fair value of investments, interest and dividends and interest income on notes receivable from participants for the year then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by The Vanguard Group, Inc. (the trustee of the Plan).

**NOTE 4 – FAIR VALUE MEASUREMENTS**

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

*Level 1:* Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

*Level 2:* Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

*Level 3:* Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

**NOTE 4 – FAIR VALUE MEASUREMENTS (Continued)**

The following presents the valuation methods and assumptions used by the Plan to estimate the fair values of investments.

Registered Investment Funds: The Plan invests in various mutual funds including balanced funds, bond funds, domestic, international and real estate stock funds. The shares of these funds are valued at the net asset value (“NAV”) on the last business day of the Plan year. The NAV of the funds are readily available from, and distributed to, multiple independent sources (i.e. Bloomberg, Reuters, Yahoo finance). As such these prices are quoted prices in active markets.

Collective Trusts: The fair values of participation units held in collective trusts are based on the net asset values per unit as reported by the fund managers. The collective trusts provide for daily redemptions by the Plan at reported net asset values per share, with no advance notice requirement with the exception of the collective trusts issued by BlackRock, Lord Abbett, and Great Gray which require advance written notice of five business days for plan directed withdrawals exceeding \$1,000,000 of the assets invested in each Fund. As the Collective Trusts have been measured at fair value by management, using net asset per share (or its equivalent) as a practical expedient, these values are also not presented in a fair value hierarchy.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan Administrator believes that the valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

\* Investments measured at fair value using net asset value per share (or its equivalent) as a practical expedient have not been classified in the fair value hierarchy. The fair value amounts presented in the hierarchy tables for such investments are intended to permit reconciliation of the fair value hierarchy to the investments at fair value line item presented in the statements of net assets available for benefits.

**NOTE 5 – RELATED PARTY TRANSACTIONS**

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Company.

Certain plan investments are managed by The Vanguard Group, Inc. (“Vanguard”). Vanguard was the custodian during 2024 as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Direct and indirect fees paid by the Plan and notes receivable from participants reflect party-in-interest transactions. Fees paid by the Plan to Vanguard for investment management and recordkeeping services amounted to \$8,246 for the year ended December 31, 2024.

**NOTE 6 – TAX STATUS**

The Plan has not received an opinion or determination letter from the Internal Revenue Service (IRS) or Department of Labor (DOL) regarding its qualification under Section 401(a) of the Internal Revenue Code. Management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code and, therefore, is tax-qualified and the related trust is tax-exempt.

Because the Plan has not obtained a favorable opinion or determination letter, it remains subject to the risk of disqualification in the event of a plan-level audit or examination by taxing authorities. However, the Plan sponsor is not aware of any operational or plan document issues that would cause the Plan to be disqualified.

The Plan’s sponsor intends to continue to maintain the Plan in compliance with applicable requirements and to take corrective action if necessary.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**NOTE 7 – SUBSEQUENT EVENTS**

Plan management has evaluated subsequent events for recognition and disclosure through October 10, 2025 which is the date the financial statements were available to be issued.
