The following description of the Baldwin Richardson Foods Company 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan under the provisions of Section 401(k) of the Internal Revenue Code (“IRC”) for the benefit of all eligible employees of the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Administrative Committee, under the direction of the Board of Directors, is responsible for the oversight of the Plan and determining the appropriateness of the Plan’s investment offerings and monitoring investment performance.

Eligibility

All employees of the Company are eligible to participate upon attaining age 18.

Contributions

Each year, participants may contribute up to 50 percent of their pretax annual compensation, as defined in the Plan, through payroll deductions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 1 percent of eligible compensation and their contributions invested in designated funds until changed by the participant.

The Company may make discretionary matching contributions equal to 50 percent of each participant’s contribution, excluding catch-up contributions, up to a maximum of 6 percent of each participant’s eligible compensation. The Company may also make discretionary profit sharing contributions, which are allocated to participant accounts in the ratio that each participant’s compensation for the Plan year bears to the total compensation for all participants for the Plan year. Participants credited with at least 1,000 hours of service during the Plan year and employed on the last day of the Plan year will be eligible to receive a profit sharing contribution. No profit sharing contributions were made in 2024 or 2023.

Contributions are subject to certain statutory limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions and employer discretionary matching contributions, an allocation of discretionary profit sharing contributions, if any, and an allocation of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts plus earnings thereon is based on years of continuous service. A participant is 100 percent vested after six years of credited service.

Notes Receivable from Participants

A participant may borrow from their accounts the lesser of \$50,000 or 50 percent of his or her vested account balance. The loans are secured by the balance in the participant's account and accrue interest at 1% above the prime rate. The outstanding notes receivable have interest rates ranging from 4.25% to 9.50% per annum and mature through periods ending in 2034. Principal and interest is paid ratably through payroll deductions. Fees related to the administration of notes receivable from participants are charged directly to the specific participant accounts.

Payment of Benefits

Upon termination of service due to death, disability, or retirement, a participant will receive an amount equal to the value of the participant's vested interest in his or her account balance. For terminated participants with balances of \$5,000 or less, the Plan Administrator can automatically roll over the vested account balance into an Individual Retirement Account. Terminated participants with balances of \$1,000 or less shall have their vested account balance paid in a single lump sum distribution.

Forfeited Accounts

Forfeitures of employer matching and profit sharing contributions are used to reduce future employer contributions. The unused forfeitures balance was \$77,463 as of December 31, 2024 and \$5,945 as of December 31, 2023. Employer contributions were reduced by \$58,599 and \$72,598 from forfeited nonvested accounts in 2024 and 2023, respectively.

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value, except for the fully benefit responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Administrative Committee determines the Plan's valuation policies utilizing information provided by the investment advisors, trustees, and insurance company. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from Plan participants and the matching contributions from the Plan sponsor are recorded in the year in which the employee contributions are withheld from compensation and participant compensation is earned.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Any related fees are recorded as administrative expenses and are expensed when incurred. Delinquent participant loans are recorded as benefits paid to participants on the basis of the terms of the Plan document.

Excess Contribution Refund Payable

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service are recorded as a liability with a corresponding reduction to contributions. The excess contribution payable at December 31, 2024 was refunded to participants prior to March 15, 2025.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

All expenses of maintaining the Plan may be paid by the Plan or the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Date of Management's Review

The Plan Administrator has evaluated subsequent events for potential recognition and disclosure through October 10, 2025, the date the financial statements were available to be issued. Management has determined that no such events have occurred.

***Note 3* Certified Investment Information**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by Lincoln Financial Group Trust Company, Inc., the trustee of the Plan.

***Note 4* Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.
- Level 2: Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 or 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5 Fully Benefit-Responsive Investment Contract

The Plan offers an investment in an insurance company's stable value fund that management believes meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses.

The investment contract held by the Plan is a stable value fund and guaranteed investment contract. The insurance company (contract issuer) is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer and can range from 1% to 3%.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value. However, management does not believe that any events are probable of occurring that might limit the ability of the Plan to transact at contract value.

Note 6* **Related Party Transactions and Party-In-Interest Transactions*

Certain Plan investments are managed by Lincoln Financial Group (Lincoln) and related parties to Lincoln. Lincoln Financial Group Trust Company, Inc. is the trustee of the Plan, and therefore these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in the fair value of the investments, as they are paid through revenue sharing, rather than a direct payment.

The chief executive officer of Baldwin Richardson Foods Company, the Plan Sponsor, is a member of the board of directors of Lincoln, is chairman and a member of certain of Lincoln's governance committees.

Note 7* **Plan Termination*

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their account balances.

Note 8* **Tax Status*

The Company adopted a Volume Submitter Profit Sharing Plan with the CODA feature which received a favorable opinion letter from the Internal Revenue Service dated June 30, 2020. The opinion letter stated that the Plan and the related trust were designed in accordance with applicable sections of the Internal Revenue Code. The Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code and therefore believes the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the taxing authorities. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 9* **Risks and Uncertainties*

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
