### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the accompanying financial statements of Lakeside Manufacturing Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

### Note 1: Description of Plan

The following description of the Lakeside Manufacturing Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### General

The Plan is a 401(k) retirement and profit sharing plan covering substantially all full-time employees of Lakeside Manufacturing, Inc. (Sponsor). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The Plan is intended to satisfy the requirements under Section 404(c) of ERISA, and therefore, provides that participants direct their contributions and/or their account balances among the Plan's investment alternatives. All investments are participant directed.

The Sponsor is the Plan Administrator. OneAmerica Retirement Services LLC (OneAmerica) is the third party administrator and recordkeeper.

#### Eligibility and Participation

Employees of the Sponsor are eligible to participate in the Plan upon the completion of three months of employment and attaining age 18. Eligible employees enter the Plan on the first day of January, April, July, or October coincident with or immediately following the attainment of the above requirements.

The Plan also includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants had their deferral rate set at 4% of compensation. Participants were increased 1% annually up to a maximum of 6%. Effective April 1, 2024, automatically enrolled participants have their deferral rate set at 6% of compensation. Participants are increased 1% annually up to a maximum of 10%.

#### Contributions

Each year, participants may contribute up to 100% of their compensation, as defined by the Plan document, not to exceed the limits of Internal Revenue Service (IRS) Section 401(k). Participants may also contribute distributions from other qualified plans (rollovers).

Discretionary Sponsor profit sharing and discretionary Sponsor matching contributions may be contributed at the option of the Sponsor's Board of Directors. The Sponsor made discretionary matching contributions equal to 50% of the first 6% of eligible compensation during 2024. Discretionary Sponsor matching contributions for 2024 were \$280,233. No discretionary Sponsor profit sharing contributions were made for 2024.

### Note 1: Description of Plan (Continued)

#### Participant Accounts

Each participant's account is credited with the participant's contributions, Sponsor contributions, if any, and related Plan earnings (losses) thereon, and charged with an allocation of administrative expenses. Allocations are based on participant earnings (losses), account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of the participant's vested account balance. Principal and interest payments on the notes are credited to the participant account from which the loan was made and are paid through payroll deductions. Note periods are generally limited to five years. Loans are secured by the balance in the participant's account and bear interest at 8.25% to 10.50%.

#### Payment of Benefits

On termination of service due to death, disability, or retirement, a participant or a designated beneficiary may elect to receive the benefits equal to the value of their vested account balance as a lump-sum payment, or in installments. Once a participant has reached the age of 59 ½, in-service distributions may be made, at the participant's election, from any accounts which are 100% vested. For termination of service due to other reasons, a participant may receive the value of the vested interest in their account as a lump-sum distribution. Under certain circumstances participants may qualify to receive a hardship distribution from their account balance. If a terminated participant's vested balance is less than or equal to \$7,000, the amount may be automatically distributed in the form of a lump-sum distribution.

#### Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings (losses) thereon. Vesting in the Sponsor's discretionary contributions portion of their account, plus actual earnings (losses) thereon, is based on the number of years of continuous service as shown by the following:

#### **Forfeitures**

The Sponsor may elect to use forfeitures to reduce discretionary Sponsor contributions or to reduce Plan expenses. Unallocated forfeitures at December 31, 2024 and 2023 were \$171 and \$5,348, respectively. During 2024 forfeitures of \$7,469 were used to offset Plan expenses. No amounts were used to reduce discretionary Sponsor contributions during 2024.

#### **Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Sponsor. Expenses that are paid by the Sponsor are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are allocated proportionately to the Plan participants based on their respective account balances and are included in net appreciation in fair value of investments.

#### **SECURE 2.0 Act of 2022**

The SECURE 2.0 Act of 2022 (SECURE 2.0), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements. Management has evaluated those provisions and there is no material impact on the Plan. Plan management will determine the option provisions to elect in the future.

### **Note 2: Summary of Significant Accounting Policies**

#### **Basis of Accounting**

The financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

#### **Use of Estimates in Preparation of Financial Statements**

The preparation of the financial statements in accordance with GAAP requires management to make estimates and assumptions that affect certain reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates and are subject to change in the near term.

#### **Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Interest income is recorded on the accrual basis. If a participant ceases to make loan repayments and the Plan Administrator deems the participant to be in default, the participant note balance is reduced and the benefit payment is recorded.

#### **Subsequent Events**

The Sponsor has evaluated subsequent events through October 10, 2025, which is the date the financial statements were available to be issued.

### **Note 3: Party-In-Interest Transactions**

Transactions involving administrative fees charged by the custodian and notes receivable from participants are considered party-in-interest transactions. These transactions are not, however, considered prohibited transactions under 29CFR 408(b) of the ERISA regulations.

### **Note 4: Risks and Uncertainties**

The Plan's investments are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments and the level of uncertainty related to changes in the values of investments, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### Note 5: Fair Value Measurements

GAAP specifies a three-tier fair value hierarchy, which prioritizes the inputs used in estimating fair value. These tiers include Level 1, defined as observable inputs such as quoted market prices in active markets; Level 2, defined as inputs other than quoted market prices in active markets that are either directly or indirectly observable; and Level 3, defined as unobservable inputs in which little or no market data exists, therefore, requiring an entity to develop its own assumptions.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common/collective trust:* A stable value fund that is composed primarily of fully benefit-responsive investment contracts that are valued at the NAV of units of the bank collective trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. The fund does not require a redemption notice period for participants and allows participants to immediately redeem all or a portion of their investment.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### Note 7: Tax Status

The IRS has determined and informed the Sponsor by a letter that the Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan Administrator and the Plan's tax counsel believe the Plan is designed, and currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that that Plan is qualified and related trust is tax-exempt.

### Note 8: Plan Termination

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan document to discontinue its contributions and to terminate or partially terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Sponsor contributions.
