### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements**

We have performed an audit of the accompanying financial statements of United Quality Cooperative 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the 2024 United Quality Cooperative 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

- the information in the 2024 financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion on the 2024 Financial Statements**

**NOTE 1 PLAN DESCRIPTION**

The following description of the United Quality Cooperative 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General**

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan is a defined contribution plan covering qualified employees of United Quality Cooperative (Company).

The Plan is administered by the Investment Committee of the Company. A third party administrator, John Hancock Life Insurance Company (U.S.A.) serves as the provider of the Plan and maintains the records of participant data.

**Eligibility**

Effective July 1, 2024, employees of the Company are eligible to contribute to the Plan upon the attainment of age 18 and completion of three months of service. Employees are able to enroll in the Plan on the first day of each calendar quarter coinciding with or next following the date they satisfy the Plan's eligibility requirements. Prior to July 1, 2024, employees of the Company were eligible to contribute to the Plan upon the attainment of age 18 and completion of one year of service, defined as 1,000 hours during the 12-month period immediately following date of hire.

Effective July 1, 2024, there are no additional eligibility requirements in order to receive discretionary employer profit sharing contributions. Prior to July 1, 2024, in order to receive discretionary employer profit sharing contributions, employees must have completed 1,000 hours of service in the Plan year and be employed on the last day of the Plan year.

**Contributions**

Participants may contribute up to the maximum dollar amount allowed under federal regulations for the Plan year. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan allows participants to allocate contributions between pre-tax and Roth deferrals.

Effective January 1, 2024, eligible participants are automatically enrolled, until they affirmatively elect otherwise, to defer 4% of their compensation, with a 1% increase on January 1<sup>st</sup> of each year up to a maximum of 10% of the participant's compensation. These contributions are defaulted to be withheld as pre-tax contributions.

Effective January 1, 2024, the Company contributes a Safe Harbor employer matching contribution to eligible participants equal to 4% of eligible compensation that a participant contributes to the Plan. Prior to January 1, 2024, the Company contributed a Safe Harbor employer matching contribution to eligible participants equal to 100% of the first 3% plus 50% of the next 2% of eligible compensation that a participant contributes to the Plan.

Additional employer profit sharing contributions may be contributed at the discretion of the Company. For the years ended December 31, 2024 and 2023, each employee will receive a discretionary profit sharing contribution equal to 3-7% of their eligible compensation. For the years ended December 31, 2024 and 2023, the discretionary employer profit sharing contributions were \$277,908 and \$290,703, respectively.

Participants may make rollover contributions for amounts representing distributions from other qualified defined benefit plans, defined contribution plans, or individual retirement accounts.

**Participant Accounts**

Each participant's account is credited with the participant's contributions and the Company's contributions. Plan earnings are allocated based on participant account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. The Plan allows for participant-directed investment programs for which separate funds are maintained. The value of each participant's account is determined daily.

**Participants' Investment Options**

Participants must direct their salary deferral contributions, and Company contributions to selected investments as offered by the Plan. Participants may change their investment options throughout the year by contacting the recordkeeper.

**Payment of Benefits**

Upon termination of employment, death, disability or retirement, a participant with a vested account balance of more than \$7,000 can receive lump-sum payment or installment payments equal to the value of the participant's vested account. If the vested value of the participant's account is less than \$7,000, the participant will be forced out of the Plan. If a mandatory distribution is being made because a participant's vested interest in the Plan exceeds \$1,000 but does not exceed \$7,000, then the Plan will roll over the distribution to an IRA. If the vested interest is less than \$1,000, the mandatory distribution will be paid in a lump sum.

Hardship distributions and in-service retirement distributions are also permitted for participants who have not separated from service. Participants must have attained age 59 ½ to qualify for in-service retirement distributions.

Generally, certain minimum distributions are required for participants who have separated from service and have reached the required minimum distribution age.

**Vesting**

Participants are always 100% vested in their elective deferrals, plus actual earnings thereon.

Effective January 1, 2024, any new Plan participant's Safe Harbor employer matching contributions are subject to a 2-year cliff vesting, in which the employee becomes 100% vested after 2 years of service with the Company. Existing Plan participants as of January 1, 2024 will be 100% vested immediately. Prior to January 1, 2024, all Plan participant's Safe Harbor employer matching contributions were 100% vested immediately.

Discretionary employer profit sharing contributions follow a 4 year vesting schedule, in which the participant is 100% vested after 4 years of service with the Company.

**Forfeitures**

At December 31, 2024 and 2023, forfeited nonvested amounts of \$3,579 and \$2,927, respectively. This account is used to reduce employer contributions or pay plan expenses. Forfeitures of \$56,680 and \$31,705 were used to offset employer contributions during the years ended December 31, 2024 and 2023, respectively.

**Notes Receivable from Participants**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of the participant's vested account balance, for a term not to exceed five years (fifteen years in cases where the loan proceeds are used to purchase the participant's principal residence). All loans shall bear a fixed interest rate at 1% above the prime interest rate. Principal and interest are paid ratably during the year through payroll deductions and credited to the participant's account. A participant may have no more than one outstanding note at any one time.

**Reclassifications**

Certain investments in the prior year have been reclassified for comparative purposes to conform with the presentation in the current year. Those changes have no effect on net assets available for benefits as previously reported.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Basis of Presentation**

The accompanying financial statements are presented in accordance with accounting principles generally accepted in the United States of America, ("GAAP"), as codified by the Financial Accounting Standards Board.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment committee determines the Plan's valuation policies utilizing information provided by investment advisors and the Plan Provider. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are reflected on a trade date basis. Interest income is recorded as earned on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year and is reflected in the statements of changes in net assets available for benefits.

**Contributions**

Contributions from Plan participants and Safe Harbor employer matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

**Payment of Benefits**

Benefits to participants are recorded when paid.

**Administrative Expenses**

The investment funds in the Plan are subject to investment fees based on a percentage of invested assets, as disclosed in the fund's prospectus. All such fees are charged directly against the fund's investment performance and thus are not separately disclosed in the accompanying financial statements. Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the plan sponsor. Expenses that are paid by the plan sponsor are excluded from these financial statements.

**Income Taxes**

The Plan's policy is to evaluate the likelihood that its uncertain tax positions will prevail upon examination based on the extent to which those positions have substantial support within the Internal Revenue Code and Regulations, Revenue Rulings, court decisions, and other evidence.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

**Excess Contributions Payable**

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The amount of excess contributions was \$16,820, as of December 31, 2023. The Plan distributed the 2023 excess contributions to the applicable participants during 2024. There were no excess contributions payable as of December 31, 2024.

**NOTE 4 FAIR VALUE MEASUREMENTS**

FASB ASC Topic 820, *Fair Value Measurements*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under Topic 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;

- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There has been no change to the methodology used at December 31, 2024 and 2023.

Pooled Separate Accounts: Valued at the net asset value (NAV) of shares held by the Plan at year end. The NAV, as provided by the insurance company, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the account less its liabilities. This practical expedient is not used when it is determined to be probable that the account will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the accounts, the investment advisor reserves the right to temporarily delay withdrawal from the account in order to ensure that securities liquidations will be carried out in an orderly business manner.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Aggressive growth pooled separate accounts invest in stocks of companies with potential for rapid growth. These investments seek long term growth of capital.

Conservative pooled separate accounts seek to preserve capital and provide stability of principal while earning current income that exceeds money market rates over the long term.

Growth pooled separate accounts include investments that invest in companies the account manager believes have above-average growth potential. Most underlying holdings are in common stocks. The accounts may make limited use of futures and/or options for the purpose of maintaining equity exposure. These managers are generally willing to pay higher market multiples for the superior growth rates and profitability they anticipate. As a result, stocks in growth portfolios will tend to have higher price/earnings ratios and will generally pay little or no dividends.

Income pooled separate accounts invest in bonds or other fixed-income securities as well as preferred shares and dividend stocks. These investments prioritize current income, often in the form of interest or dividend-paying investments.

Target date pooled separate accounts provide investors with a portfolio of a mix of stocks and bonds, as well as cash equivalents, with a variety of objectives.

**NOTE 5 CONTRACTS WITH INSURANCE COMPANIES**

The Plan holds pooled separate accounts through a Group Annuity Contract with John Hancock Life Insurance Company (U.S.A). The pooled separate accounts are credited with the earnings on the underlying investments and charged for participant withdrawals and administrative expenses.

**NOTE 6 INCOME TAX STATUS**

The Plan uses a pre-approved plan document sponsored by TSC Inc. which received an opinion letter from the IRS dated June 30, 2020, stating that the pre-approved document satisfies the applicable provisions of the IRC. The Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken a significant uncertain tax position that more likely than not would not be sustained upon examination by taxing authorities. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.

**NOTE 7 EXEMPT TRANSACTIONS WITH PARTIES-IN-INTEREST**

Fees paid to John Hancock Life Insurance Company (USA) for administrative services during the years ended December 31, 2024 and 2023 were \$9,552 and \$4,681, respectively. Fees paid to LPL Financial LLC for investment advisory services during the years ended December 31, 2024 and 2023 were \$15,853 and \$0, respectively. Fees paid to Wilshire Associates Inc. for investment advisory services during the years ended December 31, 2024 and 2023 were \$1,431 and \$778, respectively. Fees paid to Cetera Advisors LLC for investment advisory services during the years ended December 31, 2024 and 2023 were \$19,908 and \$19,443, respectively. In addition, during 2024 and 2023, \$7,725 and \$12,120 in loan set-up fees and distribution fees were paid to the third-party administrator for the Plan.

**NOTE 10 AMENDMENT AND TERMINATION**

Although it has not expressed intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of a plan termination, the rights to all participants shall remain nonforfeitable. In the event of plan termination, participants will become 100 percent vested in their accounts.

**NOTE 11 RISKS AND UNCERTAINTIES**

Participants direct the investment of their accounts into various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect account balances and the amounts reported in the statements of net assets available for benefits.
