**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of *OLOR LLC 401(k) Plan*, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

## **Opinion**

NOTE 1 - DESCRIPTION OF PLAN

The following brief description of the *OLOR LLC 401(k) Plan* ("Plan"), is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

*General*

The Plan is a defined contribution plan covering all eligible employees of *OLOR, LLC* ("Company"). Eligible employees are those who have completed 90 days or more of service and are age 21 or older. The Plan has been restated to comply with the provisions of the SECURE Act, CARES Act, and the Consolidated Appropriations Act. The Plan is subject to the provisions of ERISA.

*Contributions*

Participants may contribute elective salary reductions up to 100 percent of their compensation as long as the total contribution does not exceed the legal dollar or percentage limits for the Plan year. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contribution into various investment options offered by the Plan. The Company has the right to make discretionary matching contributions to eligible employees each plan year. The Company contributed discretionary matching contributions of 50 percent of the first 5 percent of base compensation that participants contributed to the Plan for the years ended December 31, 2024 and 2023.

*Participant Accounts*

Each participant's account is credited with the participant's elective salary reduction contribution, the Company's matching contribution, and Plan earnings (losses) charged with an allocation of administrative expenses. Allocations are based on participant earnings (losses) or account balances, as defined in the Plan. The benefit to which a participant is entitled is the benefit that could be provided from the participant's account.

*Vesting*

Participants are immediately vested in their elective salary reduction contributions plus actual earnings (losses) allocated thereon. The Company portion of contributions plus actual earnings (losses) are vested to participants ratably over a five-year period.

NOTE 1 - DESCRIPTION OF PLAN - CONTINUED

*Participant Loans*

Participants may borrow from their fund accounts as determined by the Plan administrator. Participants may borrow a minimum of \$1,000 or any amount that does not exceed 50 percent of the participant's vested account balance as of the end of the accounting period preceding the date on which the loan is approved or \$50,000, whichever amount is smaller. The loans are secured by assignment of 50 percent of the borrower's interest in their account and each loan will bear interest at a fixed rate for the life of the loan at a rate of one percent over the prime rate. Loans for general purposes have terms ranging from 12 months to 60 months while loans related to principal residences have terms up to 180 months.

*Payment of Benefits*

Upon termination of service due to death, disability, retirement, or separation, a participant will receive a lump-sum amount equal to the value of the participant's vested interest in their account.

*Plan Forfeitures*

The Plan uses forfeited amounts to either reduce employer contributions or to offset the Plan's administrative expenses. Employer contributions to the Plan were reduced by \$554 and \$8,825 from forfeited amounts received during the years ended December 31, 2024 and 2023, respectively.

*Revenue-Sharing Income*

The Plan uses revenue-sharing income to directly pay for the Plan's investment management expenses. Plan revenue-sharing income used to pay investment management fees were \$26,209 and \$20,237 during the years ended December 31, 2024 and 2023, respectively.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

*Basis of Accounting*

The accompanying financial statements are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the plan.

*Estimates*

The preparation of financial statements in conformity with GAAP requires the Plan administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

*Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the Plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES - CONTINUED

*Investment Valuation and Income Recognition*

The Plan's investments are stated at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

*Payment of Benefits*

Benefit payments to participants are recorded when paid.

*Plan Expenses*

Certain Plan expenses, including fees for investment management, recordkeeping services, and administrative expenses are paid by the Plan and are either allocated to participant accounts or are included in net appreciation in fair value of investments presented in the statements of changes in net assets available for benefits. All other administrative expenses, including compensation for officers and employees performing administrative functions, are paid by the Company and are excluded from these financial statements.

*Subsequent Events*

Management has evaluated subsequent events through October 7, 2025, the date on which the financial statements were available to be issued.

NOTE 4 - INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan has a group annuity contract with Empower Annuity Insurance Company of America and Empower Trust Company, LLC. The group annuity contract, Key Guaranteed Portfolio Fund, is a fixed account that is part of the general account of Empower Annuity Insurance Company of America. The methodology for calculating the interest crediting rate is based on the earnings (losses) of the underlying assets in the entire medium long-term new portfolio compared to the minimum interest crediting rate (which will never be less than zero percent as stated in the contract) and prevailing market conditions. Interest crediting rate is reset quarterly. The group annuity contract is presented on the face of the statements of net assets available for benefits at contract value and reported with the investments at fair value under the principles of ASU 2015-12.

NOTE 4 - INVESTMENT CONTRACT WITH INSURANCE COMPANY - CONTINUED

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include premature termination of the contracts by the Plan, plant closings, layoffs, plan termination, bankruptcy, mergers, and early retirement incentives. The Plan does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

The average yield earned by the Plan is derived by averaging the quarterly gross interest rates for the fund over the year. The average yield for the years ended December 31, 2024 and 2023, was 1.41 percent and 1.23 percent, respectively.

NOTE 5 - FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value in the statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods were appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. No Level 1 or Level 3 inputs were available to the Plan.

*Level 2 Fair Value Measurements*

The fair value of the Plan's investments in registered investment companies and in the Key Guaranteed Portfolio Fund of Empower Annuity Insurance Company of America (see Note 4), also known as a fixed annuity, are based on inputs, other than the quoted prices included within Level 1, that are observable for valuing the asset or liability, either directly or indirectly. Observable inputs include quoted market prices for similar assets or liabilities in active or non-active markets.

NOTE 7 - TAX STATUS

Effective January 1, 2022, the Plan was restated via a non-standardized pre-approved plan of KDP Retirement Services, Inc., who has been informed by the Internal Revenue Service (IRS), by a letter dated June 30, 2020, that its plan was designed in accordance with applicable sections of the Internal Revenue Code (IRC) and, therefore, the Plan is qualified and the related trust is tax exempt. The Plan administrator and the Plan's tax counsel believe that the Plan is designed and is being operated in compliance with the applicable provisions of the IRC.

GAAP requires the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing authorities; however, there are currently no audits for any tax periods in progress.

NOTE 8 - RELATED PARTY TRANSACTIONS

Certain Plan investments are shares of registered investment companies and fixed annuity contracts managed by Empower Annuity Insurance Company of America and Empower Trust Company, LLC, custodians of the Plan, for the years ended December 31, 2024 and 2023, and LPL Financial, LLC, the investment advisor. Therefore, these transactions qualify as party-in-interest transactions. The party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE 9 - NONEXEMPT PARTY-IN-INTEREST TRANSACTIONS

During the years ended December 31, 2024 and 2023, it was discovered that certain participants' amounts withheld were not timely remitted to the Plan. The total amount of late remittances contributed to the Plan during the years ended December 31, 2024 and 2023, was \$71,759 and \$89,937, respectively. The Plan sponsor remitted lost earnings to the Plan related to these late remittances.

NOTE 10 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to provisions of ERISA.

NOTE 11 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 12 - RECONCILIATION OF FINANCIAL STATEMENTS TO SCHEDULE H OF FORM 5500
