### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of LifeGift Organ Donation Center 401(a) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### ***Opinion***

In our opinion, based on our audits and on the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (US GAAP).
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of US GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with US GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

***Other Matter — Supplementary Information Required by ERISA***

The supplementary information listed in the table of contents as of December 31, 2024 are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplementary information, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with US GAAS. For information included in the supplementary information that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplementary information, we evaluated whether the supplementary information, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

## Notes to Financial Statements

### **Note 1. Description of the Plan**

The following description of the LifeGift Organ Donation Center Defined Contribution Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions, which is available from Plan Management.

#### **General**

The Plan was adopted by LifeGift Organ Donation Center (LifeGift or Employer) on January 1, 2006. It is a noncontributory defined contribution plan covering all employees. Employees of LifeGift are eligible to participate in the Plan on their first day of employment. Under the Plan, discretionary contributions are made solely by LifeGift for amounts determined by LifeGift's Investment Committee. The Plan and the Trust, of which it is a part, are intended to satisfy all of the requirements for a qualified retirement plan under the appropriate provisions of the Internal Revenue Code (Code) and similar state tax laws. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Fidelity Management Trust Company (the Trustee) serves as the custodian and trustee of the Plan's investment assets and has provided 2024 and 2023 certification statements as to the completeness and accuracy of the information provided to the Plan's sponsor. Accordingly, the Plan has elected to instruct the auditors not to perform any auditing procedures with respect to the information prepared and certified by the Trustee, pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. This limited scope exemption applies only to the Plan's investment assets, notes receivable from participants and investment income.

#### **Contributions**

Each year, LifeGift makes a discretionary contribution, based on a percentage of annual compensation, to participants who have completed 1,000 hours of service and are actively employed on the last day of the Plan year. Annual compensation includes base salary, commissions, amounts that could have been received in cash in lieu of salary reduction, contributions made pursuant to a tax sheltered annuity plan under Section 403(b) of the Code, made to a cafeteria plan under section 125 of the Code, or made to a qualified transportation fringe program by reason of application of Section 132(f) of the Code; but excluding overtime, bonuses, severance and separation pay, PTO termination pay, contributions to any other deferred compensation program, and any other extraordinary compensation.

For the year ended December 31, 2024, the Employer contributed \$1,520,216, or 5% of each eligible employee's 2024 compensation, as defined. For the year ended December 31, 2023, the Employer contributed \$1,247,307, or 5% of each eligible employee's 2023 compensation, as defined.

#### **Participant Accounts**

Each participant's account is credited with the Employer's contributions and any rollover contributions from a qualified plan as well as an allocation of investment earnings or losses, and is charged with any administrative expenses relating to their specific transactions. Contributions are deposited into a trust account, which is invested by the Trustee based on various investment options determined by each participant, including a self-directed brokerage account. A participant may change his or her investment options at any time via a telephone service or the Internet, once enrolled.

## Notes to Financial Statements

### Vesting

Employees are immediately vested with respect to their rollover contributions and earnings and losses thereon. Employer contributions and earnings and losses thereon vest based on their full years of active service with the Employer as follows (except that upon death, total permanent disability, or retirement at the age of 65, the employee becomes 100 percent vested):

Less than one year	0%
One year	20%
Two years	40%
Three years	60%
Four years	80%
Five years or more	100%

For Employer contribution vesting purposes, a year of service is defined as one in which the employee worked at least 1,000 hours during the Plan year. All years of service are counted, regardless of whether or not they are continuous, provided there are not five consecutive "One-Year Breaks-in-Service". A "One-Year Break-in-Service" is defined as any Plan year during which an individual has no more than 500 hours of service. A participant is 100 percent vested after five years of credited service.

### Notes Receivable from Participants

A participant may borrow up to the lesser of (1) 50 percent of his or her vested account balance, or (2) \$50,000. The minimum note receivable amount is \$1,000. The interest rate on the note receivable is one percent above the prime rate during the period in which the note receivable is processed, rounded to the nearest one-quarter of one percent. Payments on notes receivable from participants are made through payroll deductions. Each payment, including interest, is credited to the participant's account.

### Payment of Benefits

The standard form of benefit payment upon termination of service is a life or joint and survivor annuity. A participant may elect to not receive the standard benefit. Any participant who elects not to receive the standard benefit shall alternatively be paid in either a lump-sum amount equal to the vested value of his or her account, in periodic installment payments, or a commercial term annuity. In the event that a participant has not elected a form of benefit payment, the Plan administrator will make such election. At December 31, 2024 and 2023, the Plan has no participants who have elected to have benefits paid under an annuity option.

### Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$185,435 and \$221,310, respectively. These accounts will be used to reduce future Employer contributions and to pay Plan expenses. During 2024 and 2023, Employer contributions were reduced by \$130,000 and \$0, respectively, from forfeited nonvested accounts.

## Note 2. Significant Accounting Policies

### Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

## Notes to Financial Statements

### Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from these estimates.

### Investment Valuation and Income Recognition

The Plan's investments are recorded at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and insurance company. See Note 4 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's unrealized and realized gains and losses on investments during the year.

### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan agreement. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

### Payments of Benefits

Benefits are recorded when paid.

### Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by LifeGift. Expenses that are paid by LifeGift are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

### Plan Management's Review of Subsequent Events

The Plan has evaluated subsequent events through October 8, 2025, the date the financial statements were available to be issued.

### Note 3. Certified Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplementary information, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company, the Trustee of the Plan.

### Note 4. Fair Value Measurements

FASB ASC 820, *Fair Value Measurement*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2      Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability; and
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Self-directed brokerage accounts:* Accounts primarily consist of mutual funds and common stocks that are valued on the basis of readily determinable market prices.

### **Note 5. Related Party Transactions and Party in Interest Transactions**

Certain Plan investments are shares of mutual funds managed by Fidelity Investments Institutional Operations Company. Fidelity Management Trust Company is the custodian and Trustee for the Plan and, therefore, these transactions qualify as party-in-interest transactions. These transactions are covered by an exemption from the "prohibited transactions" provisions of ERISA and the Code. All investment fund earnings or losses posted to each Plan participant's account are net of investment management fees charged by each investment fund under the Plan.

### **Note 6. Plan Termination**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their Employer contributions.

### **Note 7. Tax Status**

The Internal Revenue Service (IRS) has determined and informed the Employer by a letter dated July 8, 2014, that the Plan and related trust are designed in accordance with applicable sections of the Code. Although the Plan has been amended since receiving the determination letter, Plan management believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Code and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

US GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **Note 8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that some changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

### **Note 9. Reconciliation of Financial Statements to Form 5500**

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of LifeGift Organ Donation Center 401(a) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### ***Opinion***

In our opinion, based on our audits and on the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (US GAAP).
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with US GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

## Notes to Financial Statements

### **Note 1. Description of the Plan**

The following description of the LifeGift Organ Donation Center Defined Contribution Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions, which is available from Plan Management.

#### **General**

The Plan was adopted by LifeGift Organ Donation Center (LifeGift or Employer) on January 1, 2006. It is a noncontributory defined contribution plan covering all employees. Employees of LifeGift are eligible to participate in the Plan on their first day of employment. Under the Plan, discretionary contributions are made solely by LifeGift for amounts determined by LifeGift's Investment Committee. The Plan and the Trust, of which it is a part, are intended to satisfy all of the requirements for a qualified retirement plan under the appropriate provisions of the Internal Revenue Code (Code) and similar state tax laws. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Fidelity Management Trust Company (the Trustee) serves as the custodian and trustee of the Plan's investment assets and has provided 2024 and 2023 certification statements as to the completeness and accuracy of the information provided to the Plan's sponsor. Accordingly, the Plan has elected to instruct the auditors not to perform any auditing procedures with respect to the information prepared and certified by the Trustee, pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. This limited scope exemption applies only to the Plan's investment assets, notes receivable from participants and investment income.

#### **Contributions**

Each year, LifeGift makes a discretionary contribution, based on a percentage of annual compensation, to participants who have completed 1,000 hours of service and are actively employed on the last day of the Plan year. Annual compensation includes base salary, commissions, amounts that could have been received in cash in lieu of salary reduction, contributions made pursuant to a tax sheltered annuity plan under Section 403(b) of the Code, made to a cafeteria plan under section 125 of the Code, or made to a qualified transportation fringe program by reason of application of Section 132(f) of the Code; but excluding overtime, bonuses, severance and separation pay, PTO termination pay, contributions to any other deferred compensation program, and any other extraordinary compensation.

For the year ended December 31, 2024, the Employer contributed \$1,520,216, or 5% of each eligible employee's 2024 compensation, as defined. For the year ended December 31, 2023, the Employer contributed \$1,247,307, or 5% of each eligible employee's 2023 compensation, as defined.

#### **Participant Accounts**

Each participant's account is credited with the Employer's contributions and any rollover contributions from a qualified plan as well as an allocation of investment earnings or losses, and is charged with any administrative expenses relating to their specific transactions. Contributions are deposited into a trust account, which is invested by the Trustee based on various investment options determined by each participant, including a self-directed brokerage account. A participant may change his or her investment options at any time via a telephone service or the Internet, once enrolled.

## Notes to Financial Statements

### Vesting

Employees are immediately vested with respect to their rollover contributions and earnings and losses thereon. Employer contributions and earnings and losses thereon vest based on their full years of active service with the Employer as follows (except that upon death, total permanent disability, or retirement at the age of 65, the employee becomes 100 percent vested):

Less than one year	0%
One year	20%
Two years	40%
Three years	60%
Four years	80%
Five years or more	100%

For Employer contribution vesting purposes, a year of service is defined as one in which the employee worked at least 1,000 hours during the Plan year. All years of service are counted, regardless of whether or not they are continuous, provided there are not five consecutive "One-Year Breaks-in-Service". A "One-Year Break-in-Service" is defined as any Plan year during which an individual has no more than 500 hours of service. A participant is 100 percent vested after five years of credited service.

### Notes Receivable from Participants

A participant may borrow up to the lesser of (1) 50 percent of his or her vested account balance, or (2) \$50,000. The minimum note receivable amount is \$1,000. The interest rate on the note receivable is one percent above the prime rate during the period in which the note receivable is processed, rounded to the nearest one-quarter of one percent. Payments on notes receivable from participants are made through payroll deductions. Each payment, including interest, is credited to the participant's account.

### Payment of Benefits

The standard form of benefit payment upon termination of service is a life or joint and survivor annuity. A participant may elect to not receive the standard benefit. Any participant who elects not to receive the standard benefit shall alternatively be paid in either a lump-sum amount equal to the vested value of his or her account, in periodic installment payments, or a commercial term annuity. In the event that a participant has not elected a form of benefit payment, the Plan administrator will make such election. At December 31, 2024 and 2023, the Plan has no participants who have elected to have benefits paid under an annuity option.

### Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$185,435 and \$221,310, respectively. These accounts will be used to reduce future Employer contributions and to pay Plan expenses. During 2024 and 2023, Employer contributions were reduced by \$130,000 and \$0, respectively, from forfeited nonvested accounts.

## Note 2. Significant Accounting Policies

### Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

## Notes to Financial Statements

### Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from these estimates.

### Investment Valuation and Income Recognition

The Plan's investments are recorded at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and insurance company. See Note 4 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's unrealized and realized gains and losses on investments during the year.

### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan agreement. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

### Payments of Benefits

Benefits are recorded when paid.

### Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by LifeGift. Expenses that are paid by LifeGift are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

### Plan Management's Review of Subsequent Events

The Plan has evaluated subsequent events through October 8, 2025, the date the financial statements were available to be issued.

### Note 3. Certified Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplementary information, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company, the Trustee of the Plan.

### Note 4. Fair Value Measurements

FASB ASC 820, *Fair Value Measurement*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2      Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability; and
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Self-directed brokerage accounts:* Accounts primarily consist of mutual funds and common stocks that are valued on the basis of readily determinable market prices.

### **Note 5. Related Party Transactions and Party in Interest Transactions**

Certain Plan investments are shares of mutual funds managed by Fidelity Investments Institutional Operations Company. Fidelity Management Trust Company is the custodian and Trustee for the Plan and, therefore, these transactions qualify as party-in-interest transactions. These transactions are covered by an exemption from the "prohibited transactions" provisions of ERISA and the Code. All investment fund earnings or losses posted to each Plan participant's account are net of investment management fees charged by each investment fund under the Plan.

### **Note 6. Plan Termination**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their Employer contributions.

### **Note 7. Tax Status**

The Internal Revenue Service (IRS) has determined and informed the Employer by a letter dated July 8, 2014, that the Plan and related trust are designed in accordance with applicable sections of the Code. Although the Plan has been amended since receiving the determination letter, Plan management believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Code and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

US GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **Note 8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that some changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.
