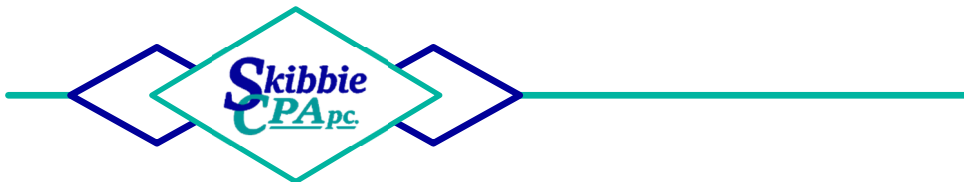

## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator, Plan Management and Participants  
Presidion Solutions, Inc. 401k Plan

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Presidion Solutions, Inc. 401k Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024, and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Presidion Solutions, Inc. 401k Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024, and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### ***Opinion***

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Presidion Solutions, Inc. 401k Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

#### 1. Description of Plan (continued...)

The following description of the Presidion Solutions, Inc. 401k Plan (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

##### *General*

The Plan was a defined contribution plan established to provide for contributions made under salary deferral agreements pursuant to Section 401(k) of the Internal Revenue Code (the “Code”). The Plan covered substantially all eligible employees of Presidion Solutions, Inc. (hereafter referred to as the “Company”) and the employer organizations who had adopted the plan (see “Participating Employers”). The Plan was a “multiple employer” plan as described in Section 413(c) of the Internal Revenue Code. The Plan was established on October 1, 1998, and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”) as amended. Presidion Solutions, Inc. was dissolved in July 2007, and all contributions have been suspended. During 2024, participant accounts were liquidated and are being transferred to Individual IRA accounts.

##### *Participating Employers*

Each employer that contracted with the Company to fulfill its payroll functions as a professional employer organization had the option of adopting this plan for the benefit of its employees. An employer that adopted this plan is known as a *participating employer*. An employer that did not adopt this plan may have adopted its own retirement plan. Any employer adopting its own retirement plan is subject to its plan’s regulations and not those of the Plan. Therefore, their plan information is not included in these financial statements.

##### *Participant Eligibility*

Prior to the Company’s dissolution, employees of the Company or its participating employers could participate in the Plan after they had completed their specific employer’s eligibility requirements relating to age and length of service as determined by their participating employer within the required limits of the Code.

##### *Contributions*

Prior to the Company’s dissolution, participants could have contributed a percent of pretax annual compensation as defined in the Plan to the maximum allowed by the Code. Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants also may have contributed amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions in various investment options offered by the Plan.

Prior to the Company’s dissolution, the Company and its participating employers could have made matching contributions and/or an additional discretionary contribution, at its discretion. All contributions were subject to limitations as provided in the Code and as defined in the Plan.

#### 2. Description of Plan (continued...)

##### *Plan termination*

The Company was dissolved in July 2007, and contributions to the Plan have been suspended. The Plan, however, has not been officially terminated. The Plan's administrator has the right to terminate the Plan subject to the provisions of ERISA. Participants are 100 percent vested in their accounts. During 2024, participant accounts were liquidated and are being transferred to Individual IRA accounts.

##### *Participant accounts*

Each participant's account is credited with the participant's contributions and the Company's matching contributions, as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### *Vesting*

The Company was dissolved in July 2007, and all participants are 100% vested in their accounts.

##### *Notes receivable from participants*

The Company was dissolved in July 2007, and participants may no longer borrow from their accounts. The outstanding loans are secured by the balance in the participant's account and will be deemed distributed upon distribution of the participant's account. Contributions to the Plan have been suspended and interest is no longer being paid or accumulating on outstanding loans.

##### *Payment of benefits*

All participants may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account.

In the event of a participant's death, his or her designated beneficiary may request a distribution of his or her account.

Withdrawals made in conjunction with IRS hardship distribution regulations are not permitted by the Plan.

##### *Forfeited accounts*

Since all participants are 100% vested in their accounts, there are no forfeited account balances.

#### 3. Summary of Accounting Policies

##### *Basis of Accounting and Use of Estimates.*

The financial statements of the Plan are prepared on the accrual basis of accounting. The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect the reported amounts and disclosures. Actual results could differ from those estimates.

##### *Investment Valuation and Income Recognition.*

Plan investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes gains and losses on investments purchased and sold as well as held during the year.

##### *Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024, or 2023. Delinquent participant loans are recorded as distributions based upon the terms of the Plan documents.

##### *Payment of Benefits*

Benefits are recorded when paid, except for material corrective distributions which are accrued during the year in which the originating contributions were made. The Plan does not accrue non-distributed benefits related to participants who have withdrawn from the Plan.

##### *Expenses.*

Plan expenses paid directly by the Company are excluded from these financial statements. Fees charged directly to participant accounts are included in administrative expenses. Investment-related expenses are included in net appreciation of the fair value of investments.

##### *Subsequent Events*

Plan management has evaluated events and transactions that occurred between December 31, 2024, and October 13, 2024, which is the date that the financial statements were available to be issued, for possible recognition or disclosure in the financial statements.

#### 3. Information Certified by the Plan Custodian

Plan management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, all investments and notes receivable from participants reported in the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, and the supplemental Schedule H, Line 4(i) - Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity reported in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024 has been reported to the Plan and certified as complete and accurate by the Plan's custodian, Charles Schwab Bank.

#### 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under Topic 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

#### 4. Fair Value Measurements (continued...)

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024, and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective Trust Funds: Valued at the NAV of the units held by the Plan at year-end. The NAV, as provided by the trustee/custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (issuances and redemptions) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require advance notification to ensure that securities liquidations will be carried out in an orderly business manner as discussed below.

Schwab Value Advantage Money Mkt: Valued at a NAV of \$1. This fund seeks the highest current income consistent with stability of capital and liquidity. To pursue its goal, the fund invests in high-quality, short-term money market instruments issued by U.S. and foreign issuers. Examples of these securities include commercial paper, certificates of deposit, repurchase agreements, variable-rate debt securities, and obligations issued by the U.S. government or its agencies and instrumentalities. For more information concerning the fund’s investment objective, strategy, and risks, please see the fund’s prospectus.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### 5. Investments Recorded at Contract Value

The Plan did not hold any investments recorded at contract value as of December 31, 2024, and 2023.

#### 6. Rollover Contributions

The Plan accepted a rollover, provided the rollover did not jeopardize the tax-exempt status of the Plan or create adverse tax consequences for the Employer. The amounts rolled over were separately accounted for in a "Participant's Rollover Account." For purposes of this Section, the term Participant included any Eligible Employee who was not yet a Participant.

#### 7. Related-Party Transactions and Party-in-Interest Transactions

Certain Plan investments are shares of mutual funds held by Charles Schwab Bank, the custodian, as defined by the Plan. Fees incurred within these investments qualify as party-in-interest transactions. Investment fees paid to parties-in-interest are netted against investment returns.

During 2024, fees were also paid to Future Benefits of America, James E. Baiers, and Morgan Stanley for their advisory and administrative services to the Plan. These fees include investment fees, third party administrative fees, and other professional service fees, and are based on customary charges as agreed upon by the Plan. These transactions qualify as party-in-interest transactions for which there is a statutory exemption.

#### 8. Tax Status

Although the Company was dissolved in July 2007 and contributions to the Plan have been suspended, the Plan adopted a pre-approved Prototype Plan. The Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believes that the Plan is qualified, and is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS/DOL. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions.

#### **9. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

#### **10. Reconciliation of Financial Statements to Form 5500**

Certain differences may exist between the recording of accruals for financial reporting purposes and IRS/Department of Labor's (DOL) Form 5500 purposes. There were no such differences as of and for the years ended December 31, 2024, and 2023.

#### **11. Termination of the Plan**

The Company was dissolved in July 2007 and contributions to the Plan have been suspended. The Plan, however, has not been officially terminated. The Plan's administrator has the right to terminate the Plan subject to the provisions of ERISA. Participants are 100 percent vested in their accounts.
