We have performed audits of the financial statements of the ImpactLife 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

### Opinion

#### Note 1. Plan Description

The following brief description of the ImpactLife 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for more complete information.

**General:** The Plan is a defined contribution plan covering substantially all employees of ImpactLife (the Company) who have completed one month of service and who are 18 years of age or older. Employees who have met the eligibility requirements can enter the Plan on the first day of the next month for elective deferral and matching contributions. A participant must also complete one year of service with at least 1,000 hours of service and be employed on the last day of the Plan year to receive an allocation of the employer discretionary contribution. Employees who have met this eligibility requirement for the employer discretionary contribution will enter the Plan quarterly on January 1, April 1, July 1 and October 1. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Human Resources Committee is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings, monitors investment performance.

**Contributions:** Participants may contribute up to, but not more than, 85% of their wages, as defined by the Plan, in the form of a payroll deduction. The Plan includes an automatic deferral feature, with a deferral percentage of 6%, unless the employee opts out of this feature. Also, effective annually on February 1, the elective deferral amount of all participants who have an automatic deferral amount or whose elective deferral percent is less than 20% shall be increased by 1% per year until either their deferral amount reaches 20% of eligible compensation or the participant affirmatively opts out. This provision shall not apply to those participants who have made a contrary election within the 12 months immediately preceding the initial automatic increase, have made a specific dollar election or have previously declined the automatic increase option. Contributions are subject to certain IRS limitations.

In addition, the Company makes matching contributions of 100% of the first 4% of eligible compensation that a participant contributes to the Plan. The Plan also allows the Company to make a discretionary contribution, which is determined annually by the Company's board of directors. No discretionary contribution was made for the year ended December 31, 2024.

Participants aged 50 or over before the end of the Plan year are eligible to make catch-up contributions as permitted under current tax law. Participants may also contribute amounts representing distributions from other qualified plans (rollover contributions).

**Participant accounts:** Each participant's account is credited with the participant's contribution, the employer matching contributions, the employer discretionary contribution and an allocation of plan earnings. Participant accounts are charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Participant-directed investments:** The Plan allows each participant to select their own investment mix in which to invest their salary deferral and employer contributions. Participants can make changes to their investment mix on a daily basis. If a participant does not make investment elections, their funds are deposited into the appropriate target date fund.

#### Note 1. Plan Description (Continued)

**Payment of benefits:** Upon termination of service, death, or retirement, a participant may elect to receive an amount equal to the value of their vested account balance in a lump-sum payment, installments or a combination of lump-sum payments and installments. If the participant's vested account balance does not exceed \$1,000, then the participant will receive their benefit in a lump-sum payment. In the event of a mandatory distribution for participants with vested account balances greater than \$1,000, but less than \$5,000, their benefit will be rolled over to an individual retirement account (IRA). The Plan also allows for hardship withdrawals that meet safe harbor requirements defined in the Plan document and for in-service distributions by participants after age 59½.

**Vesting:** Participants are immediately vested in their voluntary contributions and actual earnings thereon. Vesting in the employer matching contributions, employer discretionary contribution and earnings thereon is based on years of service. The participant is 0% vested for less than two years of credited service and then vests 20% per year of credited service until they are 100% vested after six years of credited service. Participants become 100% vested the later of the date upon reaching normal retirement age of 65 or the sixth anniversary of the year in which the participant commenced participation in the Plan if still an active employee.

**Notes receivable from participants:** Participants may borrow from their accounts a minimum of \$1,000 and up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. These transactions are treated as transfers between the investment fund and the participant notes receivable fund. The terms of the notes receivable range from one to five years. The notes receivable are secured by the balance in the participant's account and bear interest at rates commensurate with local prevailing rates as determined by the Plan Administrator. The interest rates ranged from 8.75% to 9.50% for all outstanding loans at December 31, 2024. Principal and interest are paid ratably through payroll deductions.

Notes receivable from participants have been classified as an investment asset for Form 5500 reporting purposes and, accordingly, have been included as an investment in the supplemental schedule, schedule H, line 4i—schedule of assets (held at end of year).

**Forfeitures:** Forfeitures of terminated participants' nonvested employer portion of their accounts are used to reduce future employer contributions. Forfeitures used to reduce employer contributions were \$391,812 for the year ended December 31, 2024. Unused forfeitures included in net assets available for benefits were \$6,067 and \$6,501 as of December 31, 2024 and 2023, respectively.

#### Note 2. Summary of Significant Accounting Policies

**Basis of accounting:** The accompanying financial statements are prepared on the accrual basis of accounting.

**Contributions:** Contributions from Plan participants and the contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation.

**Use of estimates:** The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

#### Note 2. Summary of Significant Accounting Policies (Continued)

**Investment valuation and income recognition:** Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Human Resource Committee determines the Plan's valuation policies utilizing information provided by the trustee. See Note 6 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

**Notes receivable from participants:** Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable are treated as distributions based on the terms of the Plan document. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024.

**Expenses:** Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

**Payment of benefits:** Benefits are recorded when paid.

**Subsequent events:** The Plan Administrator has evaluated subsequent events through September 22, 2025, the date the financial statements were available to be issued.

#### Note 3. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

#### Note 4. Tax Status

The Plan has adopted a preapproved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the preapproved plan document was in compliance with applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since adopting the preapproved plan document; however, the Plan Administrator believes the Plan is designed, and is being operated, in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **Note 6. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means

If the asset or liability has a specified contractual term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

#### Note 6. Fair Value Measurements (Continued)

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Common collective trust funds:** One of these investments is a stable value fund managed by Galliard as of December 31, 2024 and 2023, that invests primarily in fully benefit-responsive investment contracts and is valued at the net asset value (NAV) of units of the collective trust. The other investments are collective investment trusts managed by Principal that invest primarily in collective investment trusts, mutual funds and pooled separate accounts managed by Principal. The NAV is used as a practical expedient to estimate fair value for all of these funds. This practical expedient would not be used if it is determined to be probable that investments would be sold for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of any of the collective trust funds, the issuer reserves the right to require 12 months notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

**Mutual funds:** Valued based on unadjusted quoted prices in the active markets in which they are traded. The following tables set forth by level, within the fair value hierarchy, the Plan's investments at fair value as of December 31, 2024 and 2023:

#### **Note 7. Related-Party and Party-in-Interest Transactions**

Certain Plan investments are managed by Principal. Principal is the plan trustee as defined by the Plan; therefore, transactions with investments managed by the trustee qualify as party-in-interest transactions. Administrative fees paid to Principal during the year ended December 31, 2024, were approximately \$89,000, and fees paid to Morgan Stanley (a plan consultant) were approximately \$59,000.

#### **Note 8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the 2024 statement of net assets available for benefits.
