Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Gold Coast Baking Company, LLC 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). A. DESCRIPTION OF PLAN:

The following description of Gold Coast Baking Company, LLC 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

1. General - The Plan is a defined contribution plan, established on January 1, 1998. The Plan was established for the exclusive benefit of employees of Gold Coast Baking Company, Inc. and related entities (the Employer) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Employer is responsible for oversight of the Plan.
2. Amendments - During 2022, the Plan was amended to change its name to Gold Coast Baking Company, LLC 401(k) Profit Sharing Plan, formerly known as Gold Coast Baking Company, Inc. 401(k) Profit Sharing Plan.
3. Eligibility - Employees, excluding nonresident aliens and residents of Puerto Rico, who have reached the age of 18 and completed one month of service (190 hours) are eligible to participate in the Plan and are eligible for the salary deferral and Employer discretionary match. Participants that have completed one year of service are eligible for the discretionary profit sharing contribution. The employee enters all contribution portions on the completion of the eligibility requirement.
4. Contributions - The annual amount that a participant may elect as 401(k) contributions is limited to the amount designated by the Secretary of the Treasury pursuant to the limits on elective deferrals under the Code Section 402(g). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. These contributions are reported as participant contributions on the statement of changes in net assets available for benefits.

The Employer may make a discretionary matching contribution to the Plan. They may also make a discretionary profit sharing contribution that is determined annually. For the years ended December 31, 2024 and 2023, the Employer matched 25% of the participants deferral up to 50% of eligible compensation for eligible participants that were employed on the last day of the Plan year. For the years ended December 31, 2024 and 2023, the Employer did not make a discretionary profit sharing contribution.

The Plan also permits rollover contributions from other tax qualified plans or accounts, upon approval of the plan administrator.

5. Participant Accounts - Each participant's account is credited with (a) the participant's elective deferral contribution, (b) an allocation of the individual Employer discretionary matching and/or profit sharing contribution (if eligible), and (c) plan earnings on investments based on the participant's account balances.
6. Vesting - The participants' contributions and earnings thereon are fully vested at all times. Under normal vesting circumstances employer contributions and earnings thereon are 20% vested after a full year of service, as defined, and continue to vest at the rate of 20% for each successive year of service until 100% vested after 5 years of service, attaining normal retirement age, death, or disability.
7. Notes Receivable from Participants - A participant may borrow from the Plan up to one-half of the present value of their non-forfeitable accrued benefit in an amount not to exceed \$50,000. The loans shall bear interest at a reasonable rate as determined by the plan administrator over a period not to exceed five years. If the loan is used to acquire a principal residence, the trustee may allow a longer repayment period not to exceed 30 years. A participant may have only one loan outstanding at a time for any reason.

A. DESCRIPTION OF PLAN: (Continued)

8. Payments of Benefits - Upon termination of service due to death, disability, or retirement, a participant may receive the value of the vested interest in their account in the form of a lump-sum distribution or installment payments. The Plan allows for in-service distributions if a participant reaches 65 and military distributions subject to Plan provisions. If a participant terminates employment and the participant's account balance does not exceed \$5,000, the Plan administrator will authorize the benefit payment without the participant's consent.
9. Forfeitures - Any forfeiture that takes place during the year is used to either reduce administrative expenses or to reduce any future employer contributions under the Plan. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$7,910 and \$5,191, respectively. There were no forfeitures used to reduce Employer contributions for the years ended December 31, 2024 and 2023. There were no forfeitures used to pay administrative expenses for the years ended December 31, 2024 and 2023.

B. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:

1. Basis of Accounting - The financial statements of the Plan are prepared using the accrual basis of accounting.
2. Use of Estimates - The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.
3. Investment Valuation and Income Recognition - The Plan's investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

4. Benefit Payments - Benefit payments are recorded when paid.
5. Administrative Expenses - Certain expenses of maintaining the Plan are paid directly by the Plan or the Employer, as provided by the Plan document. Expenses paid directly by the Employer are excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefit payments are charged directly to the participant's account and are included in administrative expense. Investment related expenses are included in net appreciation of fair value of investments.

C. INFORMATION CERTIFIED BY THE TRUSTEE (UNAUDITED):

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974.

Transamerica Trust Company, the qualified institution of the Plan through December 31, 2024, has certified to the completeness and accuracy of notes receivable from participants and investment information reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.

D. FAIR VALUE MEASUREMENTS:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurements.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for the assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual Funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Money Markets - The money market fund held by the Plan is a government money market fund. The fund seeks to maintain a constant NAV of \$1 per share by investing in high-quality, U.S. dollar denominated money market securities issued by the U.S. government and its agencies and instrumentalities.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

E. INVESTMENT CONTRACT WITH INSURANCE COMPANY:

The Plan's group annuity investment contract with Transamerica Life Insurance Company Inc. is considered fully benefit-responsive and is recorded at contract value.

The account is credited with earnings based on the underlying investments and charged for participants withdrawals and administrative expenses. The contract value at December 31, 2024 and 2023 was zero.

Net deposits invested in the investment contract become part of Transamerica Life Insurance Company Inc.'s general account. Contract value is guaranteed by the full faith and credit of Transamerica Life Insurance Company Inc. The Plan's ability to receive amounts due in accordance with fully benefit-responsive contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the contract issuer, but there is no stated minimum or maximum. The crediting interest rate is reset twice per year. The contract cannot be terminated before the scheduled maturity date.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Company, or (4) the failure of the trust to qualify for exemption from Federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with the plan participants are probable of occurring.

In addition, certain events allow the contract issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include the following: (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreements without the consent of the contract issuer.

F. NOTES RECEIVABLE FROM PARTICIPANTS:

Loans to participants are reported at their unpaid principal balances plus any accrued but unpaid interest. At December 31, 2024 and 2023, outstanding notes receivable were \$52,102 and \$62,898, respectively.

G. TAX STATUS:

The Plan is placing reliance on an opinion letter dated June 30, 2020 received from the IRS on the prototype plan indicating that the Plan is qualified under Section 401 of the Internal Revenue Code (IRC) and is, therefore, not subject to tax under current income tax law. The prototype plan has been amended since receiving the opinion letter. However, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Company has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

H. PLAN TERMINATION:

The Employer has stated its intent to continue the Plan indefinitely; however, continuation of the Plan is voluntary on the part of the Employer, and the Employer reserves the right to modify or terminate the Plan at any time. In the event of Plan termination, participants will remain 100% vested in their accounts, net of any expenses necessary to terminate the Plan.

I. RISKS AND UNCERTAINTIES:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

J. PARTY-IN-INTEREST TRANSACTIONS:

The Plan allows for transactions with certain parties who may perform services or have fiduciary responsibilities to the Plan. Certain Plan investments are managed by Transamerica Life Insurance Company Inc., the custodian and recordkeeper of the Plan. The Plan paid \$25,173 and \$23,300 in contract administration fees during 2024 and 2023, respectively. The Plan issues loans to participants, which are secured by the balances in the participants' accounts. The Company paid certain administrative expenses of the Plan, including recordkeeping and audit fees. These transactions qualify as party-in-interest transactions for which a statutory exemption exists.

In connection with a fee sharing arrangement with Transamerica Life Insurance Company Inc., the Plan received \$33,887 in fee reimbursements and credits. During 2024, zero was used to offset Plan expenses. The Plan has credits of \$23,338 and \$12,484 available to offset future Plan expenses as of December 31, 2024 and 2023, respectively.

L. PROHIBITED TRANSACTIONS:

During the Plan year ended December 31, 2019, the plan sponsor inadvertently failed to deposit \$8,305, of participant deferrals and repayments on notes receivable within the required timeframe as stated by Employee Retirement Income Security Act of 1974 (ERISA). These deferrals and repayments on notes receivable were deposited beyond the earliest expected date on which assets could be segregated from the employer's assets. The U.S. Department of Labor considers late deposits to be prohibited transactions.

The plan sponsor will calculate lost earnings on these deferrals and repayments on notes receivable and deposit them into the Plan. The plan sponsor will self-correct these prohibited transactions and does not believe that these issues will have a material impact on the Plan's net assets available for benefits or the Plan's tax status.

M. SUBSEQUENT EVENTS:

Management has evaluated events occurring after the statement of net assets available for benefits date through October 13, 2025, the date on which the financial statements were available to be issued. No material events have been identified which would require disclosure.
