Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Planned Parenthood 403(b) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Basis for Opinion

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

NOTES TO FINANCIAL STATEMENTS

1. Description of Plan

The following brief description of Planned Parenthood 403(b) Plan (“the Plan”) is provided for general information purposes only. Participants should refer to the Plan’s agreement for a more complete description of the Plan’s provisions.

General

The Plan is a 403(b) tax-deferred annuity plan covering all employees except temporary employees of Planned Parenthood: Shasta-Diablo dba Planned Parenthood Northern California (“PPNorCal”). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”) and Section 403(b) of the Internal Revenue Code (“IRC”). PPNorCal is the plan sponsor and serves as the plan administrator.

Contributions

Participants may contribute any percentage or set dollar amount of their annual compensation, as defined in the Plan, up to the maximum limit as permitted by IRC. Participants may also contribute amounts representing distributions from other retirement plans. Additionally, participants qualifying for age-based provisions may contribute additional catch-up contributions. Participants direct the investment of their contributions into various investment options offered by the Plan and may change their investment option at any time. For the year ended December 31, 2024, employees who had completed one year of service and at least 1,000 hours were eligible to receive matching contributions of 100% of the first 3% plus an additional 50% of the next 2% of compensation that a participant contributes to the plan.

Participant Accounts

Each participant’s account is credited with the participant’s contributions, employer contributions, and the Plan earnings. Allocations are based on account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are fully vested, at all times and in all events, in their salary deferral and employer contribution plus actual earnings thereon. Such amounts are non-forfeitable.

Notes Receivable from Participants

Participants may borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The maximum loan term is five years, although it may be up to fifteen years for the purchase of a primary residence. The loans are secured by the balance in the participant’s account and bear a reasonable interest rate. Principal and interest are paid ratably through semi-monthly payroll deductions.

1. Description of Plan, continued

Payment of Benefits

In general, on termination of service due to death, disability, retirement, or other reasons, a participant may elect to receive either a lump-sum amount equal to the fair value of the participant's account balance or monthly, quarterly, or annual installments over a period of not more than his or her assumed life expectancy (or the participant's beneficiary's assumed life expectancy). A participant may also elect to transfer to an individual retirement arrangement or another qualified employer plan.

2. Summary of Significant Accounting Policies

The following are the significant accounting policies followed by the Plan:

Basis of Presentation

The financial statements of the Plan are reported on the accrual basis of accounting.

Investments Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and (losses) on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants represent participant loans that are recorded at their unpaid balance. Interest income on notes receivable from participants is recorded when it is earned, and the related fees are recorded as administrative expenses and expensed when incurred.

Payments of Benefits

Benefits are recorded when paid.

Fair Value Measurements

Generally accepted accounting principles provide guidance on how fair value should be determined when financial statement elements are required to be measured at fair value. Valuation techniques are ranked in three levels depending on the degree of objectivity of the inputs used with each level:

Level 1 inputs – quoted prices in active markets for identical assets

Level 2 inputs – quoted prices in active or inactive markets for the same or similar assets

Level 3 inputs – estimates using the best information available when there is little or no market

The Plan is required to measure certain investments at fair value. The specific techniques used to measure fair value for the financial statement element is described in the notes below that relates to the element.

2. Summary of Significant Accounting Policies, continued

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures as of and for the period presented. Actual results could differ from those estimates.

3. Notes Receivable from Participants

Principal and interest is paid ratably through semi-monthly payroll deductions, at interest rates from 3.25% to 8.50%, with various maturities. Notes receivable from participants outstanding at December 31, 2024 and 2023, were \$326,370 and \$199,956, respectively.

4. Information Prepared and Certified by the Custodian

No auditing procedures were performed on investments and interest income as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

The following summarizes the information certified by Reliance Trust Company, the custodian of the Plan, as of December 31, 2024 and 2023, respectively:

The Plan invests in a fully benefit-responsive unallocated insurance contract issued by Standard Insurance Company, which is reported at contract value, representing contributions made plus interest credited, less withdrawals and expenses. Participant transactions occur at contract value. The annualized crediting rate was 3.04% for 2024 and 2.78% for 2023, reset quarterly. Plan-level events (such as termination or significant workforce reductions) may limit transactions at contract value; no such events are considered probable as of December 31, 2024. The issuer may settle at other than contract value in such cases, but these events are not considered probable at year-end.

7. Related Party and Party-in-Interest Transactions

ERISA defines parties-in-interest more broadly than generally accepted accounting principles' related parties, encompassing all service providers to the Plan. Management identified no related parties that were not also parties-in-interest, and no material related party transactions occurred during the Plan year regarding compensation arrangements, expense allowances, or similar items.

Parties-in-interest transactions include those with Plan fiduciaries or employees, service providers, employers with covered employees, employee organizations with covered members, and persons owning 50% or more of such employers or employee associations, along with their relatives. Trustee transactions, including revenue sharing and fee offset agreements, as well as the Plan's payment of certain plan fees and expenses, qualify as parties-in-interest transactions. Administrative fees paid by the Plan to the trustee were \$95,217.

The Plan's investment options include funds managed by Reliance Trust Company, serving as custodian, or Standard Retirement Services, Inc. and its affiliates, serving as third-party administrator and recordkeeper. Transactions with these entities qualify as exempt parties-in-interest transactions under ERISA.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risk. It is reasonably possible, given the level of risk associated with certain investment securities that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

The Plan's exposure to a concentration of credit risk is limited by diversification of investments across various assets classes and the utilization of investment managers.

9. Plan Termination

Although it has not expressed any intent to do so, PPNorCal has the right under the Plan to discontinue its contribution at any time and to terminate the Plan, subject to the provisions of ERISA.

10. Tax Status

The Plan has been designed to qualify under Section 403(b) of the IRC. The terms of the Plan have been prepared to conform with the sample language provided by the Internal Revenue Service ("IRS") in Revenue Procedure 2007-71. The Plan is required to operate in conformity with IRC to maintain the tax-exempt status for plan participants under Section 403(b).

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress. The plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

11. Subsequent Events

Subsequent to December 31, 2024, the Plan was amended, effective January 1, 2025, to revise provisions related to distribution payouts for terminated participants with small account balances, increase catch-up contribution limits for participants aged 60 to 63, expand eligibility to allow certain long-term, part-time employees to make elective deferrals (without employer contributions), and update the timing of benefit payments and required minimum distributions. These amendments do not impact amounts reported as of December 31, 2024, but represent material changes to Plan provisions effective in the 2025 Plan year.

Management has evaluated subsequent events through October 8, 2025, the date which the financial statements were available for issue. Other than the events described above, no other events or transactions have occurred during this period that would require recognition or disclosure in the financial statements.
