Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Honolulu Freight Service 401(k) Plan and Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. Responsibilities of Management for the Financial Statements

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the Honolulu Freight Service 401(k) Plan and Trust (the "Plan") is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

A. General

The Plan is a defined contribution plan established January 1, 1992 to provide retirement benefits to all non-collectively bargained employees of the following employers: Honolulu Freight Service, Inc., Inter-City Delivery Service, Inc., Seattle Port Consolidators, Inc., United Drayage, Inc., Allstate Transport, Inc., and Guam Freight Service, Inc. (the "Company"). The Plan is intended to qualify under Section 413(c) of the Internal Revenue Code (the "Code") as a multiple employer plan. The plan administrator believes the Plan is designed and operated in compliance with applicable provisions of the Code and provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

B. Administration and Expenses

John Hancock Life Insurance Company ("John Hancock") serves as custodian of Plan assets and maintains participant accounts under pooled separate account investments that provides for commissions and record keeping fees to be charged to Plan investment funds. Such fees are factored into each fund as a reduction in investment return. In addition to these charges, the Plan paid contract administration, administrative and investment advisory fees totaling \$118,796 in 2024.

C. Eligibility

Employees covered by a collective bargaining agreement and employees who are ineligible for employer provided fringe benefits are specifically excluded from the Plan. All other employees who have attained age 21 and completed 6 months of service are eligible to participate in the Plan. Plan entry is the first day of the Plan year or the first day of the seventh month of the Plan year coinciding with or next following the date that eligibility requirements are satisfied.

D. Participant Contributions

Participants may elect to contribute from 1% to 50% of compensation, as defined in the Plan, up to the maximum allowed under applicable provisions of the Code. Participants of age 50 or older may make additional catch-up contributions. Newly eligible employees who do not make an affirmative election to defer compensation to the Plan, including an election not to defer, are auto-enrolled in the Plan at a pre-tax deferral rate of 3%. The deferral rate of auto-enrolled participants who do not make an alternative election will increase by 1% in successive years to a maximum of 6%.

Participants are also allowed to make rollover contributions of amounts received from other tax-qualified retirement plans. Such contributions are deposited in the appropriate investment funds in accordance with participant directions.

E. Company Contributions

The Plan provides for employer discretionary matching contributions and discretionary employer profit sharing contributions. All participating employers matched at various rates during the 2024 Plan year. The Company did not elect to make discretionary profit-sharing contributions for 2024.

F. Participant Accounts

Each participant's account is credited with the participant's contributions, rollovers, Company contributions and an allocation of Plan earnings or losses and expenses. Participants direct the investment of their accounts among diversified menu of mutual funds maintained by John Hancock in pooled separate accounts. The accounts of participants who decline to make an investment election are invested in American Funds target date maturity fund appropriate for a participant's age and projected retirement date.

G. Vesting

Participants are immediately 100% vested in their contributions, Company contributions and related earnings.

H. Payment of Benefits

Normal retirement age under the Plan is age 65. Upon termination of service, death, disability, attainment of age 59½ or retirement, a participant or beneficiary may maintain his or her account in the Plan or receive benefits payable in a lump sum. Hardship distributions are permitted under limited circumstances as defined in the Plan subject to approval of the plan administrator. Benefits are recorded when paid.

I. Notes Receivable from Participants

The Plan allows participants to borrow not less than \$1,000 and up to the lesser of \$50,000 or 50% of their vested account balance. A loan is secured by a participant's account balance, bears interest at a fixed rate based on available market financing rates at loan inception and must be repaid to the Plan within a five-year period, unless a loan is used for the purchase of a principal residence in which case the maximum repayment period may be extended. The plan administrator approves the specific terms and conditions of each loan. Principal and interest are paid ratably through payroll deductions. Participant loans outstanding at December 31, 2024 carry interest rates ranging from 4.25% to 9.50%, maturing through 2052. Notes receivable are measured at their unpaid principal balance plus accrued interest. Delinquent notes are recorded as distributions based on the terms of the Plan document.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

B. Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

C. Investment Valuation and Income Recognition

Investments held by an employee benefit plan are required to be reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of investments are recorded on the trade-date basis. Net appreciation includes gains and losses on investments bought and sold as well as held during the year.

D. Risks and Uncertainties

Plan investments are exposed to various investment risks such as interest rate, market and credit risks. Due to the level of risk associated with investments, least reasonably possible that changes in the value of investments, occur in the near term and such changes could materially affect participant accounts and amounts reported in the financial statements.

NOTE 3 - RELATED-PARTY TRANSACTIONS

Plan investments in pooled separate accounts are issued by John Hancock Life Insurance Company, the custodian. Transactions related to investments and payment of administrative expenses to Plan service providers by the Plan are considered party-in-interest transactions under ERISA regulations. Such transactions are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

NOTE 4 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to provisions of ERISA. The accounts of participants affected by a partial or complete termination of the Plan are non-forfeitable and will be determined as of the termination date.

NOTE 5 - INCOME TAX STATUS

The Company adopted a volume-submitter plan that has received an opinion letter from the Internal Revenue Service stating the form of the Plan qualifies under applicable provisions of the Code. The Company believes the Plan is operated in accordance with and qualifies under applicable requirements of the Code and related state statutes and the trust, which forms a part of the Plan, is exempt from federal income taxes.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 6 - FINANCIAL INFORMATION CERTIFIED BY THE CUSTODIAN

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information related to investments disclosed in the accompanying financial statements and



