We have performed audits of the financial statements of Safe Harbor 401(k) Profit Sharing Plan for Employees of Supportive Behavioral Resources, Inc. (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). (1) Description of Plan

The following brief description of Safe Harbor 401(k) Profit Sharing Plan for Employees of Supportive Behavioral Resources, Inc. (the Plan), provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan sponsored by Supportive Behavioral Resources, Inc. (the Company) for the benefit of its employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Governance Committee is responsible for oversight of the Plan, determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Contributions

Participants may contribute amounts from their compensation as pre-tax or Roth contributions, as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Additionally, participants age 50 or older, who are making contributions to the Plan, are allowed to make catch-up contributions as defined in the Plan. For participants age 21 years or older who have completed one year of service and have worked at least 1,000 hours, the Company contributes 100% of the first 4% of base compensation that a participant contributes to the Plan. Additional amounts may be contributed at the option of the Company.

The Plan includes an auto-enrollment function whereby all newly eligible participants and certain other employees as defined in the Plan are automatically enrolled in the Plan unless they elect otherwise. The deferral percentage for auto-enrolled employees is set at a fixed rate of 1% of the employee's compensation and increases annually by 1% up to a maximum of 4%. Contributions are subject to applicable Internal Revenue Code (IRC) limitations.

Effective July 1, 2024, the Plan was amended to remove the age and service requirements for elective deferrals, including Roth contributions, allowing employees to begin contributing immediately upon hire.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of: (a) the Company's contribution and (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant contributions or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participant and employer contributions are 100% vested at all times under the Plan.

(1) Description of Plan, Continued

Payment of Benefits

Upon termination of service, death, or qualifying instances of hardship, a participant or his or her beneficiary(ies) may elect to receive payment in a lump sum equal to the value of the participant's vested interest in his or her account. Balances under \$5,000 for terminated employees may be distributed in a lump sum at the discretion of the Company.

(2) Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value, except for the interest accumulation account, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan administrator determines the Plan's valuation policies utilizing information provided by the Plan's custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from plan participants and contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

Excess Contributions

Amounts payable to participants for excess contributions are recorded as a liability with a corresponding reduction to contributions.

(2) Summary of Significant Accounting Policies, Continued

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of the Plan are paid by the Company and are not included in the statement of changes in net assets available for benefits. Investment-related expenses are included in net appreciation in fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through October 8, 2025, the date the financial statements were available to be issued.

(3) Certified Financial Information

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments at fair value and contract value held at December 31, 2024 and 2023, and net appreciation in fair value of investments and other investment income for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Mutual of America Life Insurance Company (Mutual of America), a qualified institution.

(4) Fair Value Measurements

Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include
 - quoted prices for similar assets or liabilities in active markets;
 - quoted prices for identical or similar assets or liabilities in inactive markets;

(4) Fair Value Measurements, Continued

- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled separate accounts: Valued at the Net Asset Value (NAV) of units of the separate account. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The Plan's accounts provide a cumulative record of the number of units credited to the account and the number of units allocated or withdrawn from the account. The balance of the Plan's units multiplied by the unit value equals the Plan's pooled separate account balance. The unit value is based upon the quoted market values of the underlying assets in the account. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the separate account, the investment advisor reserves the right to temporarily delay withdrawal from the account in order to ensure that securities liquidations will be carried out in an orderly business manner.

The Plan's investments in pooled separate accounts that were measured at NAV per share are not required to be classified in the fair value hierarchy. The following table summarizes the investments measured at fair value based on the NAV per share as a practical expedient as of December 31, 2024 and 2023:

(5) Contract with Insurance Company

The Plan offers an Interest Accumulation Account option with a group annuity contract through Mutual of America. Mutual of America maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed by the Plan. The crediting interest rate is based on a formula established by the contract issuer. The contract account balance is reviewed on a daily basis and used to determine the applicable interest rate credit to only amounts held in the Interest Accumulated Account. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by the participants if they were to initiate permitted transactions under the terms of the plan. Contract value, as reported to the Plan by Mutual of America, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment contract at value.

(6) Related Party Transactions and Party-in-Interest Transactions

Certain Plan investments are managed by Mutual of America; therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for investment management services are included in net appreciation in fair value of investments. The Plan paid recordkeeping fees to the third-party administrators of \$1,695 for the year ended December 31, 2024.

(7) Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

(8) Nonexempt Transactions

During 2022 through 2024, the Company failed to remit to the Plan certain employee contributions totaling approximately \$73 within the period prescribed by DOL regulations. The Company intends to compensate the affected participants for lost earnings resulting from the delay in contributions in 2025.

(9) Tax Status

The Internal Revenue Service (IRS) has determined that the prototype 401(k) profit sharing plan is designed in accordance with applicable sections of the IRC and informed Mutual of America Financial Group of such in a letter dated November 30, 2020. The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(10) Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
