**Note 1. Description of the Plan.**

The following description of the Alpena Supermarket, Inc. ("the Company") 401(k) Savings Plan and Trust ("the Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

***General***

The Plan Sponsor established the Plan effective January 1, 1992. The Plan is a defined contribution plan covering all employees of the Company who have completed one year of service, minimum 1,000 hours, and are age twenty-one or older, except those employees acquired as part of a Code §410(b)(6)(C) transaction who become eligible as of the date of the transaction (unless otherwise excluded). The Plan is subject to the provisions of the Employee Retirement Income and Security Act of 1974 (ERISA).

Once an employee has satisfied the eligibility conditions, they can enter the plan on one of the quarterly entry dates each year.

The Plan is not subject to the automatic enrollment provisions of the SECURE 2.0 Act, which apply only to new retirement plans established after December 29, 2022. As the Plan was established prior to that date, the Plan Sponsor is not required to implement automatic enrollment and has not elected to do so.

***Employee Contributions***

Each year, participants may contribute up to the maximum amount permitted by law of pretax annual compensation, as defined in the Plan (limited to \$23,000 in 2024 and \$22,500 in 2023). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing rollovers of eligible distributions from other qualified tax plans into the Plan. Participants that are permitted to make elective deferrals shall also be permitted to make Roth elective deferrals. Contributions are subject to certain IRS limitations.

***Employer Contributions***

Employer matching contributions are discretionary. The employer may contribute to the Plan a discretionary amount as determined by the employer's management. Employer matching contributions are allocated to participants who have made elective 401(k) contributions. There were no discretionary matching contributions made for the years ending December 31, 2024 or 2023.

***Participant Accounts***

Each participant's account is credited with the participant's contributions and allocations of the Company's discretionary contributions, rollover contributions, as well as Plan earnings and losses. Allocations are based on earnings or account balances, as defined. Fund investment expenses of the Plan are charged against the fund assets of the participant who is responsible for the expense. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan's investment options currently consist of twenty-four different mutual funds and a money market fund.

**Note 1. Description of the Plan.** *(continued)*

***Vesting***

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after five years of credited service for employer matching contributions.

***Participant Loans***

Participant loans are not permitted under the Plan.

***Payment of Benefits***

Upon termination of service due to retirement, disability, termination, or death, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Benefits are recorded when paid.

***Hardship Withdrawals***

Participants may request a distribution of all or a portion of their account balance in the case of an immediate and heavy financial need, as defined in the Plan document and applicable IRS regulations. Consistent with SECURE 2.0 provisions, the Plan may rely on a participant's written certification that the distribution is necessary to meet the financial need, unless the Plan Sponsor has actual knowledge to the contrary. Plan management must approve all hardship withdrawals in accordance with the Plan's provisions.

***Plan Termination***

Although it has not expressed any intent to do so, the Company has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Upon termination of the Plan, the participants become 100 percent vested in their account balances.

***Forfeited/Asset Holding Accounts***

As of December 31, 2024 and 2023, the Plan's Asset Holding Accounts totaled \$22,805 and \$19,181, respectively. These balances include amounts attributable to unclaimed property, plan net credits, and compensation recapture. Only the compensation recapture portion represents forfeited nonvested accounts, which may be used to reduce future employer contributions or to pay administrative expenses. For the years ended December 31, 2024 and 2023, administrative fees were reduced by \$11,396 and \$9,314 from forfeited nonvested accounts, respectively.

***Party-in-interest Transactions***

Certain Plan assets are in investment funds managed by Capital Research and Management Company (CRMC), for the period January 1, 2024 through December 31, 2024. Capital Bank and Trust Company is the trustee of the Plan. CRMC and Capital Bank and Trust Company are sister companies, both owned by The Capital Group Companies, Inc; therefore, these transactions qualify as party-in-interest transactions as defined under ERISA guidelines. The Plan incurred recordkeeping fees with Capital Bank and Trust Company for the plan year ended December 31, 2024.

Edward Jones receives direct compensation from the Plan as an investment advisor and W.L. Burmeister as a third-party administrator.

**Note 2. Summary of Significant Accounting Policies.**

***Basis of Accounting***

The accompanying financial statements of the Plan have been prepared in accordance with accounting principles generally accepted in the United States of America (generally accepted accounting principles).

***Investment Valuation and Recognition***

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividend income is recorded on the ex-dividend date. Interest income is recorded when earned.

Net appreciation or depreciation of investments is reported in the statement of changes in net assets available for benefits and consists of the realized gains and losses and unrealized appreciation or depreciation of these investments.

***Benefit Payments***

Benefits are recorded when distributions are made. Benefits are generally distributed to participants in a lump sum or direct rollover, in accordance with the provisions the Plan Document. Amounts reported as distributions payable at year end represent benefit checks that have been issued to participants but not yet cashed.

***Excess Contributions Payable***

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with corresponding reduction to contributions. There was no excess contributions payable balance as of December 31, 2024 or December 31, 2023.

***Expenses***

The Company pays certain administrative expenses of the Plan directly. Amounts paid by the Company are recorded in the accompanying financial statements as contributions for administrative expenses. For the year ended December 31, 2024, the Company paid administrative expenses of \$15,120 on behalf of the Plan. The Plan incurred \$11,781 of administrative expenses.

***Use of Estimates***

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that may affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

**Note 3. Information Prepared and Certified by Trustee.**

Effective June 24, 2010, the Plan executed a Trust Agreement accepting Capital Bank and Trust Company as trustee. The agreement confirms that the Capital Bank and Trust Company will be providing all trustee services for the Plan.

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Capital Bank and Trust Company has certified the completeness and accuracy of the investment information reflected in (1) the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, (2) the December 31, 2024 schedule of assets (held at end of year), and (3) the related investment activity reflected in the statement of changes in the net assets available for benefits during 2024. Only the portion of income certified by Capital Bank and Trust Company for 2024 and 2023 is included below.

**Note 4. Fair Value Measurements.**

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability (i.e., the "exit price") in an orderly transaction between market participants at the measurement date.

The Plan categorizes its fair value measurements of investments within the fair value hierarchy established by generally accepted accounting principles. The hierarchy is based on the valuation inputs used to measure the fair value of the asset. Level 1 inputs are quoted prices in the active markets for identical assets; Level 2 inputs are significant other observable inputs; Level 3 inputs are significant unobservable inputs.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

*Money market fund:* The fair value of money market funds approximates their carrying amounts due to the short-term nature of these financial assets and are classified as Level 1. Money market funds are valued at their net asset value.

*Mutual funds:* Shares held in and mutual funds are valued at quoted market prices that represent the net asset value (NAV) of shares held by the Plan at year end and are classified as Level 1. The NAV is based on the value of the underlying assets owned by the fund, less its liabilities, then divided by the number of shares outstanding. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily NAV and to transact at that price and, therefore, are deemed to be actively traded.

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period. Plan management evaluates the significance of transfers between levels based upon the nature of the financial instrument and size of the transfer relative to the total net assets available for benefits.

**Note 5. Tax Status.**

The IRS determined and informed the Plan Administrator, the master prototype sponsor of the Alpena Supermarket, Inc. Employees' 401(k) Savings Plan and Trust by a letter dated June 30, 2020, that it is designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter. The Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable provisions of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained by examination by the Department of Treasury Internal Revenue Service.

**Note 5. Tax Status.** *(continued)*

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2022.

**Note 6. Plan Amendments.**

Effective September 15, 2023, the Plan was amended so that employees acquired as part of a Code §410(b)(6)(C) transaction would become eligible employees as of the date of the transaction (unless otherwise excluded under AA §3-1 or this AA §3-2). The Plan will count service with all employers which have been acquired as part of the transaction under Code §410(b)(6)(C).

**Note 7. Recent Accounting Standards.**

The SECURE 2.0 Act of 2022 was signed into law on December 29, 2022. This legislation includes a wide range of changes to retirement plans, effective beginning in 2023 and extending into future years.

For the year ended December 31, 2023, the Plan implemented the mandatory increase in the required minimum distribution age to 73, eliminated pre-death required minimum distributions for Roth accounts and additional options for spousal beneficiaries. Effective January 1, 2024, the Plan adopted the increase in the mandatory cash-out limit, emergency withdrawals for certain unforeseen expenses, self-certification for hardship withdrawals, and penalty-free withdrawals in case of domestic abuse. In addition, effective January 1, 2025, the Plan will implement the increase in catch-up contribution limits and expand eligibility for long-term, part-time employees who meet required service conditions.

Management continues to evaluate other provisions of the SECURE 2.0 Act that become effective in later years. The adoption of these provisions has not had, and is not expected to have, a material effect on the Plan's financial statements.

**Note 8. Subsequent Events.**

In preparing these financial statements, Plan management has evaluated, for potential recognition or disclosure, significant events or transactions that occurred during the period subsequent to December 31, 2024, the most recent statement of net assets available for benefits presented herein, through the date of the Independent Auditor's Report, the date these financial statements were available to be issued. No significant events or transactions were identified.
