### Report on the Audit of the Financial Statements

**NOTE 1 DESCRIPTION OF PLAN**

The following description of the Kingdom Enterprises Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General**

The Employer established the Plan effective January 1, 2009. The Plan was most recently restated effective January 1, 2022 and amended effective January 1, 2024. The Plan is a defined contribution retirement plan sponsored by Kingdom Enterprises Inc. and participating employers Douglas Machine Inc. and Integrated Packaging Machinery, Inc. (collectively referred to as Employer). The Plan covers substantially all employees of the Employer who meet certain eligibility requirements. An employee will become eligible for the Plan upon attainment of age 18 and completion of six months of service. Entry dates for the Plan are quarterly. The Plan excludes employees covered by collective bargaining agreements and nonresident aliens with no U.S. source income. A description of the Plan is set forth in the Summary Plan Description provided to all Plan participants. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Audit Committee is responsible for the oversight of the Plan. The Retirement Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance along with the Plan's trustee and investment advisor.

**Contributions**

The Plan includes a cash or deferred arrangement allowed under Section 401(k) of the Internal Revenue Code (IRC). Participants are thereby permitted to elect to have a percentage, up to 50%, of their compensation contributed as pre-tax 401(k) or after-tax Roth contributions to the Plan. The Plan has an automatic enrollment feature in which 3% of eligible compensation will be automatically withheld for new participants, unless otherwise elected by the participant. This percentage, as well as the elected percentage of existing participants, will be increased by 1% each year up to 6%. Participants are also allowed to make after-tax contributions which may be withdrawn at any time. The Plan allows participants age 50 or older to make catch-up contributions.

The Employer may make matching and profit sharing contributions to the Plan at its discretion. To be eligible for Employer contributions, participants must be employed on the last day of the Plan year and be credited with 1,000 hours during the Plan year. The Employer authorized a matching contribution that was designated to the Kingdom Enterprises Inc. Employee Stock Ownership Plan for the years ended December 31, 2024 and 2023. There were no Employer profit sharing contributions authorized during December 31, 2024 and 2023.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans and certain IRAs. Participants direct the investment of contributions into various investment options offered under the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

**Participant Accounts**

Each participant's account is credited with the participant's deferral contributions, the Employer's contributions, forfeitures, ESOP diversification amounts, and Plan earnings or losses. Income is allocated daily based on each participant's share of the account. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, and participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided by the participant's account.

**Vesting**

A participant is always 100% vested in their salary reduction deferral contributions, rollover, and ESOP diversification portion of their account balance. If a participant's employment is terminated for reasons of death, attainment of normal retirement age or early retirement age, or total and permanent disability, the participant is 100% vested in the Employer portion of the account. Upon termination for any other reason, vesting in Employer contributions is subject to a graded vesting schedule based on the completion of years of service, credited as follows:

<u>Years of Vesting Service</u>	<u>Vesting</u>
Less than 2 Years	0%
2 Years but Less than 3 Years	20%
3 Years but Less than 4 Years	40%
4 Years but Less than 5 Years	60%
5 Years but Less than 6 Years	80%
6 Years or More	100%

**Notes Receivable from Participants**

Notes are permitted only for the purpose of meeting a financial hardship and other specific criteria as defined in the loan policy. Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. No note in an amount less than \$1,000 will be granted. The notes are secured by the vested balance in the participant's account and bear interest at the prime rate plus 1%. Principal and interest is paid ratably through payroll deductions.

**Payment of Benefits**

Upon termination of service, death, disability, or retirement age, a participant may elect to receive the value of the vested interest in their account in the form of a lump sum distribution or installment distribution. A participant may apply for a hardship distribution or take an in-service distribution upon attaining age 59 ½ and, of part or all of the participant's deferral and rollover contribution accounts subject to Plan provisions. Participants may withdraw after-tax contributions at any time. If a participant account balance is less than \$1,000, the Plan administrator will automatically distribute the balance in the form of a lump sum without the participant's consent.

**Forfeitures**

Forfeitures of nonvested account balances are reallocated as additional Employer contributions. No forfeitures were allocated as Employer contributions during December 31, 2024 and 2023. There was no balance in the forfeiture account at December 31, 2024 and 2023.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared under the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisors, trustee, and custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Investment income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent notes receivable are recorded as distributions on the basis of the terms of the Plan document.

**Benefit Payments**

Benefit payments are recorded when paid.

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid directly by the Employer and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefit payments are charged directly to the participant's account and are included in administrative expense. Fees related to administrative and investment advisory services are also charged directly to the participant's accounts and are included in administrative expenses. Investment related expenses including revenue sharing credits are included in net appreciation of fair value of investments.

**Subsequent Events**

The Plan has evaluated subsequent events through October 3, 2025, the date the financial statements were available to be issued.

**NOTE 3 CERTIFICATION OF INVESTMENT INFORMATION**

Matrix Trust Company, the trustee, has supplied the Plan administrator with a certification as to the completeness and accuracy of the notes receivable from participants and all investment information reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statements of changes in net assets available for benefits for the years then ended, and the schedule of assets (held at end of year) as of December 31, 2024.

**NOTE 4 FAIR VALUE OF INVESTMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

*Mutual Funds* – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Collective Trust Funds* – Valued at the NAV of units of the bank collective trust. NAV is a readily determinable fair value and is the basis for current transactions. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

**NOTE 5 RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with an investment, it is reasonably possible that changes in the values of the investment will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.

**NOTE 6 GROUP ANNUITY CONTRACT WITH INSURANCE COMPANY**

In 2019, the Plan entered into a traditional fully benefit-responsive guaranteed investment contract with The Standard Insurance Company (The Standard). The Standard maintains a portion of the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1%. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

**NOTE 6 GROUP ANNUITY CONTRACT WITH INSURANCE COMPANY (CONTINUED)**

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by The Standard, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation.

**NOTE 7 PLAN TERMINATION**

Although the Employer has not expressed any intent to do so, it has the right under the terms of the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their Employer accounts.

**NOTE 8 PLAN TAX STATUS**

The Plan is placing reliance on a determination letter received from the IRS on the Plan indicating that the Plan is qualified under Section 401 of the IRC and is, therefore, not subject to tax under current income tax law. The Plan has been amended since receiving the determination letter. However, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 9 PARTIES-IN-INTEREST**

The Plan investments are managed by Matrix Trust Company. Matrix Trust Company is the trustee, as defined by the Plan and, therefore, the investment transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in administrative expenses (see also Note 2) as they are paid as a direct payment. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

**NOTE 10 RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500**

All transfers are included in the Transfers from Affiliated Plan line on the statements of changes in net assets available for benefits.

**NOTE 12 NONEXEMPT TRANSACTIONS**

During 2024, the Company failed to remit employee 401(k) deferral contribution and loan repayments for certain payroll periods within the timeframe prescribed by the Department of Labor. These are deemed prohibited transactions in accordance with ERISA and the IRC. The Company corrected the prohibited transactions by depositing lost earnings.
