Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that the audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Rose Neath Funeral Homes Retirement Savings Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant account estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Rose Neath Funeral Homes Retirement Savings Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter -- Supplemental Schedules Required by ERISA

The supplemental Schedule of Delinquent Participant Contributions at December 31, 2024 and Schedule of Assets Held at End of Year at December 31, 2024, are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion –

- the form and content of the supplemental schedules, other than the information in the supplemental schedules that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedules related to assets held by and certified to by a qualified institution agrees to or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

(1) Description of Plan

The following description of the Rose Neath Funeral Homes Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution and profit-sharing plan established effective June 1, 1994. Through June 30, 2020, the Plan covered all employees of Kilpatrick Life Insurance Company (KLIC), Kilpatrick's Rose-Neath Funeral Homes, Crematoriums and Cemeteries, Inc. (the Company or the Employer), and Case Management Group (CMG). In December 2019, KLIC and CMG were sold to new ownership (SNF Corporation). Effective July 1, 2020, Kilpatrick Life Insurance Company and Care Management Group, LLC ceased their participation in the Rose Neath Funeral Homes Retirement Savings Plan.

All full-time salaried and hourly employees who have completed one year or more of service and are aged twenty-one or older are eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions – Participants may elect to contribute a percentage of their pre-tax annual compensation as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participant annual contributions are limited to the amount set forth in the Internal Revenue Code. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover). Employee contributions are made through salary reductions. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmably elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated fund until changed by the participant. The Company may contribute a matching amount at its discretion determined prior to the end of the Plan year. For the year ended December 31, 2024, the Company made a matching contribution equal to 100% of the participant's elective deferrals up to 3% of compensation. The Company may also make discretionary profit-sharing contributions. No discretionary profit-sharing contributions were made to the Plan for the year ended December 31, 2024. Participants direct the investment of their contributions into various investment options offered by the Plan.

Participant Accounts - Each plan participant's account is credited with the participant's contributions, employer contributions, as well as allocations of Plan earnings and losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on the participant's earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participants are fully vested in their employee contributions plus actual earnings thereon. Vesting in the Company's matching and profit-sharing contributions plus actual earning thereon is based on continuous years of service as follows:

Notes Receivable from Participants – Participants may borrow from their fund accounts a minimum of \$1,000 up to one-half of their vested account balance or \$50,000, whichever is less. The loans are secured by the balance in the participant's account. The loans bear interest rates that range from 3.25% to 8.5%, which are commensurate with local prevailing rates as determined quarterly by the Plan Administrator. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits – On termination of service due to death, disability, or retirement, a participant will receive a lump-sum or installment amount equal to the vested value of his or her account. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Benefits are recorded when paid.

Forfeited Accounts – As of December 31, 2024, and 2023, available forfeited non-vested accounts totaled \$4,144 and \$0, respectively. Forfeitures are used to reduce future employer contributions and/or pay plan administrative fees. During 2024 and 2023, forfeitures were used to pay administrative expenses in the amount of \$3,797 and \$3,175, respectively.

(2) **Summary of Accounting Policies**

Basis of Accounting - The financial statements of the Plan are prepared on the accrual basis of accounting.

Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

(2) Summary of Accounting Policies (continued)

Investment Valuation and Income Recognition – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Administrative Expenses – Certain administrative expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Fees related to administrative recordkeeping, trustee fees, and other professional fees and allocated to participants. Investment-related expenses are included in net appreciation of fair value of investments.

Date of Management's Review – Subsequent events were evaluated through September 30, 2025, which is the date the financial statements were available to be issued.

(3) Fair Value Measurements

Fair value measurement accounting establishes a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels. Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 consists of inputs which are observable for the asset or liability, either directly or indirectly, from other than quoted market prices included in Level 1. Level 3 inputs are unobservable and the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value.

Mutual Funds – The Plan's mutual fund investments are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

(3) Fair Value Measurements (continued)

Common Collective Trust – The common collective trust fund investment (the Putnam Stable Value Fund or PSV) is composed primarily of fully benefit-responsive investment contracts that are valued at the NAV of the units of the collective trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may be made daily at the current NAV and are considered to be made immediately after the daily valuation. Subject to certain restrictions, withdrawals from the PSV are generally permitted daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months notification in order to ensure that securities liquidations will be carried out in an orderly business matter.

(5) **Party-in Interest-Transactions**

Section 3(14) of ERISA defines a party-in-interest to include, among others, fiduciaries or employees of the Plan, any person who provides services to the Plan, or an employer whose employees are covered by the Plan. Accordingly, loans to participants, transactions with investment funds managed and held by the trustee, and administrative and professional fees paid by the Plan are considered party-in-interest transactions. The Plan incurred administrative and professional fees, which totaled \$41,048 and \$50,307 for the years ended December 31, 2024, and 2023, respectively, and are included in the statement of changes in net assets available for benefits. Fees paid for investment management services are included in the net appreciation in fair value of investments.

(6) **Tax Status**

The Internal Revenue Service has determined and informed Reliance Trust Company (Trustee), by a letter dated June 30, 2020, that the prototype plan document and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, the related trust is tax-exempt.

(7) **Participants Terminated with a Remaining Balance**

Net assets available for benefits at December 31, 2024 and 2023, include \$1,431 and \$49,989, respectively, allocated to the accounts of persons who, as of or prior to that date, had withdrawn from participating in the earnings and operations of the Plan.

(8) **Other Employer Contributions**

Other employer contributions receivable as of December 31, 2023, presented on the Statement of Net Assets Available for Benefits of \$1,973 include the lost earnings and interest from delinquent participant contributions determined by the time period described in 29 CFR 2510.3-102. The plan sponsor subsequently funded all delinquent participant contributions to the Plan, including lost earnings and interest as calculated under the DOL's Voluntary Fiduciary Correction Program.

(9) **Plan Termination**

Although they have not expressed any intentions to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

(10) Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
