Report on the Audit of the Financial Statements

Opinion

We have audited the financial statements of Gila River Gaming Enterprises, Inc. Group Employee Benefit Plan and Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of benefit obligations and fiduciary net position as of December 31, 2024, and the related statements of changes in benefit obligations and fiduciary net position for the year then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the fiduciary net assets of Gila River Gaming Enterprises, Inc. Group Employee Benefit Plan and Trust as of December 31, 2024, and the changes in its fiduciary net position for the year then ended, in accordance with accounting principles generally accepted in the United States of America (GAAP).

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. Note 1 – Description of Plan

The following description of the Gila River Gaming Enterprises, Inc. Group Employee Benefit Plan and Trust (the Plan) provides only general information. Participants should refer to the plan agreement, as amended, for a more complete description of the Plan's provisions.

General – The Plan has been established by the Gila River Indian Community (the Community), a federally recognized Indian Tribe, and operates under the authority of Tribal Council. The Plan is sponsored by Gila River Gaming Enterprises, Inc. (the Employer or GRGE), a legally separate entity of the Community. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. As of December 31, 2024 and 2023, there were 2,861 and 2,457 employees participating in the Plan, respectively.

Eligibility – The Plan covers all GRGE employees who work a minimum of 30 hours per week and their eligible dependents. Full-time employees begin participating on the first day of the first month following a 60-day waiting period. Variable-hour employees begin participating on the first day of the first month following a 60-day waiting period after working a minimum of 30 hours per week during a one-year initial measurement period. The plan excludes retired participants as well as part-time employees.

Benefits – The Plan provides health benefits (medical, vision, dental, prescription, and behavioral health), short-term disability, long-term disability, basic and voluntary life/accidental death and disability (AD&D) benefits and voluntary benefits (accident, critical illness, hospital indemnity and long-term care) to eligible employees and their dependents. Former employees may elect coverage under the Consolidated Omnibus Budget Reconciliation Act of 1985 (COBRA) provisions, if they experience a qualifying event as defined in COBRA.

Insured benefits – Certain Plan benefits are self-insured with additional stop-loss coverage to limit exposure for claims over a specific dollar amount. Claims for self-insured benefits are processed by the Plan's third-party claims processors under an administrative service only (ASO) arrangements. The claims processors pays claims on behalf of participants and are reimbursed from the general assets of the Employer. Despite the Plan's utilization of third-party claims administrators, ultimate responsibility for payments to providers and participants is retained by the Plan.

For the years ended December 31, 2024 and 2023, the Plan was fully insured for the following benefits: long-term disability, life/AD&D benefits, and voluntary benefits. The Plan was self-insured for the following benefits: medical, vision, dental, prescription, behavioral health, and short-term disability benefits.

Notes to Financial Statements

Contributions – The Plan provides that the Employer shall contribute the full cost of medical, vision, dental, behavioral health, short-term disability, long-term disability, and life benefits for all covered personnel. Participants contribute to the Plan based upon the type of coverage selected for spouses or dependents. Contribution amounts vary based on coverage selected. The Employer does not contribute to the cost of medical coverage for COBRA participants.

Note 2 – Summary of Significant Accounting Policies

Basis of presentation – The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP), using the accrual method of accounting, in accordance with accounting standards promulgated by the Governmental Accounting Standards Board.

Use of estimates – The preparation of financial statements in conformity with GAAP requires the use of estimates and assumptions that may affect certain amounts and disclosures. Accordingly, actual results could differ from those estimates.

Cash and cash equivalents – Cash and cash equivalents represent the amounts funded through contributions to pay future benefits and administrative expenses of the Plan, which include amounts on hand and on deposit with a financial institution, JP Morgan Chase Bank, N.A.

Stop loss policy – The Plan carries an insurance policy that covers medical claims up to a specific stop loss limit of \$250,000. The Plan's assets might not be sufficient if a number of participants incurred claims up to the individual deductible in any one year. At December 31, 2024 and 2023, stop loss receivables totaled \$726,422 and \$111,347, respectively. For the years ended December 31, 2024 and 2023, specific stop loss reimbursements totaled \$726,422 and \$288,584, respectively, and are recorded as a reduction in claims paid in the accompanying statements of changes in benefit obligations and changes in net position available for benefits.

Investment valuation – Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability (the "exit price") in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Income recognition – Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis.

Benefit obligations – An estimate for claims incurred but not reported (IBNR) is determined based on actual information related to claims filed subsequent to year-end and historical trends. These amounts are paid by the Plan only if claims are submitted and approved for payment. It is reasonably possible that a significant change in the estimate will occur in the near term.

Payment of benefits – Benefits are recorded when paid by the third-party claim administrators. Amounts due to the third-party claims administrators that have yet to be reimbursed by the Plan are recorded as claims payable in the accompanying statements of benefit obligations and net position available for benefits.

Expenses – The Plan pays administrative expenses that consist primarily of fees paid to the third- party claims administrator. Certain expenses of maintaining the Plan are paid directly by the Employer and are excluded from these financial statements.

Note 3 – Cash and Cash Equivalents

Custodial credit risk is the risk that in the event of a bank failure, the Plan will not be able to recover its deposits held by the bank. The cash balance which is maintained with a financial institution at various times during the year, may exceed Federal Deposit Insurance Corporation (FDIC) insured limits, and as a result, there is a concentration of credit risk related to amounts on deposit in excess of FDIC insured limits. The Plan has not experienced any losses in such accounts and believes that it is not exposed to any significant custodial credit risk on its cash and cash equivalents.

Note 4 – Fair Value Measurements

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation techniques used for assets measured at fair value. There have been no changes in the techniques used at December 31, 2024 and 2023.

Money market fund – Shares in the registered investment company (money market fund) are valued at the daily closing price as reported by the fund. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The fund held by the Plan is deemed to be actively traded. The mutual fund held by the Plan is an open-end mutual fund that is registered with the U.S. Securities and Exchange Commission.

The valuation methods used by the Plan may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5 – Tax Status

The Voluntary Employees' Benefit Association (VEBA) trust, funding certain benefits of the Plan, received an exemption letter from the Internal Revenue Service (IRS) dated May 11, 1999, stating that the trust is tax-exempt under the provisions of 501(c)(9) of the Internal Revenue Code (IRC). However, as a result of the Plan's funding policy, from time to time the trust may be subject to income taxes. For the years ended December 31, 2024 and 2023, no federal or state income taxes have been recorded for unrelated business taxable income. The Plan and the trust are required to operate in conformity with the IRC to maintain the tax-exempt status of the trust. The Plan administrator believes that the Plan is being operated in compliance with the applicable requirements of the IRC; therefore, believes that the related trust is tax-exempt.

Note 6 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risks. It is reasonably possible, given the level of risk associated with investment securities, that changes in the values of the investments in the near term could materially affect a participant's account balance and the amounts reported in the statement of fiduciary net position. Since all investments are participant directed, all risks exist at the participant level.

Each individual within the Plan has the ability to liquidate his or her position and retains responsibility for managing exposure to fair value loss. A summary of the risks and plan exposure is summarized below.

Custodial credit risk – Custodial credit risk is the risk that in the event of the failure of the counterparty, the Plan will not be able to recover the value of its investments that are in the possession of an outside party. The Plan's does not hold any direct investments or instruments that are subject to custodial credit risk.

Interest rate risk – Interest rate risk is the risk that changes in interest rates will adversely affect the fair value of an investment. The Plan's does not hold any direct investments or instruments that are subject to interest rate risk.

Credit risk – Credit risk is the risk that an issuer or other counterparty to an investment will not fulfill its obligation to the Plan. The Plan does not hold any direct investments or instruments that are subject to credit risk.

Note 7 – Party-in-Interest and Related-Party Transactions

The Plan has arrangements with third-party service providers to administer benefits. Transactions with these service providers are considered exempt party-in-interest transactions under ERISA. Certain accounting and management services are provided to the Plan by the Employer for which no fees are charged which qualify as party-in-interest transactions and are exempt from the prohibited transactions rules.

Note 8 – Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to modify the benefits provided to, contributions required of participants, discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

In the event of termination of the Plan, the Plan shall continue until all pending claims for benefits outstanding as of the date of termination have been paid or otherwise resolved. Any amounts remaining in the Plan after all pending claims have been resolved shall be distributed to the Employer to the extent that the amounts do not exceed the employer contributions during the medical loss ratio period.
