### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of G.E.O. Heat Exchangers, L.L.C. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

## NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024 AND 2023

### **Note 1 - Description of Plan -**

The following brief description of G.E.O. Heat Exchangers, L.L.C. 401(K) Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for more complete information.

#### General

The Plan is a 401(k) defined contribution plan adopted July 1, 1998. It covers all eligible employees of G.E.O. Heat Exchangers, L.L.C. and G.E.O. Field Service, L.L.C (“the Companies”) who are at least 21 years of age and have one year (1,000 hours) of service with entry dates on the first day of each plan quarter. The Plan excludes employees covered by collective bargaining agreements and non-resident aliens. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Management oversees the governance of the Plan, determines the appropriateness of the Plan’s investment offerings, and monitors investment performance.

#### Contributions

Participants may contribute an amount equal to a percentage of their compensation earned during the plan year not to exceed the limits imposed by the Internal Revenue Code. Participants are 100% vested in their contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

The Plan provides for safe harbor matching contributions by the Companies in an amount equal to 100% of the matched employee contributions that are not in excess of 3% of the participant’s compensation and 50% of the amount of the participant’s matched employee contributions that exceed 3% of the participant’s compensation, but do not exceed 5% of the participant’s compensation. For the year ended December 31, 2024, the Companies’ safe harbor contribution was \$364,726. The Companies may also make a discretionary profit-sharing contribution to all eligible participants of the Plan. For the year ended December 31, 2024, the Companies elected to make a discretionary profit-sharing contribution in the amount of \$100,000.

#### Participant Accounts

Each participant's account is credited or charged with the participant’s contribution and the allocation of the Companies' contribution, the Plan’s investment earnings or losses, certain Plan administrative costs not covered by the Plan sponsor, and forfeitures of terminated participants’ non-vested accounts. Allocations are based upon participant earnings and account balances, as defined by the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

## Vesting

Participants are immediately vested in their voluntary contributions and employer safe harbor contributions plus actual earnings thereon. Vesting in the remainder of their accounts is based on years of continuous service as follows:

## Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$12,036 and \$6,003, respectively. These accounts may be used to reduce future employer contributions and pay administrator fees. During 2024, no forfeiture accounts were used to reduce administrative expenses.

## Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. A participant may have only one outstanding loan at any one time. The notes are secured by the balance in the participant's account and bear interest equal to 1% above the prime rate, which is commensurate with local prevailing rates. Principal and interest is paid ratably through payroll deductions.

## Payment of Benefits

Upon termination of service due to death, retirement or termination, participants are entitled to receive a lump sum payment equal to the value of their vested account balance.

## **Note 2 - Summary of Accounting Policies -**

### Basis of Accounting

The financial statements of the Plan are prepared in accordance with the accrual basis of accounting and investments are valued at current fair value as quoted by the custodian of the Plan. All assets of the Plan are participant directed.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the plan. As of December 31, 2024 and 2023, the Plan has no fully benefit-responsive investment contracts.

### Investment Valuation and Income Recognition

Investments are reported at fair value, except for fully benefit-responsive investment contracts which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Management determines the Plan's valuation policies utilizing information provided by the Plan custodian. See Note 5 for discussion of fair value measurements.

Benefits are recorded when paid. Purchases and sales of securities are recorded on the trade-date basis. Dividends are recorded on the ex-dividend date. Net investment income includes gains and losses on investments sold during the year as well as appreciation and depreciation of the investments held at the end of the year.

### Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates, and such differences may be material.

### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the Plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document. For the year ended December 31, 2024, the Plan had deemed distributions of \$14,613 and are included on the statement of changes in net assets available for benefits.

### Contributions

Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

### Risks and Uncertainties

The Plan provides for various investment options in any combination of selected funds held by the custodian. These funds are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with these funds, it is at least reasonably possible that changes in the values of these funds will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Companies and are excluded from these financial statements. Investment related expenses are included in net investment income.

### Subsequent Events

The Plan evaluated subsequent events and transactions for potential recognition or disclosure in the financial statements through October 6, 2025, the date the financial statements were available to be issued.

### **Note 3 - Plan Termination -**

Although they have not expressed any intent to do so, the Companies have the right to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants become fully vested in their accounts.

### **Note 4 - Tax Status -**

The Plan sponsor has adopted a prototype plan which received a favorable determination from the Internal Revenue Service. The Plan itself has not separately applied for recognition of tax-exempt status. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. generally accepted accounting principles require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there currently are no audits for any tax period in progress. With few exceptions, the Plan is no longer subject to income tax examinations for years prior to 2021.

### **Note 5 - Fair Value Measurements -**

The fair value measurement accounting literature provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy consists of three broad levels. Level 1 inputs to the valuation methodology are based on unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access. Level 2 inputs are based primarily on quoted prices for similar assets in active or inactive markets and/or based on inputs that are derived principally from or corroborated by observable market data by correlation or other means. Level 3 inputs are unobservable and are based on assumptions market participants would utilize in pricing the asset.

The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. When available, valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value at December 31, 2024 and 2023:

Interest-Bearing Cash (Money Market): Valued at fair value based on preserving the net asset value of \$1.00 per share based on the underlying assets invested in treasury securities, when applicable.

Registered Investment Companies: Valued at fair value based on quoted net asset values (NAV) of the shares held by the Plan at year end which is considered to be readily determinable.

Although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 6 - Information Prepared and Certified by the Custodian / Trustee -**

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments held at December 31, 2024, and net investment income for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company, trustee and Matrix Trust Company, custodian, as of December 31, 2023.

**Note 7 - Related Party and Party-In-Interest Transactions -**

Certain plan investments were managed by Matrix Trust Company (Matrix) as of December 31, 2023 and Fidelity Management Trust Company (Fidelity) as of December 31, 2024. Since Matrix and Fidelity were the custodian / trustee of the investments as defined by the Plan, these transactions qualify as party-in-interest. Fees incurred by the Plan for the investment management services are included in net investment income, as they are paid through revenue sharing, rather than a direct payment. The Company may also directly pay for other fees related to the Plan's operations. All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

**Note 8 - Reconciliations of Financial Statements to Schedule H of Form 5500 -**
