### NOTE A - DESCRIPTION OF THE PLAN

The following description of the TouchPoint, Inc. Employees' 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan covering substantially all eligible employees of TouchPoint, Inc. (the "Company"). The Company's Investment Committee controls and manages the operation and administration of the Plan. Charles Schwab Bank serves as the Trustee of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

#### **Eligibility**

Eligible employees include all regular full-time employees of the Company, who are not considered excluded employees as defined in the Plan document. Employees are automatically enrolled in the Plan. Unless the participant elects otherwise, 3% of their salary will be automatically elected as a pre-tax salary deferral contribution to the Plan.

#### **Contributions**

Eligible employees (the "Participants") can contribute up to the maximum amount allowable under the limits set by the Internal Revenue Code ("IRC"). Certain eligible employees were allowed to make additional catch-up elective deferrals up to the maximum amount allowable under the limits set by the IRC. The Participants are responsible for directing the allocation of their contributions among the established funds. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans ("rollover"). The Company makes a matching contribution equal to 50% of the participant's contribution up to the first 6% of salary.

In addition, the Company may also make discretionary contributions to the Plan. For the year ended December 31, 2024, the Company elected to contribute a discretionary contribution equal to 2% of salary to all employees, the related employer discretionary contributions were \$1,380,191.

#### **Participant Accounts**

Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contribution, the Company's matching contribution, and allocations of Company discretionary contributions, and Plan earnings, and charged with withdrawals and an allocation of Plan investment losses and administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Investments**

Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers several mutual funds, common collective trust funds, and a self-directed brokerage account as investment options for participants.

#### **Vesting**

Participants are fully vested in their contributions, plus actual earnings thereon. Participants are also immediately fully vested in the Company's matching contributions. Vesting in the Company's non-elective contribution portion of their accounts and earnings thereon is based on continuous years of service. A participant is 100% vested after three years of credited service and 0% vested for less than 3 years of service.

#### **Notes Receivable from Participants**

Participants may borrow from their fund accounts up to a maximum of 50,000 or 50% of their account balance, whichever is less. The loans are secured by the balance in the participant's account and bear interest at prime rates plus 1%. Principal and interest are paid ratably through payroll deductions.

#### **Payment of Benefits**

Participants' benefits under the Plan are payable to participants, their beneficiaries or their estates upon termination of service, retirement, death, disability, hardship or upon the attainment of age 59-1/2. A participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account.

#### **Forfeited Accounts**

Employees who terminate employment and are not fully vested will forfeit the nonvested portion of their account balance to the Plan, as specified in the Plan document. Forfeitures that are not used to pay administrative expenses will be used to reduce other employer contributions, added to other employer contributions, or reallocated as elected by the employer. At December 31, 2024 and 2023, there were no forfeited nonvested accounts. During the year ended December 31, 2024, employer contributions were reduced by \$72,856 from forfeited nonvested accounts.

#### **Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their retirement savings account.

#### **Plan Amendments**

On December 29, 2022, the "Setting Every Community Up for Retirement Enhancement (SECURE) 2.0 Act" was signed into law in the United States. The Secure 2.0 Act is an expansion of the Secure Act passed during 2019. The Act includes several mandatory and optional provisions that will become effective across several years. The Secure 2.0 Act aims to expand retirement access, increase retirement savings, and simplify plan administration. Plans may choose to operationally implement the provisions of the Secure 2.0 Act, however plan administrators have until December 31, 2026 to officially amend the plan document to reflect the provisions adopted by the plan.

### NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### **Basis of Accounting**

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with generally accepted accounting principles in the United States of America ("GAAP").

#### **Use of Estimates**

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### **Investment Valuation and Income Recognition**

The Plan's investments are stated at fair value. Fair value is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **Notes Receivable from Participants**

Loans to participants are reported at their unpaid principal balances plus accrued interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

#### **Management Fees and Operating Expenses**

Management fees and operating expenses charged to the Plan for investments are deducted from income earned on a daily basis and are not separately reported. Consequently, management fees and operating expenses are reported as a reduction of investment return for investments.

#### **Administrative Expenses and Expense Offset Arrangements**

Certain administration expenses of maintaining the Plan are paid by the Plan Sponsor. Expenses that are paid by the Plan Sponsor are excluded from these financial statements. Participant accounts are charged with an allocation of certain administrative expenses, such as recordkeeper fees, that are paid by the Plan. Fees related to the administrative of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation (depreciation) in fair value of investments.

Certain revenue sharing amounts are kept in an unallocated expense benefit account to be used to offset future expenses. The unallocated expense accounts totaled \$0 and \$19,196 at December 31, 2024 and 2023, respectively, with \$19,357 of funds applied to offset administrative expenses for the years ended December 31, 2024.

### NOTE C - FAIR VALUE MEASUREMENTS

FASB Accounting Standards Codification ("ASC") 820, Fair Value Measurement, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ACS 820 are described as follows:

*Level 1* - Valuations based on unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access;

*Level 2* - Valuations based on quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; or inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability;

*Level 3* - Valuations based on inputs that are unobservable and significant to the fair value measurement.

### NOTE C - FAIR VALUE MEASUREMENTS (Continued)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Self-directed brokerage accounts:* Accounts primarily consist of mutual funds, exchange traded funds, and common stocks that are valued on the basis of readily determinable quoted market prices.

*Common collective trust funds:* Consist of 1) a stable value fund that is composed primarily of fully benefit responsive investment contracts and 2) diversified fixed income and equity funds that track indices. The common collective trust funds are valued at the NAV of units of the respective collective trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. Notice periods apply to Plan level redemptions only, not participant transactions.

The valuation methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### **NOTE C - FAIR VALUE MEASUREMENTS (Continued)**

(a) Certain investments that are measured at fair value using the NAV per share (or its equivalent) practical expedient have not been categorized in the fair value hierarchy. The fair value amounts presented in this table are intended to permit reconciliation of the fair value hierarchy to the amounts presented in the Statements of Net Assets Available for Benefits.

The Plan invests in eight common collective investment trust funds for the years ended December 31, 2024 and 2023. These common collective investment trust funds are direct filing entities. There are no participant redemption restrictions for these investments; the redemption notice period is applicable only to the Plan.

### **NOTE D - RELIANCE ON TRUSTEE'S REPORT**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Charles Schwab Trust Bank.

### **NOTE E - EXEMPT PARTY-IN-INTEREST AND RELATED PARTY TRANSACTIONS**

Certain Plan investments are managed by the trustees or their related affiliates and therefore, these transactions qualify as party-in-interest transactions. Fees paid to the Plan's recordkeeper totaled \$82,855 and are partially paid through revenue sharing as disclosed in Note B. Notes receivable from participants and related interest income also qualify as party-in-interest transactions.

### **NOTE F - TAX STATUS**

The Plan has adopted a Volume Submitter Plan sponsored by Schwab Retirement Plan Services. On September 21, 2020, the Internal Revenue Service ("IRS") stated in an opinion letter that the Volume Submitter adopted by the Plan, as then designed, was in compliance with applicable requirements of the IRC and therefore, the related trust is exempt from taxation. The Plan has been amended since receiving the IRS opinion letter. However, the Plan administrator believes that the Plan is currently being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes that the Plan is qualified and the related trust is tax-exempt.

### **NOTE F - TAX STATUS (Continued)**

In accordance with U.S. GAAP, plan management evaluates tax positions taken by the plan and recognized a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **NOTE G - RISK AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.

### **NOTE H - SUBSEQUENT EVENTS**

The Plan has evaluated subsequent events through August 12, 2025, the date the financial statements were available to be issued. Based on this evaluation, the Plan is not aware of any material events that would require recognition or disclosure in these financial statements.
