## INDEPENDENT AUDITORS' REPORT

### SCOPE AND NATURE OF THE ERISA SECTION 103(A)(3)(C) AUDIT

We performed audits of the accompanying financial statements of the Lessard Design Inc. Employee Savings Trust (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, the related Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024, and the related notes to the financial statements.

**NOTE 1**    **DESCRIPTION OF PLAN**

The following description of the Lessard Design Inc. Employee Savings Trust (Plan) is provided for general information purposes only. Participants should refer to the Plan Document or the Summary Plan Description for more complete information of the Plan's provisions.

***General***

The Plan is a defined contribution plan that covers employees of Lessard Design Inc., Metropolitan Management, LLC, Metropolitan Development Group, LLC, and Lessard International, LLC (collectively referred to as the Company), provided the employee is at least 21 years old. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

***Contributions***

Participants may contribute up to 100% of annual compensation as defined, subject to applicable Internal Revenue Code limitations, including catch-up contributions if applicable. Participants may also rollover distributions from qualified plans. Upon becoming eligible, employees are automatically enrolled in the Plan with a deferral contribution rate of 3%. Participants may also elect to contribute Roth contributions.

During the year ended December 31, 2024, the Company made a discretionary matching contribution of 25% of the participant's deferrals up to 6% of the contributing participant's eligible compensation. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

The Company may elect, at its sole discretion, to make nonelective contributions. The Company did not make any nonelective contributions during the year ended December 31, 2024.

***Participant Accounts***

Each participant's account is credited with the participant's contribution, the Company's discretionary match, and allocations of (a) the Company's contribution and (b) Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Notes Receivable From Participants***

Participants may borrow up to 50% of their vested account balances not to exceed \$50,000. Note terms require amortization of principal and interest over a period not to exceed five

years. Notes used to acquire a principal residence may extend beyond a five-year term. A note receivable is collateralized by the balance in the participant's account and bears interest at the prime rate plus 1%. Notes receivable are repaid through payroll deductions and may be repaid in full at any time.

***Vesting***

Participants are immediately vested in their voluntary contributions. A participant generally becomes fully vested in the Company's discretionary contributions upon five years of service, disability (as defined by the Plan), or death.

***Investment Options***

Upon enrollment in the Plan, a participant may direct employee contributions into various investment options offered by the Plan. Specific information regarding these options may be obtained from the Plan Administrator. Participants may change their investment options at any time.

***Payment of Benefits***

Upon retirement, disability, death, or termination of employment, a participant is entitled to receive a lump-sum amount or installments, subject to Plan provisions, equal to the vested portion of the participant's account. Hardship withdrawals and in-service withdrawals at age 59½ are also permitted, subject to provisions defined in the Plan Document.

***Plan Termination***

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts, and the value of the interests of all participants and beneficiaries shall be determined and distributed to them in a lump sum.

***Forfeitures***

At December 31, 2024 and 2023, forfeited non-vested accounts totaled approximately \$48,000 and \$26,000, respectively. These accounts will be used to reduce future Company contributions or pay plan expenses in accordance with the Plan Document.

***Administrative Expenses***

Certain administrative expenses incurred by the Plan are paid by the Company. In addition, the Company provides services to the Plan without charge.

**NOTE 2** SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

***Accounting Standards Codification***

All references in the financial statements to the Codification refer to the Accounting Standards Codification and the Hierarchy of Generally Accepted Accounting Principles (GAAP) issued by the Financial Accounting Standards Board. The Codification is the single source of authoritative GAAP in the United States.

***Basis of Accounting***

The accompanying financial statements are prepared on the accrual basis of accounting.

***Use of Estimates***

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

***Valuation of Investments***

Investments are reported at fair value. See Note 4 for a discussion of fair value measurements.

***Payment of Benefits***

Benefits are recorded when paid.

***Risk and Uncertainties***

The Plan provides for investments in various investment securities, which are exposed to various risks, such as interest rate, credit, and overall volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term, and such changes could materially affect the amounts reported in the Statements of Net Assets Available for Benefits.

***Notes Receivable From Participants***

Notes receivable from participants are carried at their unpaid principal balances plus accrued interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan Document.

***Subsequent Events***

The Plan evaluated subsequent events and transactions for potential recognition or disclosure in the financial statements through October 8, 2025, the date the financial statements were available to be issued.

**NOTE 3 INFORMATION CERTIFIED BY THE TRUSTEE**

The Plan’s investments were held by the Trustee of the Plan, Capital Bank and Trust Company, for the years ended December 31, 2024 and 2023. Financial information related to those investments is included in the accompanying financial statements based on information certified by the Trustee. The information was not audited by the Plan’s independent auditors and is summarized below:

**NOTE 4 VALUATION OF INVESTMENTS**

Investments are recorded at fair value in accordance with the provisions of the Fair Value Measurements and Disclosures Topic of the Codification, which establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value.

The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

*(See Independent Auditors’ Report)*

The three levels of the fair value hierarchy are described below:

- Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2      Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Below are descriptions of the valuation methodologies used for assets measured at fair value.

**Mutual Funds:** Valued at the net asset value (NAV) of shares held by the Plan at year end. NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. NAV is a quoted price in an active market.

**Collective Trust:** Valued using NAV per unit. The NAV is based on the value of the underlying investments owned by each fund, minus its liabilities, and then divided by the number of units outstanding. Participant-initiated transactions may occur daily at NAV.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 TAX STATUS**

The Plan adopted a non-standardized, pre-approved plan that obtained a determination letter dated June 30, 2020, wherein the Internal Revenue Service stated the plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code (IRC). The Plan has since been amended and restated. The Plan Administrator believes the Plan is designed and operating in compliance with the applicable provisions of the Code. Therefore, no provision for income taxes was included in the Plan's financial statements.

GAAP requires Plan management to evaluate uncertain tax positions for recognition in the financial statements. The Plan Administrator concluded that there were no uncertain tax positions taken as of December 31, 2024.

**NOTE 6 PARTIES-IN-INTEREST TRANSACTIONS**

Certain Plan investments are managed by the Trustee of the Plan. These transactions qualify as party-in-interest transactions. The Plan pays investment management and recordkeeping fees to parties in interest. The Plan paid approximately \$30,000 to parties in interest for the year ended December 31, 2024. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

In addition, administrative fees were paid indirectly through revenue sharing and are included in the net appreciation in fair value of investments.
