Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

**Supplemental Schedule Required by ERISA**

Our audits were conducted for the purpose of forming an opinion on the financial statements as a whole. The supplemental schedule of Schedule H, line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, including its form and content, is presented in conformity with the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion, the information in the accompanying schedule is fairly stated, in all material respects, in relation to the financial statements as a whole, and the form and content are presented in conformity with the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA.

**Note 1 – Description of Plan**

The following description of Kenneth's Profit Sharing and Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution employee stock ownership benefit plan (ESOP) covering all employees of Kenneth's Hair Salons & Day Spas, Inc. (the Company) who have one year of service and are 21 years of age or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Funding**

Funding is provided by annual employer contributions. The employer shall contribute cash no less than the amount required enabling the Trustees to discharge any indebtedness under the acquisition loan owed for that Plan year. Any amount contributed above the amount required to discharge indebtedness will be allocated to the participants subject to limitations based on total participants' compensation and net income of the Company. If any cash remains after allocations have been made to the participants, the Plan Administrator has the sole discretion to hold the cash in a separate cash account, purchase investments, or repay the acquisition loan indebtedness. Contributions by the participants are neither required nor permitted.

**Participant Accounts**

Individual account balances are maintained for each participant. Account balances are adjusted annually at the end of the Plan year as follows:

Employer contributions and forfeitures are allocated on the last day of the Plan year to eligible participants who worked at least 1,000 hours during the year. To receive an allocation, an employee must be employed on the last day of the Plan year, regardless of hours worked, unless the employee has reached normal retirement age. The Plan allocations are based on each eligible participant's compensation compared to the total of all eligible participants' compensation. In a participant's initial year of participation, the compensation for the entire year will be included. However, compensation will not include amounts earned while not meeting the eligibility requirements of the Plan.

Participant allocations first start with ESOP stock allocations to each participant's stock account, which includes released shares and forfeitures. The next participant allocations are cash account allocations to each participant's cash account. Both stock and cash allocations are based on participant's compensation. If any shares of stock or cash remain unallocated for the year due to contribution limitations, it will be held in a suspense account to be allocated in the next Plan year.

Cash dividends paid to the Plan Trustee on shares of Company stock held will be allocated based on the amount of shares held on the record date. These cash dividends are applied to the participant's cash account and may be applied to any repayment of debt, held as cash, or used to purchase Company stock.

**Participant Accounts (Continued)**

A pro-rata share of income, expenses, and realized and unrealized gains and losses is allocated to participants based on the percentage, which each participant's account balance at the beginning of the year bears, to the total of all participants' account balances at that date. These allocations will be made prior to allocating for any employer contributions, but after any distributions have been made for the Plan year.

**Vesting**

Vesting is based on years of service. Participants become 100% vested upon completion of three years of service. A year of service is defined as a year in which the employee has worked at least 1,000 hours. Participants who reach normal retirement age, but before completing three years of service, also become 100% vested in their account.

**Payment of Benefits**

Excluding required minimum distributions, benefit payments will be paid in a lump sum. The minimum distributions required will be paid annually.

The Company may segregate cash for vested balances of terminated employees. Cash segregated for future payments during the years ended December 31, 2024 and 2023 was \$0.

**Diversification**

Diversification is offered to participants close to retirement, allowing them to receive a distribution from their investment in shares of Company common stock in order to diversify their investment. Participants who reached age 55 at the beginning of the Plan year with at least 10 years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a 6-year period. In each of the first 5 years, a participant may diversify up to 25 percent of the total shares ever allocated to their account, less, any shares previously diversified. In the sixth year the participant may diversify an additional 25 percent of the total shares. Participants who elect to diversify can only receive a cash distribution. The election to diversify is made subsequent to Plan year-end based upon the shares of Company common stock held in the participant's account at year-end.

**Forfeitures**

Forfeitures are allocated among eligible participants at the end of the Plan year in which the forfeiture occurs. Stock forfeitures allocated for years ended December 31, 2024 and 2023 were 157.27 and 248.94 shares, respectively. The cash forfeitures allocated for the years ended December 31, 2024 and 2023 were \$130 and \$142, respectively. As of December 31, 2024, the Plan had no unallocated forfeitures.

**Secure 2.0 Act**

The SECURE 2.0 Act of 2022 ("SECURE 2.0"), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. Each of the provisions in SECURE 2.0 has its own effective date ranging from the date of enactment to 2028 and beyond, with the bulk of the provisions taking effect in 2023 and 2024. The Plan is required to be amended in regard to the requirements of SECURE 2.0 by December 31, 2025.

**Note 2 – Summary of Significant Accounting Policies**

The following is a summary of significant accounting policies followed in the preparation of these financial statements. These policies conform to accounting principles generally accepted in the United States of America and have been applied on a consistent basis.

**Basis of Presentation**

The financial statements of the Plan are presented on the accrual basis of accounting.

**Administrative Expenses**

A majority of the administrative expenses of the Plan are paid by the Plan Sponsor. These expenses are primarily for the Plan trustee, annual valuation of shares of Company common stock, annual independent audit of the Plan, and third-party recordkeeping and administration fees.

**Use of Estimates**

The preparation of financial statements in accordance with U.S. generally accepted accounting principles requires the Plan Administrator to make estimates and assumptions that effect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Investment Valuation and Income Recognition**

The shares of Company common stock are reported at fair value. See Note 6 for a disclosure of the fair value measurements. Dividend income is accrued on the ex-dividend date. Purchases and sales of securities are recorded on a trade-date basis. Realized gains and (losses) from security transactions are reported on the average cost method. Net appreciation (depreciation) includes the Plan's realized and unrealized gains and (losses) on all investments bought, sold, and held during the year.

**Subsequent Events**

Management evaluated all activity of the Plan through October 3, 2025, the date the financial statements were available to be issued, and concluded that no subsequent events have occurred that would require recognition or disclosure in the financial statements or notes except as noted below.

**Note 3 – Income Tax Status**

The Internal Revenue Service has determined and informed the Plan Administrator, by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving this determination letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

**Note 4 – Plan Termination**

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan subject to the provisions of ERISA. In the event of termination, each participant's account automatically becomes 100% vested. The net assets of the trust would be distributed in the form of payment as determined by the Plan Administrator.

The Company is a closely-held entity, with no active market or established market price for the shares of its common stock. Therefore, the fair value of shares of Company common stock on December 31, 2024 and 2023 has been determined based upon valuation by an independent appraiser.

**Note 6 – Fair Value**

FASB ASC 820 establishes a framework for measuring fair value, which provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 inputs) and the lowest priority to unobservable inputs (Level 3 inputs). The three levels of the fair value hierarchy under FASB ASC 820 are described in the table below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The fair value measurement level of assets or liabilities within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques utilized need to maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the Level 3 valuation methodologies used for assets measured at fair value. There were no changes in the methodologies used for valuation as of December 31, 2024 and 2023.

*Company common stock:* Valued based on discounted expected future cash flows. This method is utilized because it provides a strong indicator of the Company's value based on its underlying characteristics and future earnings potential. (Level 3)

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 7 – Long-term Debt**

The Plan had a note payable to the Company. The proceeds were used to purchase the Company's common stock. Unallocated shares were held as collateral for the note. The note had a fixed rate of 6% per annum and was payable in annual installments of \$1,361,816. The note was repaid in full during 2023, with the last installment payment in July 2023, as a result there is no outstanding balance as of December 31, 2024 and 2023.

**Note 8 – Party-in-Interest Transactions**

The Company is the Plan Sponsor as defined by the Plan agreement and, therefore, transactions and investment in shares of Company common stock qualify as party-in-interest transactions.

**Note 9 – Risks and Uncertainties**

Investment securities by their nature are exposed to various risks, such as changes in interest rates, economic and market conditions, and credit risks. Additional risks and uncertainties exist within the assumptions used in the valuation of shares of Company common stock based on expected future earnings, cash flows, and other such techniques. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.
