Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 12 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor’s Responsibilities for the Audit of the Financial Statements section –

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTES TO FINANCIAL STATEMENTS FOR THE YEARS ENDED DECEMBER 31, 2024 AND 2023

1. INFORMATION REGARDING THE PLAN

The following brief description of the Excel Truck Group 401(k) Plan is provided for general information purposes only. Participants should refer to the plan agreement for more complete information.

General – The Plan is a defined contribution plan covering all employees of Virginia Truck Center, Inc., Virginia Truck Center of Richmond, Inc., and Charlotte Truck Center, Inc. (the Companies) who have completed one year of service and are at least 18 years old. As of October 1, 2021, employees are eligible after completion of six months of service and are at least 18 years old. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Certified Investments – Certain information related to investments disclosed in the accompanying financial statements and ERISA – required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company and Transamerica Life Insurance Company (the trustees of the Plan).

Contributions – Each year, participants may contribute up to the dollar limit set by law, which is \$23,000 and \$22,500 for 2024 and 2023, respectively, of pretax and/or after-tax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investments options offered by the Plan. The Company contributes 50% up to 6% that a participant contributes to the Plan up to a \$4,000 employer match maximum. Additional profit sharing amounts may be contributed at the option of the Plan Sponsor. As of February 1, 2018, the Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation, increasing 1% annually until a 10% maximum and their contributions invested in a designated balance fund until changed by the participant.

Participant Accounts – Each participant's account is credited with the participant's payroll contributions and the employer's matching contribution and an allocation of the Plan earnings. Participant's accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Amounts forfeited by terminating participants of the plan are used to offset employer contributions.

Vesting – Participants are immediately vested in their contributions plus actual earnings thereon. The portion of the participants' individual account attributable to employer contributions is fully vested after completion of six years of service. Participants' accounts become fully vested upon attainment of the normal retirement age of 65 or in the event of death or total disability.

Notes Receivable From Participants – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan transactions are treated as a transfer to (from) the investment fund from (to) the installment loans fund. Loan terms cannot be longer than five years, except for certain housing loans. The loans are secured by the balance in the participant's account and bear interest at the prevailing local market rate. Interest rates range from 3.25% to 9.50%. Principal and interest is paid ratably through bi-weekly payroll deductions.

Payment of Benefits – Distributions to participants or their beneficiaries are generally payable at the time of normal retirement, early retirement, death or disability while in the employ of the Company or following termination of employment. Various methods are available for settlement of a participant’s vested account balance including lump-sum cash settlement and periodic payments.

In certain hardship situations, as described in the plan agreement, participants may withdraw part of their account balances while actively employed, but such withdrawals are limited to the amount dictated by the hardship. Participants’ withdrawals are limited to deferred account balances and may not include any interest earned thereon.

Forfeitures – At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$64,505 and \$2,032, respectively. These amounts will be used to reduce future employer contributions and pay administrative expenses. In 2024 and 2023, employer contributions were reduced by \$44,959 and \$50,906, respectively from forfeited nonvested accounts.

Expense Budget Account – At December 31, 2024 and 2023, expense budget account totaled \$37,835 and \$41,631, respectively. The significant terms of expense offset arrangements with third parties whereby expenses are netted against income. Expense offset arrangements generally consist of fees being paid to a third-party service provider (for example, recordkeeper) directly through the use of investment fee rebates made available by the Plan’s separate third-party investments manager.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

General – The financial statements of the Plan are prepared on the accrual basis.

Use of Estimates – The preparation of financial statements in accordance with generally accepted accounting principles in the United States requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition – The pooled separate accounts with Transamerica are stated at fair value as reported to the plan by Transamerica Life Insurance Company (Transamerica), based on the quoted market prices of the underlying mutual funds. The unit value of the pooled separate account is calculated by dividing the total value of the assets of the separate account by the number of units in the separate account. For separate accounts that invest exclusively in mutual funds, the total value of the assets of the separate account is based on the net asset value (NAV), or price per share, of the underlying mutual fund. The mutual fund calculates its NAV by dividing the mutual fund’s net assets by the mutual fund’s outstanding number of shares. Those separate accounts investing in mutual funds or equity securities are measured using quoted prices in active markets for identical assets. Those separate accounts directly investing in fixed maturity securities are measured based on the pricing data provided by outside valuation service providers who in turn generally use the mean of bid and ask prices but may also use alternative observable pricing inputs for certain securities. The stable value fund is valued at contract value, and is based on its beginning balance plus any deposit and credited interest, less any withdrawals, charges or expenses, a measurement which approximates fair value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowances for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Excess Contributions Payable – Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 excess contributions to the applicable participants prior to March 15, 2025.

Payment of Benefits – Benefits are recorded when paid.

Expenses – Expenses of maintaining the Plan are paid by the Plan. Fees related to the administration of notes receivable from participants and fees related to the maintenance of individually directed accounts are charged directly to the participant’s account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events – Management evaluated subsequent events through October 13, 2025 the date the financial statements were available to be issued.

3. INVESTMENTS

During 2024 and 2023, the Plan’s investments (including investments bought, sold and held during the year) appreciated in value by \$3,310,188 and \$3,220,400, respectively as follows:

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the assets or liability;
- inputs that are derived principally from or corroborated by observable market data, correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
- The pooled separate accounts with Transamerica are stated at fair value as reported to the plan by Transamerica, based on the quoted market prices of the underlying mutual funds converted into as unit value of the pooled separate accounts. Separate accounts directly investing in fixed maturity securities are measured based on the pricing data provided by outside valuation service providers who in turn generally use the mean of bid and ask prices but may also use alternative observable pricing inputs for certain securities. The net asset value of the pooled separate accounts is calculated daily and distributions from net investment income and net realized gains are retained by the trust.
- The stable value fund, is valued at contract value, and is based on its beginning balance plus any deposit and credited interest, less any withdrawals, charges or expenses, a measurement which approximates fair value.

5. STABLE VALUE FUND

Transamerica offers a stable value fund that the participant may elect to transfer all or part of its funds. The stable value fund is considered to be a fully benefit-responsive investment contract. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits. Contract value, as reported by Transamerica, is the beginning balance plus any deposit and credited interest, less any withdrawals, charges or expenses, a measurement which approximates fair value. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at December 31, 2024 and 2023 was \$1,307,867 and \$1,468,278, respectively. This investment seeks to protect against any loss of principal while providing returns in excess of money market funds and one-year U.S. Treasury bills. The investment has a portfolio investment rate design in which all deposits are credited with the same interest rate, credited on a daily basis, and with no set maturity. The effective credited interest rate is set monthly and effective on the first day of the month. Contract charges may reduce this return. The Transamerica Stable Value Option is not a separate account investment choice – it is an investment in Transamerica’s general account. The average yield of the stable value fund based on the actual earnings and interest credited to participants yielded 1.58% and 1.18% for the years ended December 31, 2024 and 2023, respectively.

Certain events limit the ability of the plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger the another plan), (2) changes to the plan’s prohibition on competing investments options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that any events which would limit the plan’s ability to transact at contract value with participants are probable.

6. RELATED PARY TRANSACTIONS

Certain plan investments are units of pooled separate accounts managed by Reliance Trust Company and Transamerica Retirement Services. Reliance Trust Company and Transamerica Retirement Services, are the trustees as defined by the Plan and, therefore, these transactions qualify as related party transactions. Fees paid by the Plan for administrative and trust services amounted to \$111,135 and \$47,710 for the years ended December 31, 2024 and 2023, respectively. Fees paid for advisory fees amounted to \$62,695 and \$87,623 for the years ended December 31, 2024 and 2023, respectively. Fees paid for professional fees amounted to \$12,750 and \$11,880 for the years ended December 31, 2024 and 2023, respectively.

Certain administrative functions are performed by officers or employees of the Company. These employees are also plan participants. No such officer or employee receives compensation from the plan.

7. PLAN AMENDMENT OR TERMINATION

The Board of Directors of the Company may amend or terminate the Plan at any time. In the event the Plan is terminated, each participant will be entitled to his proportionate share of the assets available for plan benefits as of the termination date.

8. TAX STATUS

The IRS has determined and informed the Company by a letter dated March 31, 2014, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan’s tax counsel believe that the Plan is designed, and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

9. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.

10. PLAN MERGER

Effective August 15, 2024, the Crook Motor Company, Inc 401(k) Plan merged into the Excel Truck Group 401(k) Plan. In connection with the merger, net assets of approximately \$5,232,667 were transferred to the Plan from the Crook Motor Company, Inc 401(k) Plan. The assets transferred consisted primarily of mutual funds and participant loans. The merger was made to consolidate retirement plan assets under a single plan for administrative efficiency.
