Note A – Description of Plan

The following description of First Tee Foundation Employees Savings Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan with a 401(k) feature covering employees of PGA TOUR First Tee Foundation, Inc. and World Golf Foundation, Inc. (collectively, “Company” or “Employer”). The Plan was formed and adopted on April 1, 1997 and most recently restated effective January 1, 2021. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Effective January 1, 2024, the Plan was amended to implement the following changes:

- **Employer True-Up Contributions:** The Plan provides for annual Employer True-Up Contributions to be made within three months following the end of the Plan year. These contributions are made on behalf of participants who: (a) are eligible for Employer matching contributions, (b) have made employee salary deferral and Roth contributions for the Plan year equal to at least 3% of compensation, (c) have received Employer contributions for the Plan year equal to less than 1.5% of compensation, and (d) are employed by the Employer on December 31 of the Plan year. The True-Up Contribution equals 1.5% of the participant’s compensation (or a pro-rated amount if eligibility begins July 1), reduced by prior Employer contributions.
- **Increase in Mandatory Distribution Threshold:** The mandatory distribution amount was increased from \$5,000 to \$7,000.
- **Use of Forfeitures:** The Plan was amended to allow forfeitures to be used to pay the administrative expenses. Forfeitures incurred during any Plan year that began before January 1, 2024 shall be treated as having been incurred in the Plan year beginning January 1, 2024.

Employees who are at least age 21 are eligible immediately to make contributions and receive the Employer safe harbor contributions. Employees who have one year of credited service and are age 21 or older are eligible for matching contributions. A year of credited services is defined as at least 1,000 hours of service in a 12-month period. The entry dates for matching Employer contributions under the Plan are each January 1 and July 1.

Administration of the Plan

The accounting records are maintained by the Employer. The Plan’s assets are held and managed by Charles Schwab Trust Bank (the “Custodian”). Schwab Retirement Plan Services, Inc. is the record-keeper. Contributions are held by Charles Schwab Trust Bank, who invests cash received, interest and dividend income, as directed by the participant, and makes distributions to participants.

Contributions

The Plan has an automatic deferral feature for all eligible employees at an automatic deferral of 3% of compensation, increasing by 1% each year up to a maximum of 10%. Participants may contribute up to 15% of pretax annual compensation, as defined in the Plan, subject to Internal Revenue Code (“IRC”) limitations. The maximum participant deferral for the year ended December 31, 2024 was \$23,000. A participant who has attained the age of 50 may also make catch up contributions, subject to the IRC limitations of \$7,500 for the year ended December 31, 2024. The Plan also allows participants to contribute amounts representing distributions from other eligible retirement plans as well as make Roth contributions.

The Employer makes a safe harbor contribution equal to 3% of eligible compensation. The Employer makes a matching contribution equal to 50% of the participant’s deferral, up to a maximum of 3% of eligible compensation. The Employer safe harbor and matching contributions are directed by the participant into the various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service (“IRS”) limitations.

Note A – Description of Plan (continued)

Participant Accounts

Each participant's account is credited with the participant's salary reduction contribution, Roth contributions, rollover contributions from other qualified retirement plans and an allocation of the Company's contributions. Each participant's account shall be allocated earnings, gains, expenses, and losses with respect to the investments of the participant's account.

Vesting

Participants are immediately 100% vested in their contributions and the Employer safe harbor contribution plus actual earnings thereon. Vesting in the Employer matching contributions, plus actual earnings thereon, is based on years of credited service. A participant is 100% vested after three years of credited service. A participant who reaches normal retirement age 65, becomes totally disabled, or dies, whichever comes first while under the Company's employment, shall be 100% vested on such date.

Investment Options

Participants may change their investment elections daily through a telephone access system or online system.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. A participant may only have a maximum of one loan outstanding at any given time. The notes are secured by the balance in the participant's account, and bear interest at a rate commensurate with local prevailing rates as determined by the Plan Administrator. The maximum note repayment period is five years. Principal and interest payments with respect to the notes are credited solely to the account of the borrowing participant from which the note was made.

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. If a loan payment is past due for more than 90 days, the unpaid portion of the participant's loan will be treated as a taxable distribution.

Distribution of Benefits

In the event of termination of service, death, disability or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account, as defined in the Plan agreement, less any applicable taxes. If a participant's vested balance is \$7,000 or less, the Plan Administrator will distribute the entire vested account balance to the participant without their consent. Participants may also request in-service distributions upon attaining age 59 ½, as a qualified reservist or for a qualified birth or adoption. Benefits may be received when a participant demonstrates a situation of financial hardship as defined in the Plan.

Forfeitures

Non-vested benefits of terminated participants are forfeited on the date the participant receives a complete distribution of vested benefits. Forfeitures are used to reduce Plan administration expenses and Employer contributions. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$0. During the year ended December 31, 2024, Employer contributions were reduced approximately by \$1,681 from forfeited non-vested accounts.

Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue contributions to the Plan at any time and to terminate the Plan subject to the provisions of ERISA and the IRC. If the Plan terminates, affected participants and beneficiaries will become 100% vested in their accounts.

Note B – Summary of Significant Accounting Policies

Basis of Presentation

The accompanying financial statements are presented on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (“US GAAP”).

Use of Estimates

The preparation of financial statements in conformity with US GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and the changes in net assets available for benefits and disclosure of contingent assets and liabilities during the reporting period. Actual results could differ from these estimates.

Valuation of Investments

The Plan’s investments are stated at fair value. If available, quoted market prices are used to value investments. Shares of mutual funds are valued at the net asset value (“NAV”) of shares held by the Plan at year end. The Plan’s interest in the common collective trust is valued based on information reported by the investment advisor using the audited financial statements of the collective trust at year-end. Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant’s account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Fair Value Measurements

The Financial Accounting Standards Board has established a framework for measuring fair value in ASC 820, *Fair Value Measurements*. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy are described below:

Fair Value Measurements (continued)

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used during the Plan year ending December 31, 2024 and 2023.

Money market funds: Money market funds are interest-bearing investment funds, comprised of short-term securities, with original maturities of one year or less. The funds are stated at fair value based on quoted market prices.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/collective trusts: Valued at NAV provided by the custodian. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying assets owned by the trust, minus its liabilities, divided by the number of units outstanding.

This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. There were no unfunded commitments to purchase investments at December 31, 2024 and 2023. Participant-directed redemptions have no restrictions and are recorded at the end of every business day.

While the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note C – Certified Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Charles Schwab Trust Bank, a qualified institution. As of December 31, 2024 and 2023 and for the year ended December 31, 2024, the Plan Administrator instructed the auditors not to perform any auditing procedures with respect to the information certified by Charles Schwab Trust Bank, except for comparing such information to the related information included in the financial statements, as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Note D – Income Tax Status

The IRS has determined by letter dated January 27, 2017 that the Plan is qualified in accordance with applicable sections of the Code and, therefore, the related trust is exempt from taxation. Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Code and, therefore, believes that the Plan, through the date the financial statements were available to be issued, is qualified and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken any significant uncertain tax positions that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note E – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note F – Party-In-Interest Transactions

Section 3(14) of ERISA defines a party-in-interest to include, among others, fiduciaries or participants of the Plan, any person who provides services to the Plan, or an employer whose employees are covered by the Plan. Certain Plan investments are managed by the Custodian. Transactions related to these investments qualify as party-in-interest transactions. Notes receivable from participants are also considered to be party-in-interest transactions because they are transacted with Plan participants. Fees paid to parties-in-interest by the Plan for services amounted to \$2,736 during the year ended December 31, 2024.

Note G – Subsequent Events

Subsequent events have been evaluated through October 7, 2025, which is noted below, and is the date the financial statements were available to be issued.
