Report on the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of The Hertz Corporation Income Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of The Hertz Corporation Income Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

NOTE 1 DESCRIPTION OF PLAN

The following description of The Hertz Corporation Income Savings Plan (the Plan or the Hertz Plan) of The Hertz Corporation (Hertz or the Company) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan originally effective August 30, 1985. The Plan was most recently restated effective November 30, 2021 as part of the Cycle 3 remedial amendment period. The Plan was last amended effective April 1, 2024 to reduce eligibility service requirements, and subsequent to year end, effective September 1, 2025 to modify the participating employers. The Plan covers certain eligible employees of the Company. The Plan excludes leased employees, independent contractors, nonresident aliens, and those covered by a collective bargaining agreement (unless the agreement provides for membership). The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Hertz Corporation Benefits Committee (The Hertz Benefits Committee) is responsible for the oversight of the Plan. The Hertz Benefits Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Compensation Committee of the Company's Board of Directors.

Effective in March 2020, certain provisions under the CARES Act relating to participant distributions and participant loans were enacted. The CARES Act allows for utilization of these provisions immediately, but requires formal adoption of the amendment, as extended, no later than December 31, 2025. As of October 9, 2025, the Plan as not been formally amended to adopt these provisions.

Eligibility

Prior to April 1, 2024, employees of the Company were eligible to participate in the deferral and match components of the Plan after completion of 60 days of continuous employment. Effective April 1, 2024, the continuous employment requirement dropped from 60 days to 30 days. Plan entry dates are monthly.

For participants actively participating in the Hertz Corporation Account Balance Defined Benefit Pension Plan (the Pension Plan) at the time it was frozen, December 31, 2014, who would have been eligible for a compensation crediting rate of 5% or 6% on January 1, 2015, if the Pension Plan had not been frozen, the Company provides additional contributions to the Plan (transition contributions) each pay period for up to five years for eligible participants who are actively employed with the Company during such time.

No transition contribution will be given to nonunion employees for years after 2019. Certain union groups continue to receive transition contributions as required by a collective bargaining agreement after 2019.

Contributions

The Plan includes a salary deferral arrangement allowed under Section 401(k) of the Internal Revenue Code (IRC). Eligible participants are permitted to elect to have a percentage, limited by Plan provisions, of their compensation contributed as pre-tax 401(k) or after-tax Roth contributions to the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

The Plan is a “safe harbor plan” that requires the Company to contribute 100% of the participants’ deferrals that do not exceed 3% of the participants’ deferred compensation and 50% of the participants’ deferrals between 3% and 5%, not to exceed 4% of total employee deferred compensation. There were no Company discretionary contributions authorized for 2024.

For those participants eligible for transition contributions, the amount of transition contribution depended on the participant’s age as of December 31, 2014, and the compensation crediting rate that the participant would have been eligible for under the Pension Plan on January 1, 2015, if the Pension Plan had not been frozen.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover) and certain IRAs. Participants direct the investment of contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service (“IRS”) limitations.

Participant Accounts

Each participant’s account is credited with the participant’s contributions, the Company’s safe harbor matching contributions, as applicable, the Company’s transition contribution, and an allocation of Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, as defined in the Plan document. The benefit to which a participant is entitled is the participant’s vested account balance.

Vesting

Participants are immediately vested in their contributions, the Company’s safe harbor matching contributions, and the Company’s transition contributions plus actual earnings thereon. Vesting for the Company’s matching contributions made before January 1, 2015, plus actual earnings thereon, will be 100% vested after the completion of three years of credited service. Notwithstanding the above, a participant is fully vested upon reaching normal retirement age, or death.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued, unpaid interest. A participant, while still employed by Hertz, may borrow from the Plan in accordance with its loan policy. Such borrowings are subject to certain restrictions as provided by the IRS. No loan is made to a participant while any previous loan to the participant is outstanding. Loans are made for terms of 1 – 5 years, except that the term of a loan used to acquire or construct any dwelling which is to be used as a principal residence of a participant may be 6 – 10 years. No loan may be in an amount less than \$500 or in an amount greater than the lesser of (i) \$50,000 or (ii) 50% of the vested dollar value of the units credited to the participant at the time the loan is made. The loans are secured by the balance in the participants accounts. The interest rates on loans are established at the beginning of each month equal to the prime rate as published in *The Wall Street Journal*.

Principal and interest are paid ratably through payroll deductions. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

Benefit Payments

Upon termination of service and retirement (age 65), a participant may elect to receive the value of their vested account in the form of a lump sum distribution or installments. For terminations due to death, the participant's beneficiary is entitled to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. For all terminations, if the value of the participant's vested interest in his or her account is \$1,000 or less, the participant is required to receive a lump-sum amount equal to the vested interest in the account. The Plan allows for in-service distributions if a participant reaches age 59½ and hardship distributions subject to Plan provisions.

Forfeitures

Forfeited balances of terminated participants' nonvested accounts are first made available to reinstate previously forfeited Company matching contribution accounts of rehired participants and any remaining forfeitures are used to reduce future Company contributions or be used to pay Plan expenses. For the year ended December 31, 2024, \$47,113 of forfeitures were used to reduce Company contributions. For the year ended December 31, 2023, there were no forfeitures used to pay Plan expenses. Forfeited nonvested accounts as of December 31, 2024 and 2023 totaled \$136,942 and \$125,915, respectively.

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclose contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Hertz Benefits Committee determines the Plan's valuation policies utilizing information provided by the investment advisers and trustee. See Note 4 for a discussion of the fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable are reclassified as distributions based on the terms of the Plan document.

Contributions

Contributions from participants and employer contributions are recorded in the year in which the employee contributions are withheld from compensation.

Benefit Payments

Benefit payments are recorded when paid.

Administrative Expenses

Participants of the Plan pay investment managers' fees, to the extent they are not paid with revenue sharing credits, as well as loan initiation fees. Some of the Plan's expenses are financed through revenue sharing credits. Trustee's fees and other administrative expenses of the funds are paid by the Company.

Investments in mutual funds are subject to sales charges in the form of front-end loads, back-end loads, or 12b-1 fees. 12b-1 fees are allowable under Section 12b-1 of the Investment Company Act of 1940. These fees are deducted prior to the allocation of the Plan's investment earnings activity and, thus, not separately identifiable as an expense.

Subsequent Events

The Plan has evaluated subsequent events through October 9, 2025, the date the financial statements were available to be issued.

Effective September 1, 2025, the Plan was amended to modify participating employers and provide credited service for work completed while employed by one of the participating employers.

NOTE 3 CERTIFICATION OF INVESTMENT INFORMATION

Fidelity Management Trust Company, the trustee of the Plan, has supplied the Plan administrator with a certification as to the completeness and accuracy of all investments and related investment activity and notes receivable from participants and related activity in the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, the Statements of Changes in Net Assets Available for Benefits for the year ended December 31, 2024, and the Supplemental Schedule of Assets (Held at End of Year) as of December 31, 2024.

NOTE 4 FAIR VALUE OF INVESTMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

NOTE 4 FAIR VALUE OF INVESTMENTS (CONTINUED)

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used as of December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Master Trust are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/Collective Trust Funds: Valued at NAV of units of the bank collective trust. NAV is a readily determinable fair value and is the basis for current transactions. Participant transactions (purchases and sales) may occur daily.

Money Market Fund: Valued at amortized cost, which approximates current market value.

NOTE 5 RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

NOTE 6 PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the participants would become 100% vested in their account balances.

NOTE 7 PLAN TAX STATUS

The Plan was restated effective November 30, 2021, as part of the Cycle 3 remedial amendment period by adopting a pre-approved document that received an IRS opinion letter stating the pre-approved plan was designed in accordance with the applicable sections of the IRC. The Plan has been amended since adopting the pre-approved plan. However, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 PARTY-IN-INTEREST TRANSACTIONS

Certain investments are managed by Fidelity Management Trust Company, the trustee as defined by the Plan. Therefore, these investment transactions qualify as party-in-interest transactions.

Report on the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of The Hertz Corporation Income Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

NOTE 1 DESCRIPTION OF PLAN

The following description of The Hertz Corporation Income Savings Plan (the Plan or the Hertz Plan) of The Hertz Corporation (Hertz or the Company) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan originally effective August 30, 1985. The Plan was most recently restated effective November 30, 2021 as part of the Cycle 3 remedial amendment period. The Plan was last amended effective April 1, 2024 to reduce eligibility service requirements, and subsequent to year end, effective September 1, 2025 to modify the participating employers. The Plan covers certain eligible employees of the Company. The Plan excludes leased employees, independent contractors, nonresident aliens, and those covered by a collective bargaining agreement (unless the agreement provides for membership). The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Hertz Corporation Benefits Committee (The Hertz Benefits Committee) is responsible for the oversight of the Plan. The Hertz Benefits Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Compensation Committee of the Company's Board of Directors.

Effective in March 2020, certain provisions under the CARES Act relating to participant distributions and participant loans were enacted. The CARES Act allows for utilization of these provisions immediately, but requires formal adoption of the amendment, as extended, no later than December 31, 2025. As of October 9, 2025, the Plan as not been formally amended to adopt these provisions.

Eligibility

Prior to April 1, 2024, employees of the Company were eligible to participate in the deferral and match components of the Plan after completion of 60 days of continuous employment. Effective April 1, 2024, the continuous employment requirement dropped from 60 days to 30 days. Plan entry dates are monthly.

For participants actively participating in the Hertz Corporation Account Balance Defined Benefit Pension Plan (the Pension Plan) at the time it was frozen, December 31, 2014, who would have been eligible for a compensation crediting rate of 5% or 6% on January 1, 2015, if the Pension Plan had not been frozen, the Company provides additional contributions to the Plan (transition contributions) each pay period for up to five years for eligible participants who are actively employed with the Company during such time.

No transition contribution will be given to nonunion employees for years after 2019. Certain union groups continue to receive transition contributions as required by a collective bargaining agreement after 2019.

NOTE 1 DESCRIPTION OF PLAN (CONTINUED)

Contributions

The Plan includes a salary deferral arrangement allowed under Section 401(k) of the Internal Revenue Code (IRC). Eligible participants are permitted to elect to have a percentage, limited by Plan provisions, of their compensation contributed as pre-tax 401(k) or after-tax Roth contributions to the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

The Plan is a “safe harbor plan” that requires the Company to contribute 100% of the participants’ deferrals that do not exceed 3% of the participants’ deferred compensation and 50% of the participants’ deferrals between 3% and 5%, not to exceed 4% of total employee deferred compensation. There were no Company discretionary contributions authorized for 2024.

For those participants eligible for transition contributions, the amount of transition contribution depended on the participant’s age as of December 31, 2014, and the compensation crediting rate that the participant would have been eligible for under the Pension Plan on January 1, 2015, if the Pension Plan had not been frozen.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover) and certain IRAs. Participants direct the investment of contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service (“IRS”) limitations.

Participant Accounts

Each participant’s account is credited with the participant’s contributions, the Company’s safe harbor matching contributions, as applicable, the Company’s transition contribution, and an allocation of Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, as defined in the Plan document. The benefit to which a participant is entitled is the participant’s vested account balance.

Vesting

Participants are immediately vested in their contributions, the Company’s safe harbor matching contributions, and the Company’s transition contributions plus actual earnings thereon. Vesting for the Company’s matching contributions made before January 1, 2015, plus actual earnings thereon, will be 100% vested after the completion of three years of credited service. Notwithstanding the above, a participant is fully vested upon reaching normal retirement age, or death.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued, unpaid interest. A participant, while still employed by Hertz, may borrow from the Plan in accordance with its loan policy. Such borrowings are subject to certain restrictions as provided by the IRS. No loan is made to a participant while any previous loan to the participant is outstanding. Loans are made for terms of 1 – 5 years, except that the term of a loan used to acquire or construct any dwelling which is to be used as a principal residence of a participant may be 6 – 10 years. No loan may be in an amount less than \$500 or in an amount greater than the lesser of (i) \$50,000 or (ii) 50% of the vested dollar value of the units credited to the participant at the time the loan is made. The loans are secured by the balance in the participants accounts. The interest rates on loans are established at the beginning of each month equal to the prime rate as published in *The Wall Street Journal*.

Principal and interest are paid ratably through payroll deductions. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

Benefit Payments

Upon termination of service and retirement (age 65), a participant may elect to receive the value of their vested account in the form of a lump sum distribution or installments. For terminations due to death, the participant's beneficiary is entitled to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. For all terminations, if the value of the participant's vested interest in his or her account is \$1,000 or less, the participant is required to receive a lump-sum amount equal to the vested interest in the account. The Plan allows for in-service distributions if a participant reaches age 59½ and hardship distributions subject to Plan provisions.

Forfeitures

Forfeited balances of terminated participants' nonvested accounts are first made available to reinstate previously forfeited Company matching contribution accounts of rehired participants and any remaining forfeitures are used to reduce future Company contributions or be used to pay Plan expenses. For the year ended December 31, 2024, \$47,113 of forfeitures were used to reduce Company contributions. For the year ended December 31, 2023, there were no forfeitures used to pay Plan expenses. Forfeited nonvested accounts as of December 31, 2024 and 2023 totaled \$136,942 and \$125,915, respectively.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclose contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Hertz Benefits Committee determines the Plan's valuation policies utilizing information provided by the investment advisers and trustee. See Note 4 for a discussion of the fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable are reclassified as distributions based on the terms of the Plan document.

Contributions

Contributions from participants and employer contributions are recorded in the year in which the employee contributions are withheld from compensation.

Benefit Payments

Benefit payments are recorded when paid.

Administrative Expenses

Participants of the Plan pay investment managers' fees, to the extent they are not paid with revenue sharing credits, as well as loan initiation fees. Some of the Plan's expenses are financed through revenue sharing credits. Trustee's fees and other administrative expenses of the funds are paid by the Company.

Investments in mutual funds are subject to sales charges in the form of front-end loads, back-end loads, or 12b-1 fees. 12b-1 fees are allowable under Section 12b-1 of the Investment Company Act of 1940. These fees are deducted prior to the allocation of the Plan's investment earnings activity and, thus, not separately identifiable as an expense.

Subsequent Events

The Plan has evaluated subsequent events through October 9, 2025, the date the financial statements were available to be issued.

Effective September 1, 2025, the Plan was amended to modify participating employers and provide credited service for work completed while employed by one of the participating employers.

NOTE 3 CERTIFICATION OF INVESTMENT INFORMATION

Fidelity Management Trust Company, the trustee of the Plan, has supplied the Plan administrator with a certification as to the completeness and accuracy of all investments and related investment activity and notes receivable from participants and related activity in the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, the Statements of Changes in Net Assets Available for Benefits for the year ended December 31, 2024, and the Supplemental Schedule of Assets (Held at End of Year) as of December 31, 2024.

NOTE 4 FAIR VALUE OF INVESTMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used as of December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Master Trust are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/Collective Trust Funds: Valued at NAV of units of the bank collective trust. NAV is a readily determinable fair value and is the basis for current transactions. Participant transactions (purchases and sales) may occur daily.

Money Market Fund: Valued at amortized cost, which approximates current market value.

NOTE 5 RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

NOTE 6 PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the participants would become 100% vested in their account balances.

NOTE 7 PLAN TAX STATUS

The Plan was restated effective November 30, 2021, as part of the Cycle 3 remedial amendment period by adopting a pre-approved document that received an IRS opinion letter stating the pre-approved plan was designed in accordance with the applicable sections of the IRC. The Plan has been amended since adopting the pre-approved plan. However, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 PARTY-IN-INTEREST TRANSACTIONS

Certain investments are managed by Fidelity Management Trust Company, the trustee as defined by the Plan. Therefore, these investment transactions qualify as party-in-interest transactions.
