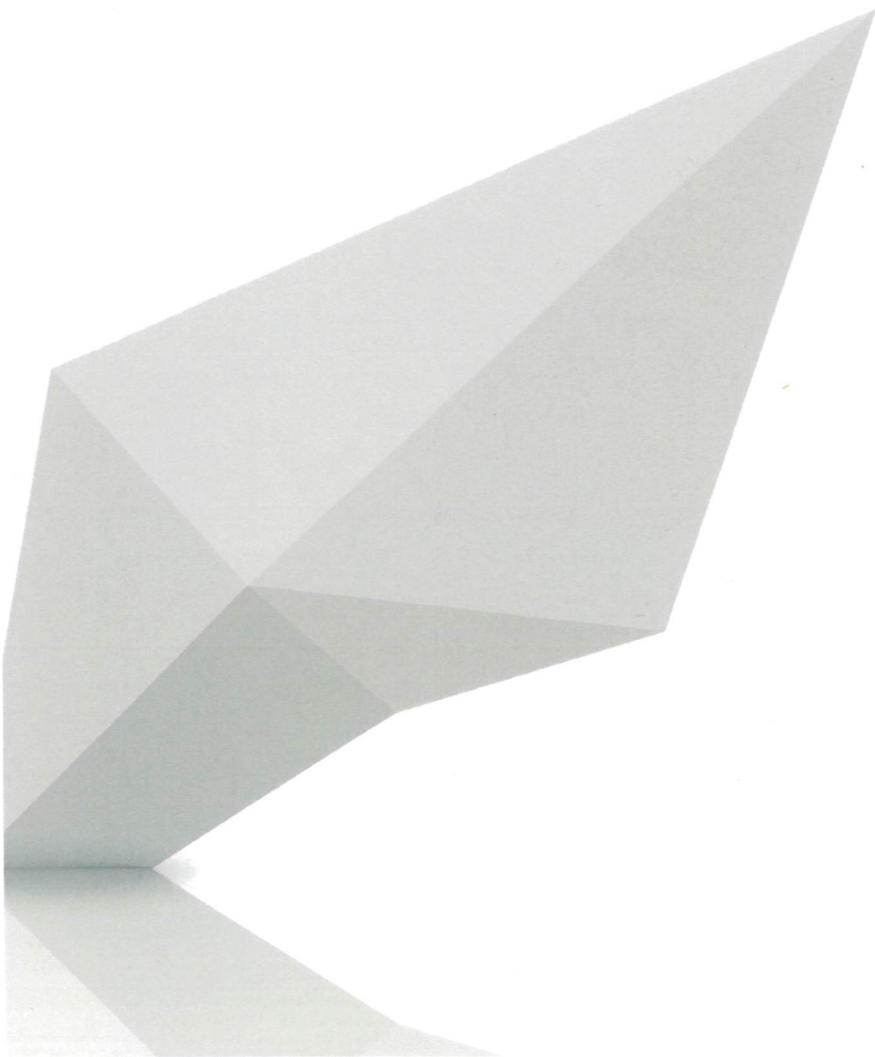

Notes to Financial Statements

Note 1: Description of Plan

The following description of the Volm Companies 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all full-time employees of Volm Companies, Inc., Plaspack U.S.A., Inc., and Yellowstone Plastics, Inc. (collectively referred to as the "Company"). Employees become eligible to participate in the Plan on the first entry date (the first day of the month) following 30 days of employment and provided they have reached the age of 18. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Setting Every Community Up for Retirement Enhancement ("SECURE") Act 2.0

The SECURE 2.0 Act of 2022 ("SECURE 2.0"), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements. All provisions of SECURE 2.0 have been and will continue to be evaluated and implemented by plan management in accordance with future regulations and guidance, and the Plan will be amended, as needed.

Contributions

Each year participants may contribute up to 85% of pretax annual compensation, as defined in the Plan, up to the annual maximum allowed by the Internal Revenue Service (IRS). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. The Plan also allows for Roth contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan also includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. Automatically enrolled participants have their deferral rate automatically increased each plan year by 1% until a deferral rate of 10% is reached.

The Company may make discretionary matching contributions. Rollovers are not matched. There was no Company discretionary matching contribution for the year ended December 31, 2024.

Note 1: Description of Plan (Continued)

Contributions (Continued)

The Company shall make a profit sharing contribution equal to 3% of each eligible participant's compensation. The Company may also make an additional discretionary profit sharing contribution each plan year. For the year ended December 31, 2024, the Company made a 3% profit sharing contribution and an additional discretionary profit sharing contribution of 2%, totaling 5% in the amount of \$1,649,545, net of forfeitures applied. The discretionary profit sharing contributions are allocated to participants in the same ratio as each participant's compensation bears to the total of such compensation of all participants. To be eligible for the Company's discretionary profit sharing contribution, a participant must be employed on the last day of the plan year and have completed 1,000 hours of service.

The Company may also make required minimum contributions under the Top-Heavy rules or other legal requirements. The Company made qualified nonelective contributions (QNEC) in the amount of \$737 during the year ended December 31, 2024.

Contributions are subject to certain IRS limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions, Company discretionary matching contributions, Company QNECs, and allocations of (a) the Company's profit sharing contributions, (b) plan earnings (losses), and (c) forfeitures of terminated participants' nonvested accounts. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their salary deferral contributions and rollover contributions, plus actual earnings (losses) thereon. Vesting in the Company's discretionary matching contributions and profit sharing contributions, plus actual earnings (losses) thereon, is based on years of continuous service. Participants vest at a rate of 20% per year beginning with the second year of service. Participants become fully vested after six years of service in which the participant works at least 1,000 hours each year.

Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The notes are secured by the balance in the participant's account and bear interest at the Wall Street Journal Prime rate plus 1%, but the plan administrator may determine that other rates of interest are also reasonable. Interest rates on existing loans range from 4.25% to 9.50%. Principal and interest are paid ratably through payroll deductions.

Note 1: Description of Plan (Continued)

Payment of Benefits

On termination of service if a participant's vested balance exceeds \$7,000, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or a series of installment payments. If the participant's vested account balance does not exceed \$7,000, the Plan will distribute that portion in a lump-sum as soon as administratively feasible after the participant terminates employment with the Company. In addition, hardship distributions are permitted if certain criteria are met. The Plan also allows for in-service distributions upon attaining age 59½.

Forfeitures

Plan forfeitures arise as a result of participants who terminate service with the Company before becoming 100% vested in the Company's contributions. These forfeitures are first used to pay plan expenses or used to reduce Company discretionary matching or profit sharing contributions, and then may be added to any Company contribution or allocated to all participants in the same proportion that each participant's compensation for the plan year bears to the compensation of all participants for such year. Unallocated forfeitures from nonvested accounts were \$52,131 and \$48,364 at December 31, 2024 and 2023, respectively. Forfeitures in the amount of \$127,586 were used to reduce the Company profit sharing contribution for the year ended December 31, 2024.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant notes receivable are recorded as benefit payments on the basis of the terms of the plan document.

Payment of Benefits

Benefits are recorded when paid. The amount of benefit payments requested in 2024 that were distributed in 2025 was \$526,066.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Third-party administration, trustee, and custodial expenses are allocated proportionately to plan participants based on the respective account balances and are included in administrative expenses. Investment-related expenses are allocated proportionately to plan participants based on their respective account balances and are included in net investment income.

Subsequent Events

The Plan has evaluated subsequent events through October 10, 2025, which is the date the financial statements were available to be issued.

Effective November 21, 2024, the Company made a decision to change the Plan's service providers from One America Retirement Services, LLC ("One America") as recordkeeper and Matrix Trust Company ("Matrix") as Trustee to Empower Trust Company, LLC as recordkeeper and Trustee. The transition caused a blackout period which began on April 10, 2025 and ended on May 7, 2025. A blackout period indicates that participants will temporarily be unable to access their account to direct or diversify their investments, obtain a loan from the Plan or obtain a distribution from the Plan. The transition concluded on May 7, 2025.

Note 3: Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs that are unobservable inputs for the asset or liability.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/collective trust - T Rowe Price Stable Value Common Fund: A stable value fund that is composed primarily of fully benefit-responsive investment contracts that are valued at the NAV of units of the bank collective trust. Participant transactions (purchases and sales) may occur daily.

Self-directed brokerage accounts: Accounts primarily consist of mutual funds, money market, and common stocks that are valued on the basis of readily determinable market prices. Preferred stock held in accounts is valued at par value, which approximates fair value.

Note 4: Information Prepared and Certified by the Trustee

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including non-interest bearing cash, investments, and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Matrix Trust Company, the Trustee of the Plan.

Note 5: Related-Party and Party-in-Interest Transactions

The Plan paid certain expenses related to plan operations and investment activity to various service providers. The Plan paid fees to Heck Capital Advisors for investment advisory services and to OneAmerica Retirement Services, LLC for third-party administration services. These transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

Certain plan investments held in self-directed brokerage accounts are shares of Volm Companies, Inc. preferred stock. At December 31, 2024, the Plan held 1,000 shares of Volm Companies, Inc. preferred stock valued at \$100,000. At December 31, 2023, the Plan held 2,000 shares of Volm Companies, Inc. preferred stock valued at \$200,000. This investment and transactions in this investment qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

Notes receivable from participants also qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

Note 6: Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Company contributions.

Note 7: Tax Status

The Company adopted a nonstandard pre-approved document with an IRS notification letter which states the pre-approved plan document is in compliance with the applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the opinion letter; however, the plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Note 8: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
