We have performed audits of the accompanying financial statements of The Merion Cricket Club 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). Note 1 – Description of Plan

General

The following description of The Merion Cricket Club 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

On November 6, 1997, The Merion Cricket Club (the “Club”) adopted the Plan as of January 1, 1997 and subsequently amended and restated the Plan. The Plan is a defined contribution Plan covering all employees of the Club who are age twenty-one or older and have completed 6 months of service measured from date of hire. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Club’s management oversees governance of the Plan. The Club receives and reviews the regular reporting from the Investment Management Team. The Investment Management Team determines appropriateness of the Plan’s investments and monitors the selection of funds and investment performance in the Plan.

Effective January 1, 2024, the Plan was amended to comply with the long-term part-time employee eligibility provisions of the Setting Every Community Up for Retirement Enhancement Act of 2019 (“SECURE Act”). Under these provisions, employees who complete at least 500 hours of service in each of three consecutive 12-month periods and attain age 21 are eligible to make elective deferrals under the Plan, even if they have not satisfied the Plan’s standard 1,000-hour service requirement.

Beginning January 1, 2025, the Plan will be further amended, as required under the SECURE 2.0 Act of 2022, to expand these eligibility provisions to employees who complete at least 500 hours of service in each of two consecutive 12-month periods.

Contributions

Participants may contribute pretax annual compensation, as defined in the Plan. Participants may also contribute amounts representing distributions from another qualified retirement plan. No after-tax contributions may be made to this Plan. The Club shall contribute a discretionary percentage of the participant’s contribution to the Plan. Additional amounts may be contributed at the option of the Club’s Board of Trustees. Contributions are subject to certain Internal Revenue Code (“IRC”) limitations.

Investment options

Upon enrollment in the Plan, a participant may direct employee and employer contributions into certain available investment options.

Note 1 - Description of Plan (continued)

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Club's matching and discretionary contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is one-hundred percent vested after three years of credited service. A participant is one-hundred percent vested upon attainment of normal retirement age, death, or disability, while an employee.

Participant accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Club's contribution and (b) Plan earnings. Non-elective contributions are allocated, pro rata, as a uniform percentage of participant compensation. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participant notes

Under the terms of the Plan, participants are permitted to borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. This maximum amount is reduced by the excess of the Participant's highest outstanding balance of all loans on any day during the one (1) year period ending on the day before the loan is made, over the outstanding balance of loans from the Plan on the date the participant's loan is made. Loan transactions are treated as a transfer to (from) the investment fund from (to) the participants' notes fund. Loan terms may not exceed five years except for the purchase of a primary residence, in which case, the loan period may be up to twenty-five years. A participant can have two loans currently outstanding from the Plan. The loans are secured by the balance in the participant's account and bear interest at the prime rate plus 1%. Principal and interest is paid ratably through payroll deductions. As of December 31, 2024, interest rates on the outstanding notes receivable from participants range from 4.25% to 9.50%.

Payment of benefits

On termination of service due to death, disability or attainment of retirement age, a participant or beneficiary may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account, or periodic payments as further outlined in the Plan document. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Forfeited accounts

Forfeited non-vested accounts are used to first pay Plan expenses, then to reduce future Club contributions. For the year ended December 31, 2024, \$3,726 was used to reduce Plan expenses.

Note 2 - Summary of significant accounting policies

Basis of accounting

The Plan's financial statements are prepared on the accrual basis of accounting, except for benefits paid which are recorded on a cash basis.

Investment valuation and income recognition

The Plan's investments are stated at fair value. Realized and unrealized gains and losses from the assets in each account are credited to or charged against each participant's account. Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded when earned. Dividends are recorded on the ex-dividend date.

Fair value measurements

Fair value refers to the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. The fair value hierarchy gives the highest priority to quoted prices in active markets and the lowest priority to unobservable data. Fair value measurements are required to be separately disclosed by level within the fair value hierarchy. The three levels of inputs used to measure fair value are as follows:

Level 1 – Unadjusted quoted prices in active markets for identical assets.

Level 2 – Quoted prices for identical assets in markets that are not active, quoted prices for similar assets in active markets, inputs other than quoted market prices, and inputs derived principally from observable market data.

Level 3 – Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

Mutual funds

The Plan's investments in mutual funds are stated at fair value based on the quoted market prices of the underlying securities within each fund. These funds are required to publish their daily Net Asset Value ("NAV") and to transact at that price.

Pooled separate accounts

The value of each pooled separate account is determined at the close of each business day based on the fair value of the respective investments. The value of each account is expressed in "units". The "unit value" is the dollar value of one unit and is determined at the close of each business day by dividing the total fair value of each account by the total number of units in the account. The value of each participant's account on any date is determined by multiplying the number of units held by the "unit value" at the close of the business day.

Common/collective trusts

The value of the common/collective trusts is determined at the close of each business day based on the fair value of the respective investments. The value of each account is expressed in "units". The "unit value" is the dollar value of one unit and is determined at the close of each business day by dividing the total fair value of each account by the total number of units in the account. The value of each participant's account on any date is determined by multiplying the number of units held by the "unit value" at the close of the business day.

Administrative expenses

General administrative expenses of the Plan are paid by the Club and are not reflected in the accompanying financial statements. Certain other transaction-related participant expenses, such as those associated with loan maintenance and administration, are paid by the Plan and are included in the accompanying financial statements.

Certain administrative functions are performed by officers or employees of the Club. No such officer or employee receives compensation from the Plan.

Note 2 - Summary of significant accounting policies (continued)

Risk and uncertainties

The Plan's investments are exposed to various risks such as interest rate, market, credit and liquidity. Due to the level of risk associated with these investments, it is reasonably possible that changes in the values of these investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits as of December 31, 2024. The Plan's investments are not insured or protected by the Pension Benefit Guaranty Corporation, or any other governmental agency, accordingly, the Plan is subject to the normal investment risks associated with common/collective trust accounts and mutual funds. Any defaults on notes receivable from participants are treated as taxable distributions to the participants.

Payment of benefits

Benefits are recorded when paid.

Contributions

Contributions from participants are recorded as they are withheld from the participants' wages. Contributions from the Club are recorded as earned.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or December 31, 2023.

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the amounts reported in the financial statements. Actual results could differ from these estimates.

Subsequent events

The Plan has evaluated events and transactions for potential recognition or disclosure through October 1, 2025, which is the date the financial statements were available to be issued.

Note 3 – Information certified by the Trustees

The Plan Administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Hand Benefits and Trust Company has certified to the completeness and accuracy of all investments reflected on the accompanying statements of net assets available for benefits as of December 31, 2023. Effective July 1, 2024, Hand Benefits and Trust Company no longer acted as the Plan's Trustee and Principal Trust Company assumed responsibility as Trustee of the Plan. Accordingly, Principal Trust Company has certified to the completeness and accuracy of all investments reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and the Supplemental Schedule H – Part IV – Line 4(i) – Schedule of Assets (Held at End of Year) as of December 31, 2024. Hand Benefits and Trust Company has certified to the completeness and accuracy of the related investment activity reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024 and Principal Trust Company has certified to the completeness and accuracy of the related investment activity reflected in the statement of changes in net assets for benefits for the period from July 1, 2024 through December 31, 2024.

Note 4 - Parties-in-interest transactions

The Plan's investments were managed by Hand Benefits and Trust Company, and effective July 1, 2024, are managed by Principal Trust Company. Hand Benefits and Trust Company and Principal Trust Company are Trustees, as defined by the Plan and, therefore, are considered parties-in-interest.

In addition, certain other investment and administrative fees related to the Plan were paid by the Plan or by the Club and qualify for the party-in-interest exemption, as defined by ERISA. Personnel and facilities of the Plan Sponsor have been used by the Plan at no additional charge to the Plan.

Note 5 – Plan termination

Although it has not expressed any intent to do so, the Club has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.

Note 6 – Tax status

The Internal Revenue Service has determined and informed the Plan that the Plan is designed in accordance with applicable sections of the IRC. Although the Plan has been amended/restated since receiving the determination letter, the Plan Administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified.
