1. Description of the Plan

Effective January 1, 2023, the Plan was amended and renamed NYU Langone Health Retiree Medical Account Plan (the “Plan”). The following description of the Plan provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan’s provisions. Copies are available from the Plan sponsor.

General

The Plan was established effective January 1, 2012. The Plan is a non-taxable retiree medical plan available to employees of NYU Langone Hospitals, NYU Langone Health System and NYU Grossman School of Medicine (collectively “NYULH”) for the purpose of providing reimbursement for qualified medical care expenses to certain retirees. The Plan is funded through a Voluntary Employees’ Beneficiary Association. The Plan Administrator is NYULH or any individual or committee to whom NYULH has delegated the responsibility, authority and discretion to manage and direct the operations and administration of the Plan. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (“ERISA”).

Employees are eligible to participate in the Plan if an employee was eligible to receive benefits under the former NYU Langone Hospitals Employee Benefit Plan, NYU Grossman School of Medicine Employee Benefit Plan, or the NYU Langone Health System Employee Benefit Plan and is at least age 40.

The following employees are not eligible for contributions under the plan:

- i) Employees subject to any collective bargaining agreement, unless and to the extent the collective bargaining agreement specifically provides for their coverage under this Plan.
- ii) Employees who are eligible to receive benefits under the NYU Langone Hospitals Retiree Welfare Benefit Plan or the NYU Grossman School of Medicine Retiree Welfare Benefit Plan, unless an employee was at least age 60 but not yet 65 at the effective date of this Plan.

The Plan assets are held by Teachers Insurance and Annuity Association of America (“TIAA”) as an insurance company of the Plan. TIAA, FSB is the custodian/trustee for the non-annuity assets, including mutual funds. TIAA is a non-profit, legal reserve life insurance and annuity company. Plan assets can also be invested in mutual funds managed by The Vanguard Group (“Vanguard”). Vanguard is an investment management company that offers mutual funds and financial products and services to both individual and institutional customers.

Effective May 1, 2024, the TIAA-CREF Lifecycle Funds were renamed the Nuveen Lifecycle Funds (“Lifecycle Index Funds”). This change did not impact any of the underlying Fund’s investment strategies or portfolio management. Contributions made for participants are initially invested in the Lifecycle Index Fund of the year that is nearest to the participant’s 65th birthday. The Plan also allows participants to select their own investments and create their portfolio from its menu of investments in several asset classes. Participants can transfer their balances to other funds, or they may change the investment of their future contributions. They can also transfer funds between options.

As with all mutual funds, the principal value in a Lifecycle Index Fund, or any other mutual funds held within the Plan, is not guaranteed. Investment return is allocated to participants’ accounts based upon the number of units the participant owns in each investment and the net appreciation (depreciation) of the assets in the investment.

Contributions

NYULH contributes four thousand dollars per participant annually. For all pay cycles, the contribution will appear in the first available paycheck in the month following any of these events: attaining age 40, a newly hired NYULH employee who is age 40 or above, or an employee who moved from an ineligible to eligible status (provided the employee is age 40 or over when the move to eligible status occurs). NYULH has no obligation to make contributions to participant accounts or to fund medical care expenses of retired participants in excess of the annual per participant contribution.

Participants are not permitted to make voluntary participant contributions except at the discretion of NYULH. If permitted, eligible participants may make participant contributions pursuant to an after-tax salary deduction agreement.

The balance in each participant's account consists of NYULH's contributions made on their behalf and investment return less expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

NYULH contributions will vest:

- i) If the participant has completed at least 15 years of continuous service beginning on or after age 40 and work in a position eligible to receive continuous service until age 62
- ii) If the participant dies or are totally disabled after completing at least 10 years of continuous service

If the participants meet the eligibility rules their RMA account balance will be available to help cover medical expenses when employment at NYULH ends and you are at least age 62.

Upon a break in continuous service before vesting, any balance in the Plan shall be forfeited immediately. Any forfeited account balance will not be eligible for reinstatement, and the continuous service earned prior to the break in service will be reset to zero as of the date of such forfeiture, and will not be available for purposes of determining the vesting of future employer contributions to the Plan.

Forfeited Accounts

Where a participant's employment with NYULH is terminated before they are 100% vested in employer contributions, the unvested portion of their employer contributions will be forfeited. The balance in the forfeiture account can be used to fund future employer contributions required to be made to the Plan or to pay administrative expenses. NYULH utilized \$25,636 of forfeitures to reduce contributions and pay administrative expenses in 2024. Administrative expenses are reported net against employer contributions. As of December 31, 2024 and 2023, the amounts available in the forfeiture account totaled \$516 and \$2, respectively.

Plan Loans

The Plan does not permit hardship withdrawals or loans.

Payment of Benefits

Funds in the participant's account will be available for payment of benefits by TIAA if the account is vested in accordance with the Plan document and the participant has satisfied each of the following requirements:

- i) The participant or participant's dependent has incurred a qualified medical care expense,
- ii) The participant is at least 62 years of age,
- iii) The participant is a retiree, and
- iii) The participant was employed in a position eligible to receive medical benefits under the Plan on the last day of his or her employment (except when a participant had transferred (whether voluntarily or involuntarily) to a position which was not eligible for participation in the Plan or which did not provide retiree medical benefits at the time the participant retired).

At the time of retirement, part of the participant's account will be liquidated by TIAA and the monies made available to the participant through a debit card which can be used to pay for allowable medical expenses for the participant and eligible family members.

Participants direct the investment of contributions made on their behalf into various investment options offered by the Plan in accordance with the plan document. The Plan currently offers numerous TIAA-CREF and Vanguard mutual funds.

2. Summary of Significant Accounting Policies

Basis of Presentation

The financial statements of the Plan are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of Estimates

The preparation of the Plan's financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingencies at the date of the financial statements and the reported amounts of changes in net assets available for benefits during the reporting period. Actual results could differ from these estimates and such differences could be material.

Valuation of Investments and Income Recognition

The Plan's investments are held by TIAA and are stated at fair value. Shares of mutual funds are valued at daily closing price as reported by the fund. These funds are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The Lifecycle Index Funds seek high total return over time through a combination of capital appreciation and income. Each of the Lifecycle Index Funds is designed to provide a single diversified portfolio managed with a target retirement age in mind. The target date is the approximate date when investors expect to begin withdrawing money from the fund. Each portfolio invests in several underlying equity and fixed-income index funds offered by the TIAA-CREF. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023. See Note 4 for discussion of fair value measurements.

The Plan presents in the accompanying statement of changes in net assets available for benefits the net appreciation in the fair value of its investments, which consists of the realized and unrealized gains or losses less expenses.

Purchases and sales of securities are recorded on a trade-date basis. Dividend income is recorded on the ex-dividend date and interest income (when applicable) is recorded on the accrual basis.

Payment of Benefits

Benefits are recorded when paid.

Expenses of the Plan

All direct expenses of the Plan will be paid by NYULH, except that, at the Plan Administrator's discretion, direct expenses of the Plan may be paid with forfeited funds.

Fees that are related to a particular participant account may be assessed against that account. Such fees will be the responsibility of the participant unless NYULH, in its sole discretion, determines that it will pay certain fees assessed against the account.

Risks and Uncertainties

The Plan invests in various types of mutual funds or investment securities. These investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the value of participant account balances and the amounts reported in the accompanying statements of net assets available for benefits and the statement of changes in net assets available for benefits.

3. Certified Financial Data

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, TIAA, a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate.

4. Fair Value Measurements

Accounting standards establish a framework for measuring fair value. That framework sets forth a fair value hierarchy which requires an entity to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The levels of the fair value hierarchy are described below. Authoritative guidance on fair value measurements, Accounting Standards Codification Topic 820, *Fair Value Measurement*, establishes a hierarchy of valuation methodologies based on the extent to which asset valuations are observable in the marketplace. The following describes the hierarchy of methodologies used to measure the fair value of investments:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan can access.

- Level 2 Inputs to the valuation methodology are observable, either directly or indirectly, such as quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; or other inputs that are observable or can be corroborated by observable market data for substantially the full terms of the assets or liabilities.

- Level 3 Inputs to the valuation methodology are unobservable.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Valuation techniques used maximize the use of observable inputs and minimize the use of unobservable inputs. The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different estimate of fair value at the reporting date.

5. Plan Termination

Although the Plan has not expressed any intent to do so, NYULH has the right to discontinue its contributions and to terminate the Plan at any time subject to the provisions of ERISA. In the event of plan termination, the assets will be distributed to the plan participants.

6. Tax Status

The Internal Revenue Service has determined and informed NYULH by letter dated July 15, 2014, that the Plan is intended to qualify pursuant to Section 501(c)(3) of the Internal Revenue Code ("IRC") and, accordingly, the Plan's related trust is exempt from income taxes. The Plan Administrator and the Plan's internal legal counsel believe that the Plan is qualified and the related trust is tax-exempt in accordance with the applicable provisions of the IRC. Therefore, no provision for income taxes has been made.

7. Party-in-Interest and Related-Party Transactions

Certain of the Plan's investments are managed by Nuveen, a TIAA Company, and, therefore, these qualify as party-in-interest transactions. The total fair value of investments managed by Nuveen was \$416,175 at December 31, 2024 and by TIAA was \$348,320 at December 31, 2023. The Plan Administrator and the Plan's counsel believe that the Plan's transactions with related parties are permitted by the U.S. DOL's prohibited transaction exemptions.
