#### 1. Plan Description

The following description of the Trinity Business Group, LLC 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan Agreement for a more comprehensive description of the Plan's provisions.

- a) *General* – The Plan is a 401(k) defined contribution plan covering substantially all non-union, and non-resident alien employees of Trinity Business Group, LLC (the "Company") who have completed sixty days of service and are age twenty-one or older. Participants may enter the plan on the first day of each plan quarter after the eligibility requirements are met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").
- b) *Contributions* – Each year participants may contribute to the Plan up to 100% of compensation, on a pre-tax or post-tax (Roth) basis, subject to certain limitation under the Internal Revenue Code ("IRC"). Participants who have attained age 50 before the end of the calendar year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit plans or defined contribution plans (rollover).

The Plan includes an automatic enrollment feature as of January 1, 2021. Eligible employees who do not opt-out are automatically enrolled to contribute 1 percent of compensation to the Plan.

For the year ended December 31, 2024 and 2023, the Company made matching contributions of 100% of the first 1% of compensation that each participant contributed to the Plan. Additional profit sharing amounts may be contributed at the discretion of the Company. Participants must be employed by the Company on the last day of the year to be eligible. No profit sharing contributions were made for the years ended December 31, 2024 and 2023.

Participants direct the investment of their contributions and the Company's contribution into various investment options offered by the Plan. Participants may change their investment options at any time via the telephone or website.

- c) *Participants Accounts* – Each participant’s account is credited and/or reduced with the participant’s contributions and withdrawals, employer matching contributions, and allocations of the Plan earnings and losses and administrative expenses. Allocations are based on participant earnings or account balances, as defined. Administrative expenses maybe charged based on account balances or charged equally to each participant. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.
- d) *Vesting* – Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Sponsors’ contribution portion is based on years of continuous service. A participant is 100% vested after four years of service.

The vesting schedule for Company contributions is as follow:

| Years of Service        | Vesting Percentage |
|-------------------------|--------------------|
| Less than 1 year        | 0%                 |
| 1 year but less than 2  | 25%                |
| 2 years but less than 3 | 50%                |
| 3 years but less than 4 | 75%                |

- e) *Payment of Benefits* – In the case of retirement, death, disability or termination of employment, participants receive the vested accumulated value of their account in a lump sum distribution. The Plan also allows distribution in cases of hardship.
- f) *Forfeited accounts* – The portion of a participant's account not vested at the date of his/her termination of employment is forfeited immediately. Forfeitures under the Plan will be either, allocated to Participant’s accounts during the Plan Year, to reduce the amount the Employer must contribute to the Plan or used to reduce related Plan costs and expenses. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$15,613 and \$13,932, respectively. The forfeiture account may be used to pay Plan expenses or reduce employer contributions. In 2024, forfeitures of \$1,433 were used to reduce employer matching contributions.

## 2. Summary of Significant Accounting Policies

### Basis of Accounting

The financial statements of the Plan are prepared on the accrual method of accounting.

### Use of Estimates

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan to make estimates and assumptions that affect the reported amounts of net assets and changes therein. Actual results could differ from these estimates.

### Investment Valuation and Income Recognition

Investments are reported at fair value. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### Payment of Benefits

Benefits are recorded when paid.

### Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

## 3. Subsequent Events

The Plan has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued.

**5. Fair Value Measurements**

The Plan’s investments are reported at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value.

Following is a description of the valuation methodologies used for assets measured at fair value.

Mutual funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

## 6. Risks and Uncertainties

The Plan utilizes various investment instruments, which are exposed to various risks, such as interest rates, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

## 7. Related Party and Party-in-Interest Transactions

The Plan's investments are held and managed by the Plan trustee, Nationwide, and therefore these transactions qualify as party-in-interest transactions. Fees paid to Nationwide for recordkeeping fees in 2024 and 2023 were \$2,157 and \$7,054, respectively.

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

**9. Tax Status**

The Plan is a pre-approved defined contribution plan ("Pre-approved Plan") sponsored by CCH Incorporated ("CCH"). CCH obtained its latest opinion letter dated June 30, 2020 that the Pre-approved Plan, as then designed, was in compliance with the applicable requirements of IRC. is designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan management believes that the Plan is currently designed, and is currently being operated, in compliance with applicable requirements of the IRC and, therefore, believes that the Plan is qualified, as the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.
