Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of The Winterberry Group Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate. Investments not held by The Standard Insurance Company were not certified and therefore audited. The Plan changed trustees effective October 1, 2023 from Great-West Life & Annuity Insurance Company for the period January 1, 2023 through September 30, 2023 to The Standard Insurance Company for the period from October 1, 2023 through December 31, 2023 and as of and for the year ended December 31, 2024.

Opinion

Notes to Financial Statements

1. Description of Plan

The following description of The Winterberry Group Retirement Plan (the Plan) is provided for general purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan, established on January 1, 1993, as a safe harbor defined contribution plan, is available to all employees of Environmental Designs, LLC, (the Company and Plan Administrator) who have met the eligibility requirements stipulated by the Plan. The Plan is administered by the management of the Company and is subject to the provisions of the Employee Retirement Income Security Act (ERISA).

Eligibility

In general, employees are eligible to participate in the Plan upon completing three months of service and attainment of age 21. Employees who meet the eligibility requirements can enter into the Plan the first day of the month following the date they satisfy the eligibility requirements. The Plan does not provide an automatic enrollment feature.

Contributions

The Plan allows for participants to make pre-tax and Roth contributions (salary deferrals). Participants may contribute any portion of their compensation up to the maximum allowed by the Internal Revenue Code (IRC). The maximum amount of salary deferrals that participants under the age of 50 were permitted to contribute to the Plan in 2024 and 2023 was \$23,000 and \$22,500, respectively, while participants aged 50 or older were able to defer an additional catch-up contribution of \$7,500 for both the plan years 2024 and 2023.

The Plan allows for rollover contributions. The Plan will accept eligible rollover contributions received on behalf of an eligible employee regardless of whether age and service requirements of the Plan have been met.

The Plan was adopted as a safe harbor plan, where the Company provides a safe harbor match of 100% of the first 3% of compensation contributed as elective deferrals, and 50% of salary deferrals between 3% and 5% of compensation, for a maximum match of 4% of eligible compensation. For the years ended December 31, 2024 and 2023, the Company made matching contributions of \$246,992 and \$203,297. In addition, the Employer makes additional prevailing wage contributions based on the hourly contribution rate required under the applicable prevailing wage law. Prevailing wage contributions for the years ended December 31, 2024 and 2023 total \$381,587 and \$205,768, respectively.

1. Description of Plan (continued)

Contributions (continued)

The Company may also elect to make a discretionary matching contribution to the Plan, with just Plan participants currently contributing being eligible. The Company may also decide to make a discretionary profit-sharing contribution to the Plan, with all Plan participants being eligible. The Company is not required to make either of these types of contributions. There were no discretionary matching or profit-sharing contributions made by the Company to the Plan during the years ended December 31, 2024 and 2023, respectively.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contributions and (b) Plan earnings (losses), and is charged with an allocation of administrative expenses paid by the Plan and any other participant-specific Plan expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Forfeited Accounts

At December 31, 2024 and 2023, the forfeited non-vested account balances totaled \$5,475 and \$5,475, respectively. This account will be used to reduce future employer contributions and to pay Plan administrative expenses. During the years ended December 31, 2024 and 2023, \$0, respectively, of the forfeited non-vested accounts were used to pay for Plan expenses. During the years ended December 31, 2024 and 2023, new forfeitures and earnings amounted to \$0 and \$460, respectively.

Vesting

Participants are immediately vested in their safe harbor voluntary contributions plus actual earnings thereon. Participants vest in the Company's matching discretionary contributions and any earnings thereon in accordance with the following schedule:

For both types of employer contributions, a year of service for vesting purposes is defined as any Plan year which an eligible employee is credited with at least 1,000 hours of service.

Investment Options

Certain Plan investments are held by The Standard Insurance Company (The Standard). All these investments are fully participant directed. Participants may direct the investment of their contributions and the Company matching contributions and profit-sharing contributions into any of the Plan's available investment options. Some investments held by The Standard, are in the form of a group annuity contract.

However, if participants do not direct the investment of account funds, then the funds will be invested in accordance with the default investment alternatives established under the Plan.

The Plan holds investments with TD Ameritrade, a division of TD Ameritrade, Inc which was sold to Charles Schwab in September 2023. The Plan investments at Charles Schwab are directed by a sole participant (related party) and contributions in this investment are also directed by the sole participant. The investment is eligible for and subject to participant Company matching contributions and profit-sharing contributions into any of the Plan's available investment options.

The Plan held crypto currency investments held by Robinhood Markets, Inc. The Plan investments at Robinhood are directed by the sole participant (related party) and investment of the contributions are directed by the sole participant. The crypto currency investments were transferred out of Robinhood Markets, Inc in November 2024. The account was closed, and moved into the existing Charles Schwab account in January 2025.

The Plan also holds stock within Wells Fargo. The Plan investments at Wells Fargo are directed by the sole participant (related party) and investment of the contributions are directed by the sole participant.

The Plan also holds investment within Vonfinch partnership investment. The Plan investments at Vonfinch are directed by the sole participant (related party) and investment of the contributions are directed by the sole participant.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance minus their highest outstanding loan balance from the Plan during the year. Loans must be repaid over a period of no more than 5 years except in the case of a loan used to acquire a principal residence in which case the Plan Administrator may permit a longer repayment term. Payments of principal and interest are made through payroll deductions. A loan is secured by the vested balance in the participant's account. The loan bears interest at a rate of 1% above the prime rate. Interest rates on participant loans ranged from 4.25% to 9.00% as of December 31, 2024.

Notes Receivable from Participants (continued)

If a participant terminates employment with the Company, their loan generally becomes due and payable in full immediately. If the participant does not repay the entire outstanding loan balance upon termination, the participant's vested account balance will be reduced by the remaining outstanding balance of the loan.

Payment of Benefits

Upon a participant's separation from service due to death, disability, termination, or retirement, benefits may be distributed to them in a single lump sum amount equal to the vested value of their account. Active participants may also withdraw funds from their pre-tax and Roth deferral accounts under certain hardship conditions.

If the vested benefit is less than \$5,000, the Plan Administrator may initiate an involuntary distribution. Prior to such distribution, the participant has the right to request that the amount be distributed directly to the participant in the form of a lump sum amount or request that it be rolled over to a different IRA provider or another retirement plan eligible to receive rollover contributions.

2. Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared in accordance accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make significant estimates and assumptions that affect the reported amounts of net assets available for benefits at the date of the financial statements and the changes in net assets available for benefits during the reporting period and, when applicable, disclosures of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

The Winterberry Group Retirement Plan Notes to Financial Statements (continued)

2. Significant Accounting Policies (continued)

Risks and Uncertainties

The Plan provides various investment options, including mutual funds with various investment objectives. Investments are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. The disclosure of the Plan's partnership investment is based upon the cost of the investment plus (minus) partnership income (losses). The Plan's Crypto currency is valued based on daily closing price as reported by the Custodian. Crypto currency held by the Plan are cash investments that are registered with the Securities and Exchange Commission. The crypto currency investments are only traded at the Plan Trustee's discretion.

Purchases and sales of mutual funds and securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on all investments bought and sold as well as held during the year.

Fair Value Measurements

The Plan follows Accounting Standards Codification (ASC) 820, for all financial assets and liabilities and nonfinancial assets and liabilities that are recognized or disclosed at fair value in the financial statements on a recurring basis. ASC 820 defines fair value, establishes a fair value hierarchy, and expands disclosures about fair value measurements.

2. Significant Accounting Policies (continued)

Fair Value Measurements (continued)

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include:
Quoted prices for similar assets in active markets;
Quoted prices for identical or similar assets or liabilities in inactive markets;
Inputs other than quoted prices that are observable for the asset;
Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Notes Receivable from Participants

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. No allowances for credit losses have been recorded as of December 31, 2024 and 2023, respectively. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be a distribution, the participant loan balance is reduced and a benefit payment is recorded.

Benefit Payments

Benefits are recorded when they have been approved for payment and paid by the Plan.

Administrative Expenses

In general, all costs related to the administration of the Plan are paid by Plan assets.

(d) *Mutual Fund Transactions* - All purchases and sales of mutual funds during 2024 and 2023, including the gain or loss on sales.

The Partnership investment and securities as listed in the statement of net assets have not been certified and have been subject to a full scope audit.

4. Fair Value Measurements (continued)

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutuals funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held in a group annuity contract by the Plan are deemed to be actively traded.

Securities:

- *Stocks:* Valued at the daily closing price as reported by the Custodian. Stocks held by the Plan are investment funds that are registered with the Securities and Exchange Commission. The investments are only traded by the Plan at the Plan Trustee's discretion.
- *Crypto currency:* Valued based on daily closing price as reported by the Custodian. Crypto currency held by plan are cash investments that are registered with the Securities and Exchange Commission. The crypto currency investments are only traded at the Plan Trustee's discretion.

The Plan's Level 3 investments had purchases of \$0 for the year ended December 31, 2024 and a allocated loss of \$0 for the year ended December 31, 2024.

Partnership investment: Fair value based on a derivative cost amount, purchased by the Plan investment plus investment gains or losses.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Income Tax Status

The Plan has adopted a prototype plan sponsored by Pension Consultants, Inc. The prototype plan obtained its latest determination letter on March 31, 2014, in which the Internal Revenue Service (IRS) stated that the prototype, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The prototype plan has been amended since receiving the determination letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

5. Income Tax Status (continued)

Accounting principles generally accepted in the United States require the Plan Administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would be sustained upon examination by the IRS.

The Plan files Form 5500 and is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

6. Party-in-Interest and Related Party Transactions

Section 3(14) of ERISA defines party-in-interest transactions to include, among others, fiduciaries or employees of the Plan, any person who provides services to the Plan or an employer whose employees are covered by the Plan. Accordingly, loans to participants, interest income from participant loans, administrative expenses paid by the Company, investment assets, investment real estate, crypto currency and transactions with investment funds managed and held by the trustees are considered party-in-interest transactions. Administrative expenses were \$3,763 and \$4,487 for the years ended December 31, 2024 and 2023, respectively.
